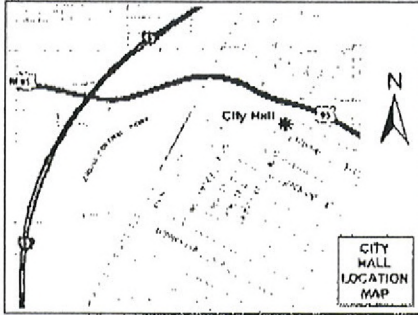
Dear Ms. Obodai,
