MAYOR GOODMAN declared the Public Hearing open for Item 91, which was heard with Items 40 and 41.

CITY COUNCIL MEETING OF: DECEMBER 2, 2009

GEORGE HARRIS appeared with IRMA AGUIRRE and expressed appreciation for staffs recommendation. He thanked Business Services and Planning and Development staffs for their assistance during the application process. He pointed out that 41 jobs will be created from this development and accepted the conditions. MS. AGUIRRE added that the proposed business will be an upscale Latin chic restaurant.
