DEAR BOCA PARK NEIGHBORS,

ON WEDNESDAY DECEMBER 16TH AT 1:00 PM THE LAS VEGAS CITY COUNCIL WILL BE VOTING ON WHETHER TO APPROVE AND GRANT A LIQUOR LICENSE TO

LEE'S DISCOUNT LIQUOR STORE TO BE OPENED AT BOCA PARK WHERE THE MILTON HOMER FURNITURE STORE IS CURRENTLY. THE FURNITURE STORE IS CLOSED AND THE OWNER WHICH IS NOT TRIPLE FIVE WHO DEVELOPED THE CENTER, IS SELLING THE BUILDING TO MR LEE THE OWNER OF LEE'S DISCOUNT LIQUORS.

HERE ARE A COUPLE POINTS ON WHY WE AS NEIGHBORS SHOULD VEHEMENTLY OPPOSE THIS STORE OPENING IN A HIGH END SHOPPING AREA LIKE BOCA PARK.
