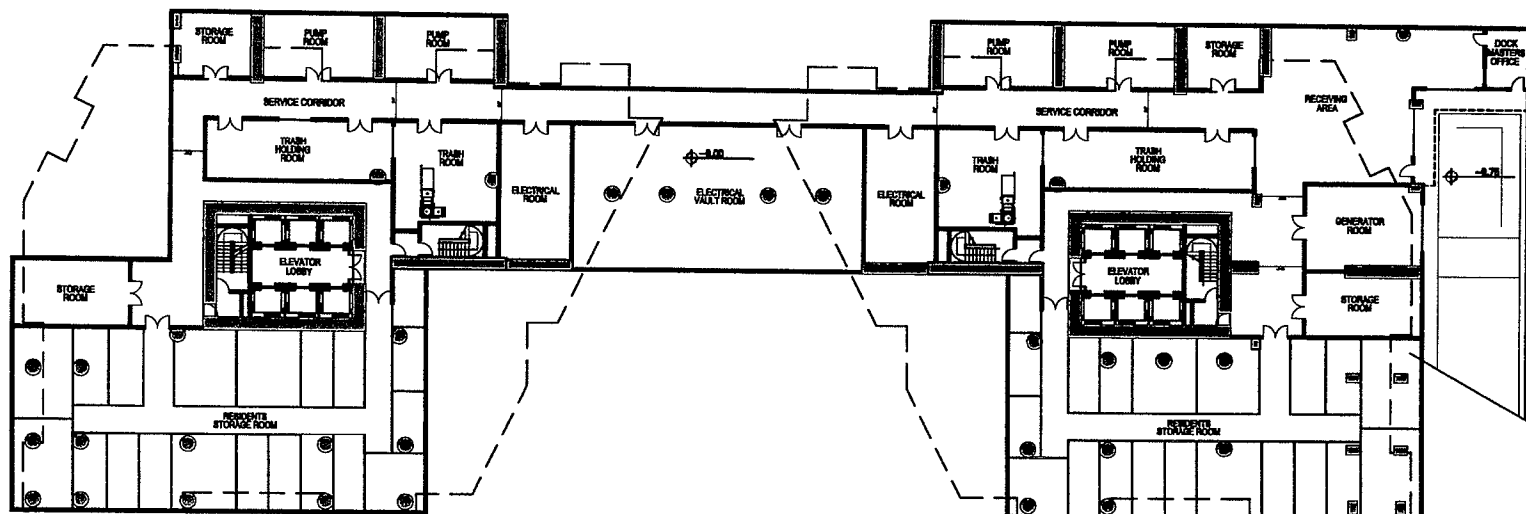

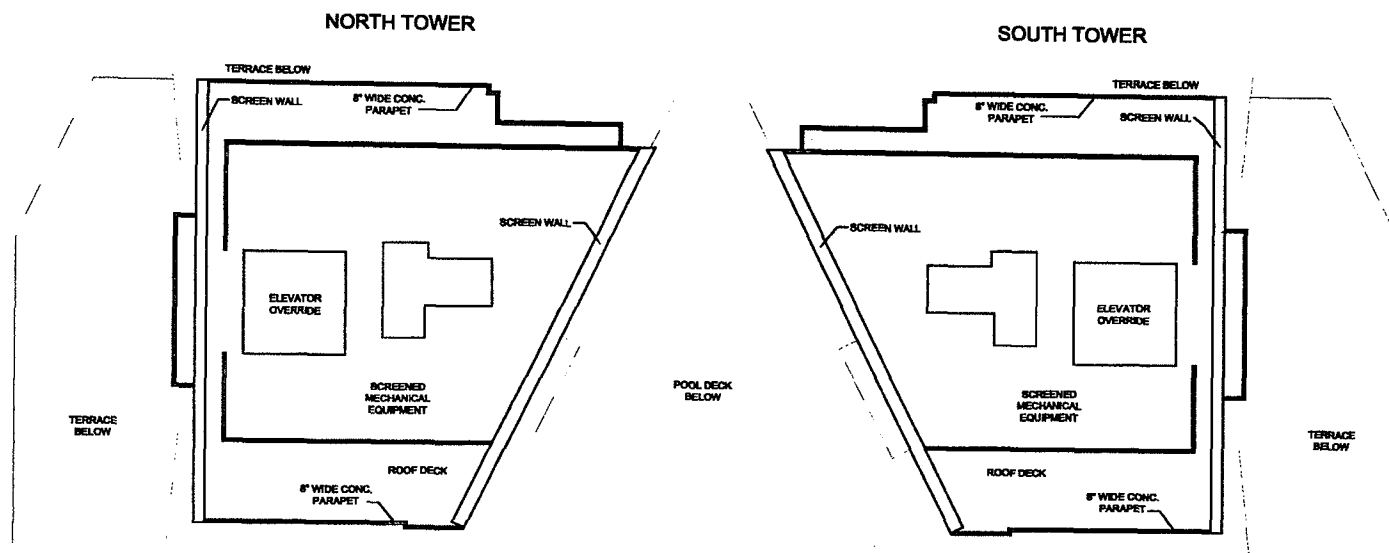


UPPER PENTHOUSE LEVEL

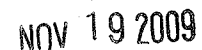

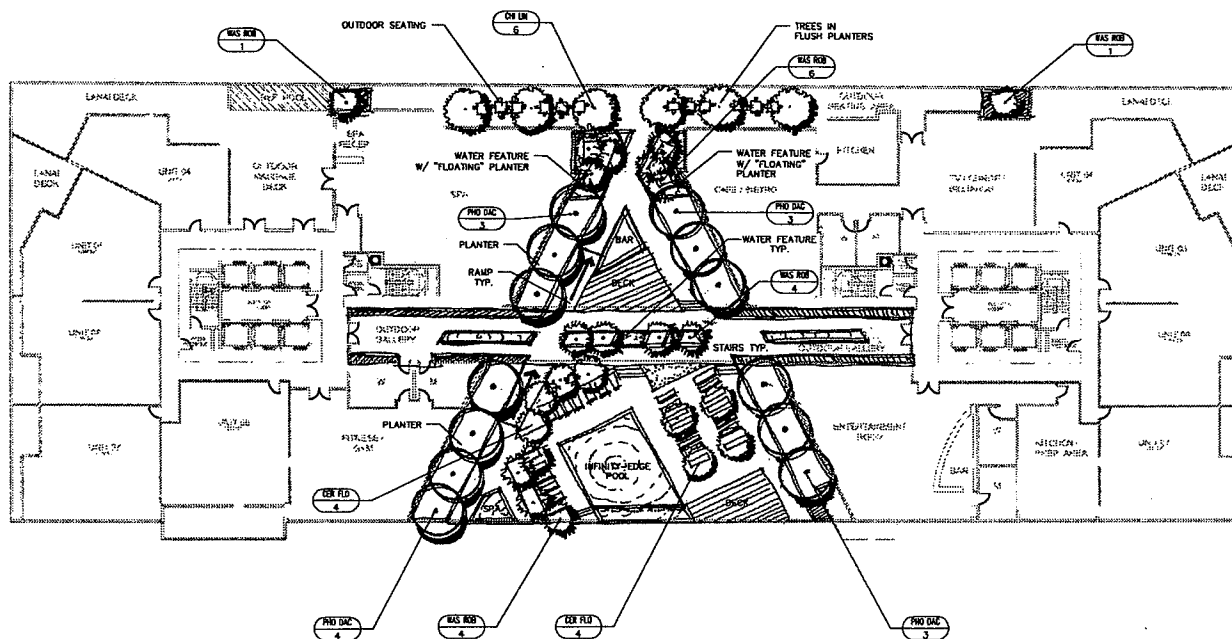

ALL LANDSCAPE BED AREAS TO RECEIVE 100% COVERAGE BY MEANS OF AN AUTOMATIC SPRINKLER SYSTEM.

ALL PLANTINGS SHALL INCLUDE 3" LAYER OF DOUBLE SHREDDED CYPRUS.

PLANT LIST QUANTITIES ARE PROVIDED FOR CONVENIENCE. IN THE EVENT OF QUANTITY DISCREPANCIES, THE DRAWING SHALL TAKE PRECEDENCE. IT IS THE CONTRACTOR'S RESPONSIBILITY TO VERIFY PLANT MATERIAL QUANTITIES, INCLUDING SOO AND MULCH. CONTRACTOR SHALL INSURE THAT ADEQUATE WATER IS SUFFICIENTLY SUPPLIED IN NECESSARY QUANTITIES TO ALL NEWLY INSTALLED PLANTINGS TO ESTABLISH PLANT MATERIAL.

ALL LANDSCAPING SHALL BE INSTALLED ACCORDING TO SOUND NURSERY PRACTICES AND SHALL BE FLORIDA NO. 1 OR BETTER AS GIVEN IN "GRADES AND STANDARDS FOR NURSERY PLANTS", STATE OF FLORIDA, DEPARTMENT OF AGRICULTURE.

ALL PLANTING BED AREAS HAVE A MINIMUM OF 24" OF PLANTING SOIL AND ALL SOOED AREAS SHALL HAVE 2" OF PLANTING SOIL. THE PLANTING SOIL SHALL BE 40% MULCH AND 60% SAND, UNLESS FIELD OBSERVATION AND SOIL ANALYSIS INDICATES A DIFFERENT COMPOSITION. THE LANDSCAPE ARCHITECT MAY REQUIRE SOIL ANALYSIS TO BE SUBMITTED IF DEEMED APPROPRIATE.

ALL SOIL SHALL BE FREE OF WEEDS, LARGE ROCKS (OVER 3" DIAMETER) DEBRIS (INCLUDING LIMBS, STEMS, OLD IRRIGATION PIPE, AND OTHER NON-ORGANIC MATERIALS). THE USE OF RECYCLED COMPOST AS A SOIL AMENDMENT IS RECOMMENDED.

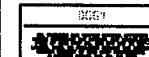

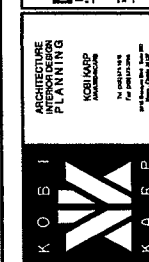
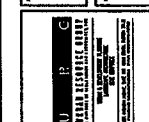
