PURPOSE/BACKGROUND:

The condition of the property was a public hazard and an attractive nuisance. The Department of Neighborhood Services declared the property in violation and started legal notification. When no corrective action was taken nor an appeal filed the Department of Neighborhood Services hired American Demolition to remove all trash, dead trees and limbs, and high vegetation. To date, there have been nine (9) inspections conducted at this location. The value of the property based on the sale date of May 2006 was \$79,706.

RECOMMENDATION:

That the City Council: Approve the report of expenses to include \$1,199 invoice for American Demolition services in addition to other fees assessed for a total of \$5,148.85 and consider assessing a maximum of \$29,550 in daily civil penalties.
