NORTH ELEVATION

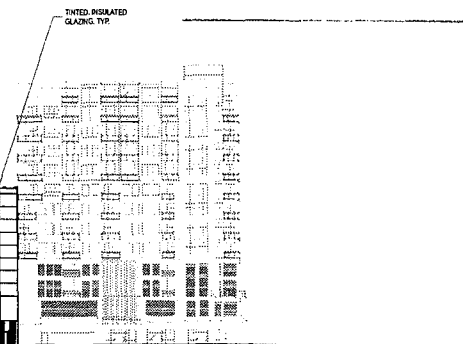
