Dear City Council:

I do not support zoning change from R-E (Residence Estates) to C-V (Civic). According to a planner I spoke with today, this zoning change will make it easier for the new planned shooting range to be legally developed. If that is factually true, then this is bad public policy and terrible planning because the planned rifle shooting range is too close to children in schools like Arbor View High School and nearby parks like Tule Springs, residents in houses in Silverstone Ranch, and people playing golf on Silverstone Ranch Golf Course.

According to the shooting range rifle range layout diagram posted on the Clark County website, the line of fire is pointing south towards innocent people in houses and schools!!! People can be hurt and killed by stray rifle bullets which can travel more than a mile. It is probable that rifle bullets can make it through or ricochet around ineffective southern barriers.

The City Council needs to use some good sense and put a stop to allowing the 697.78 acres generally located at 9200 Tule Springs Road (APN 125-04-301-005) to be used for development of a new shooting range.
