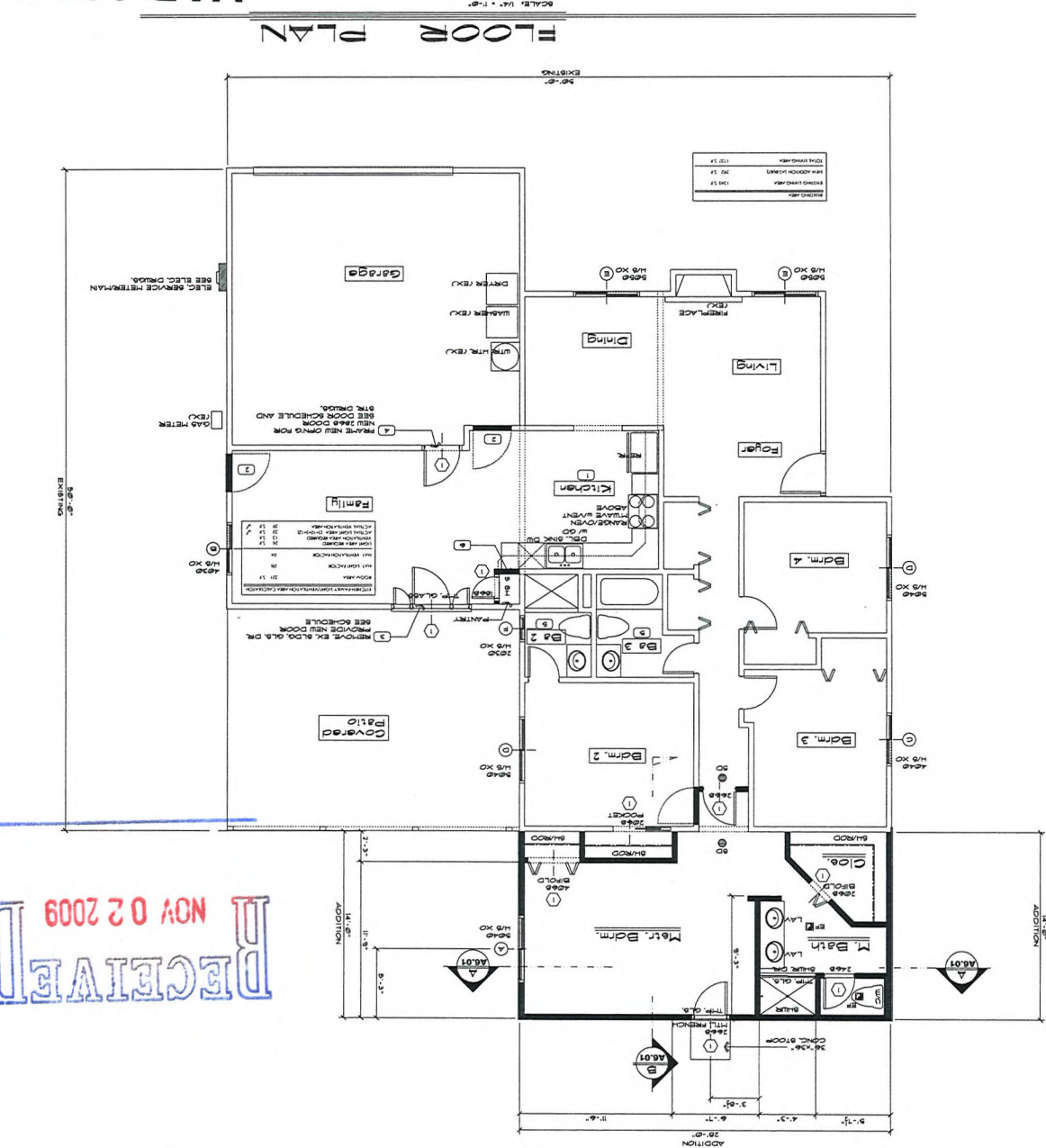

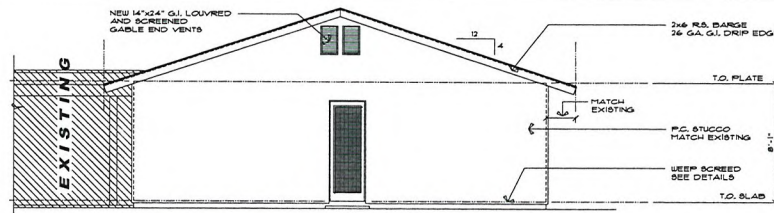

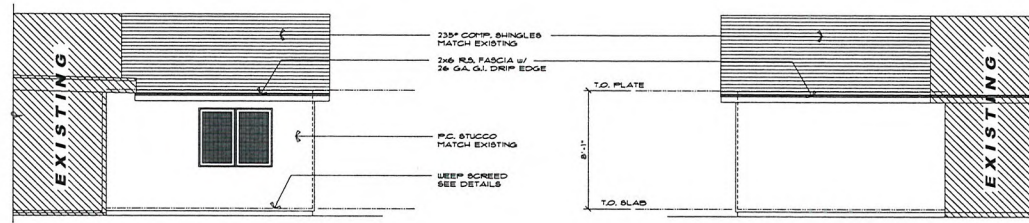

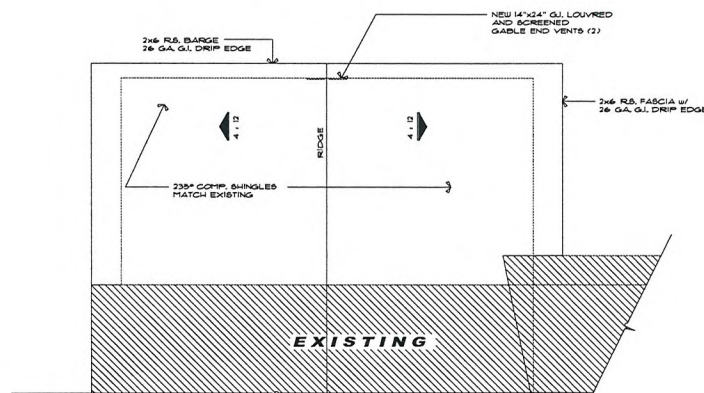


RIGHT SIDE ELEVATION
