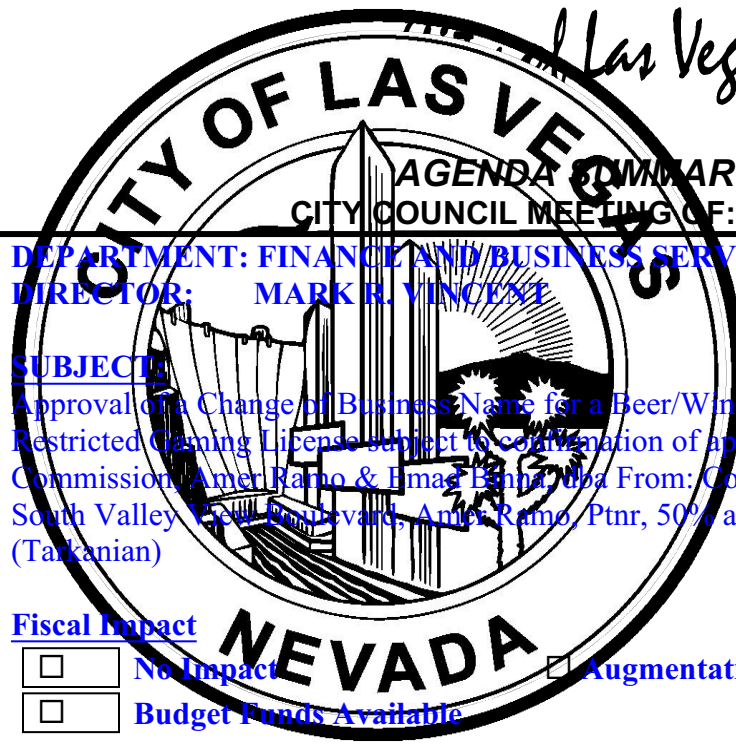

PURPOSE/BACKGROUND:

Approval of a Change of Business Name for a Beer/Wine/Cooler On-sale License and a Restricted Gaming License for 15 slots.

RECOMMENDATION:

Recommend approval subject to confirmation of approval by the Nevada Gaming Commission and with the following conditions:

- 1) The owner or key employee shall be on the premises during the hours of 2:00 p.m. to 11:00 p.m.
- 2) The business hours shall be from 6:00 a.m. to 11:00 p.m.
- 3) Employed security in uniform shall be on the premises during the hours of 6:00 p.m. to 11:00 p.m.
- 4) The lighting in the rear of the store shall be improved to meet Metro's standards for safety.
- 5) The licensees will continue to keep the site clean and free of trash.
- 6) Window signage shall be limited to 25 percent or less of the window space.
- 7) The safety of the rear entrance shall be approved by Metro.
- 8) The licensees shall work with Boulder Area Command to eliminate crime and attend the First Tuesday program and join the Trespass program.
- 9) The shelves shall be adequately stocked with food.
