PURPOSE/BACKGROUND:

Ordinance No. 6079 adopted 2/17/2010 changed the composition of the Commission to add a new Category 10 - Archeological Profession, reduce the number of Members-At-Large from five to four and make various other changes. Terms are for four years, with no limit to the number of terms that may be served. Gregory Richard Seymour was appointed 6/6/2007 to Category 5 Representative of a Recognized Local Historic Preservation Association or Historic Preservation Interest Group. He qualifies to serve for the new Category 10 for the remainder of his term expiring 6/18/2011. Mr. Stoldal, currently representing Category 7, Members-At-Large, whose term expired 12/31/2009, qualifies to fill Category.
