PURPOSE/BACKGROUND:

The condition of the property was a public hazard and an attractive nuisance. The Department of Neighborhood Services declared the property in violation and started legal notification. When no corrective action was taken nor an appeal filed the Department of Neighborhood Services hired American Demolition to board all open doors and windows on main structure, demolish and remove unpermitted addition in rear yard, remove all trash and high vegetation. To date, there have been nine (9) inspections conducted at this location. The value of the property based on the sale date of August 1977 was \$33,500.

RECOMMENDATION:

That the City Council: Approve the report of expenses to include \$1,149 invoice for American Demolition services in addition to other fees assessed for a total of \$4,393.35 and consider assessing a maximum of \$38,050 in daily civil penalties.
