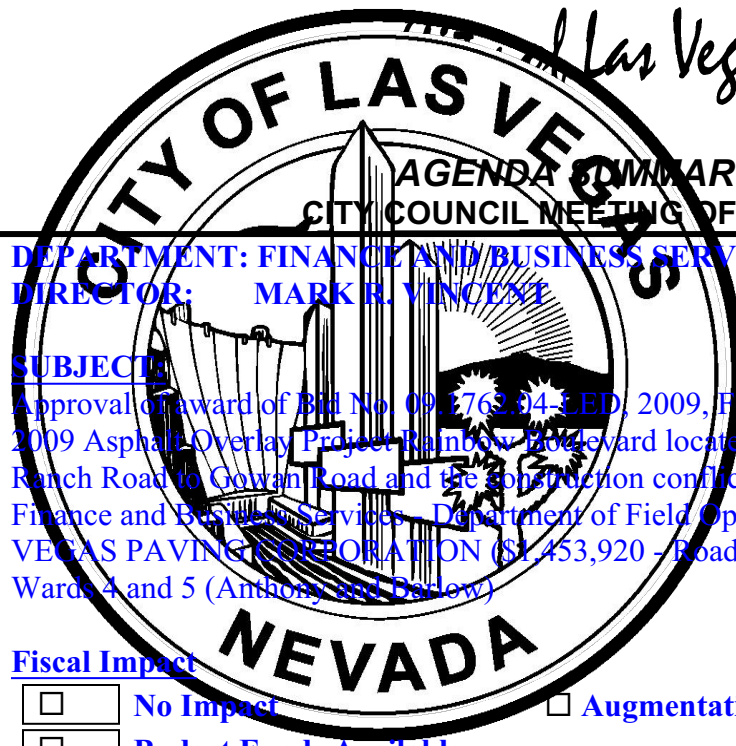

PURPOSE/BACKGROUND:

This work will consist of removal and replacement of the following: asphalt pavement, aggregate base layer, concrete sidewalks, concrete curb and gutter and asphaltic concrete pavement overlays and patches. It will also provide for installation of: tactile warning panels, new traffic delineations, markings and symbols, traffic loop detectors and ITS conduit and pull boxes and other related work. Funding for this project is being provided by the American Recovery and Reinvestment Act (ARRA) of 2009.
