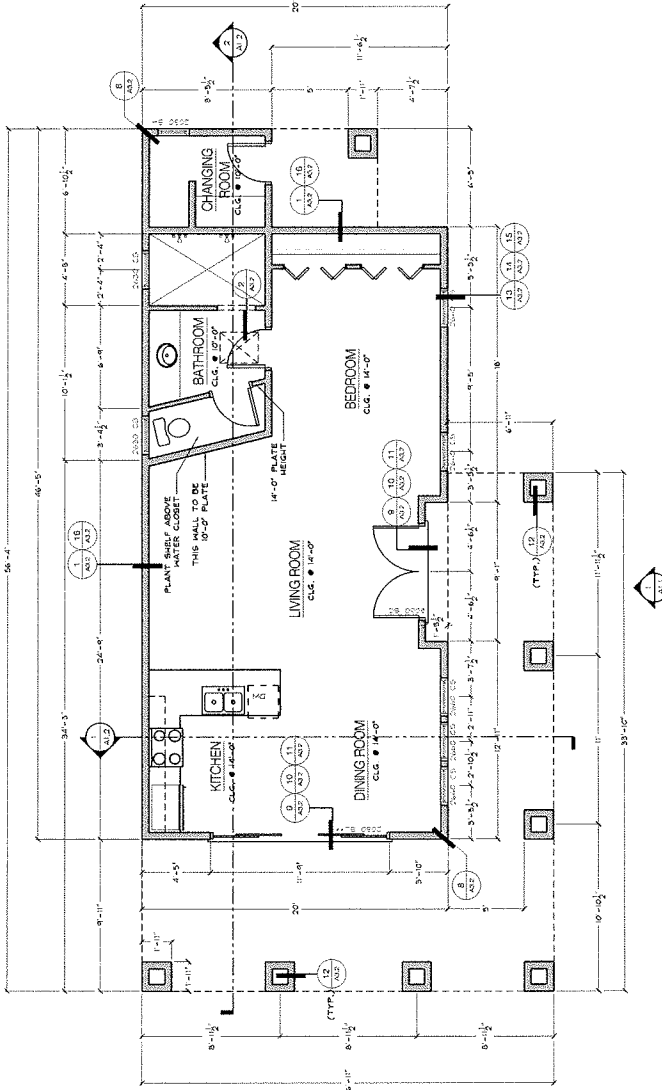

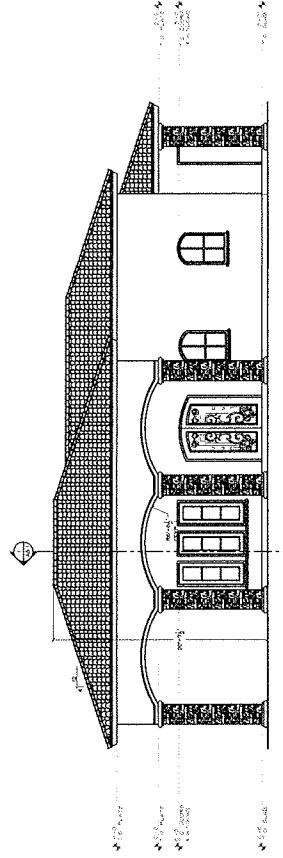
LEFT ELEVATION



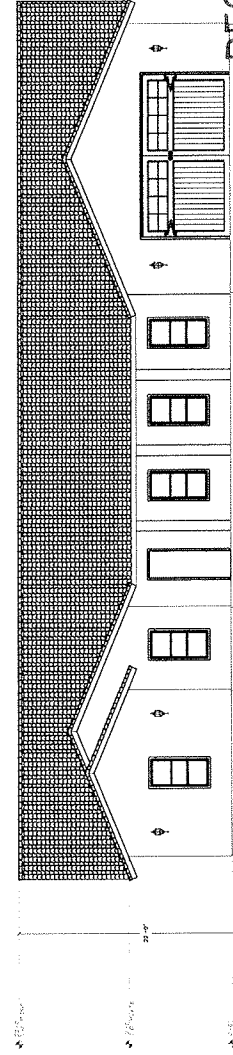
REAR ELEVATION
