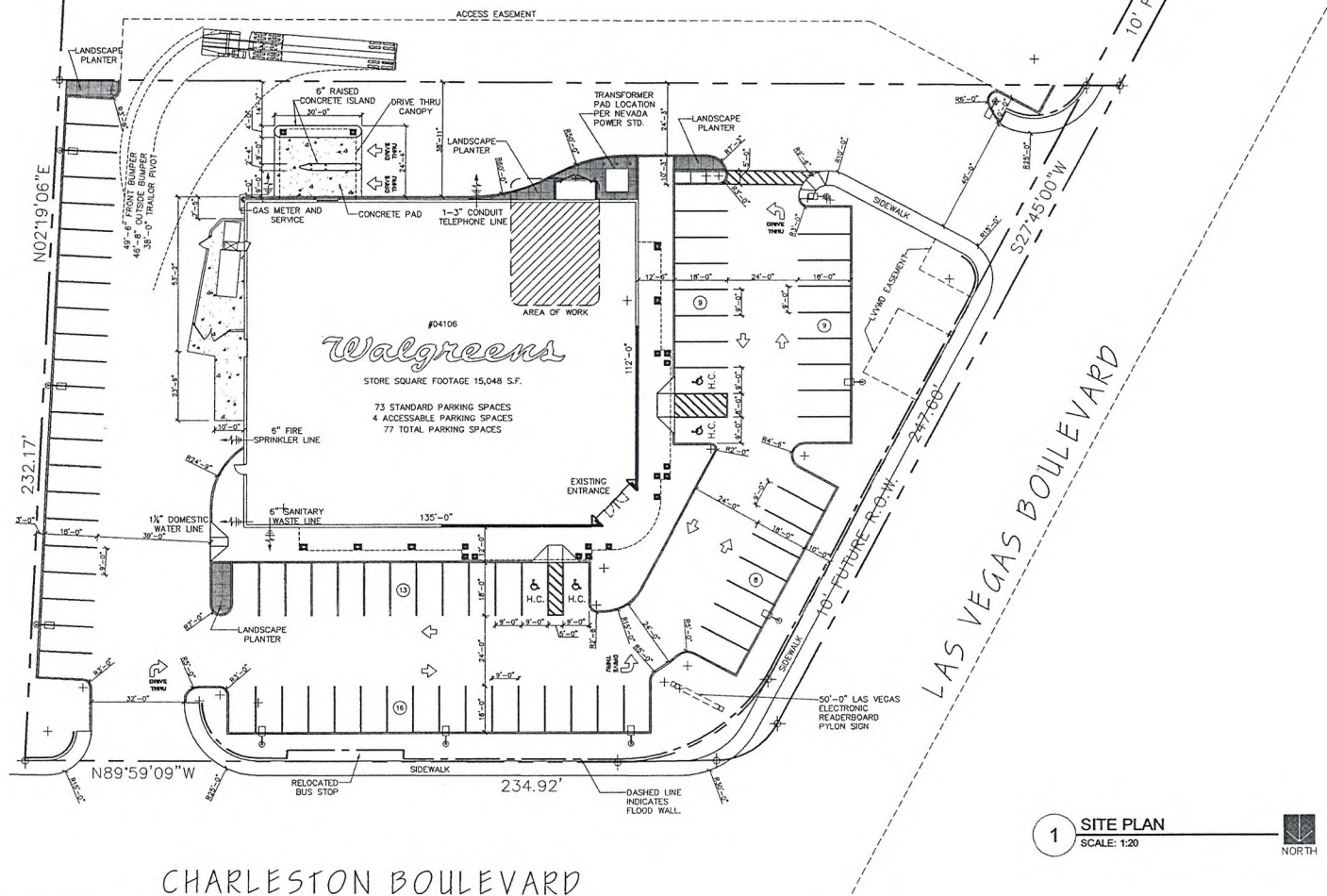

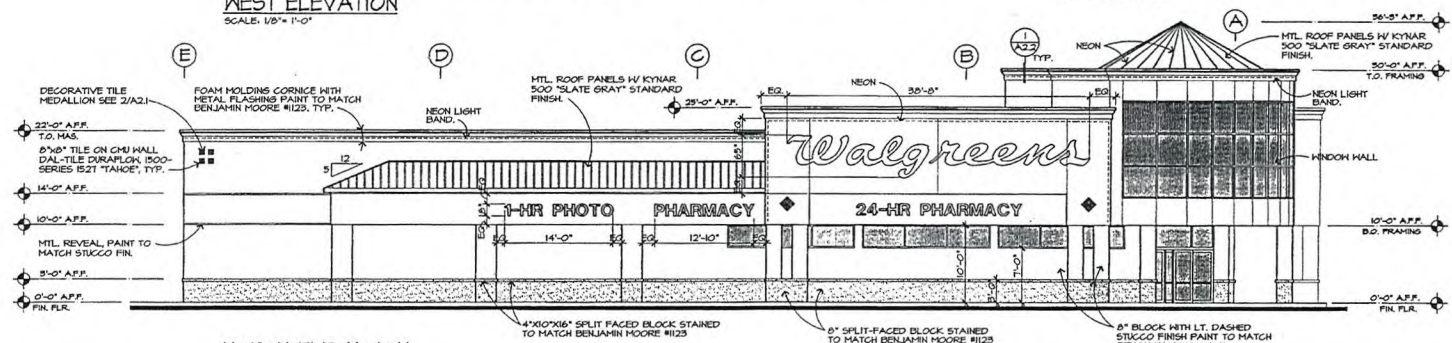

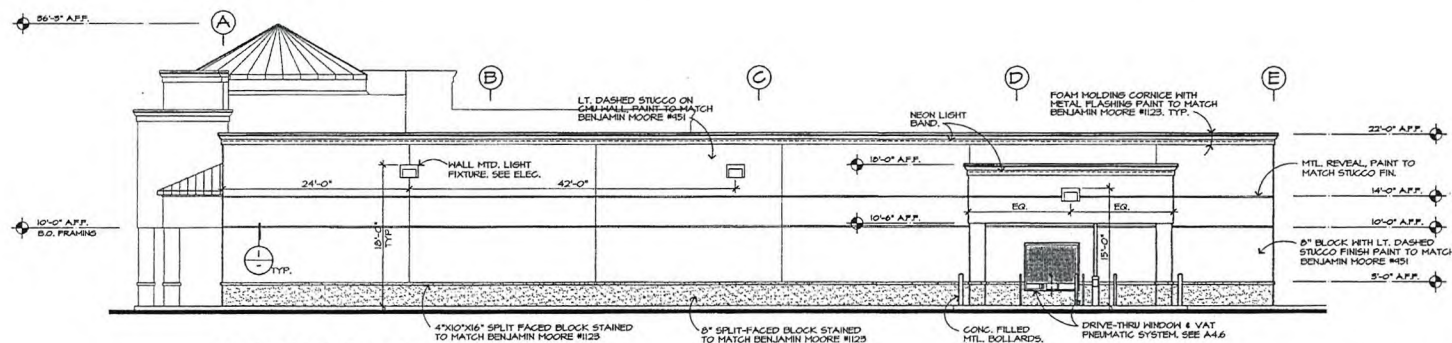
WEST ELEVATION

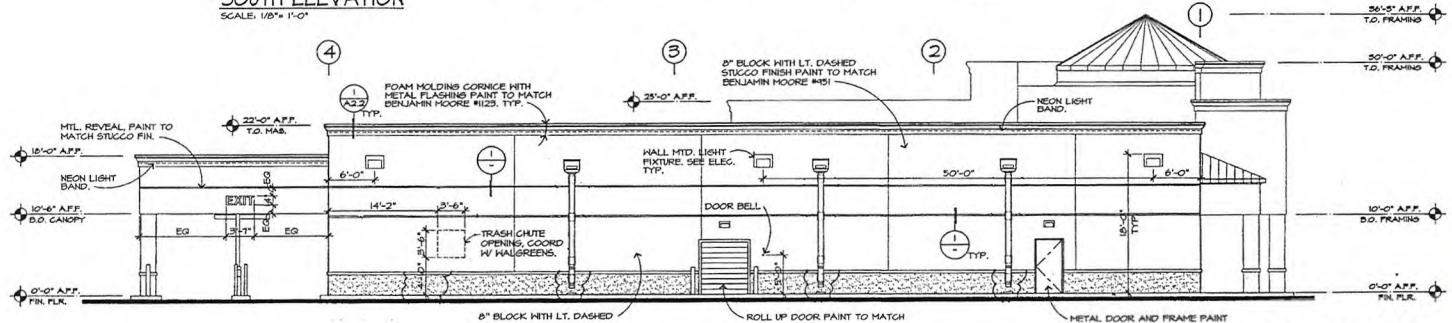
NORTH ELEVATION
