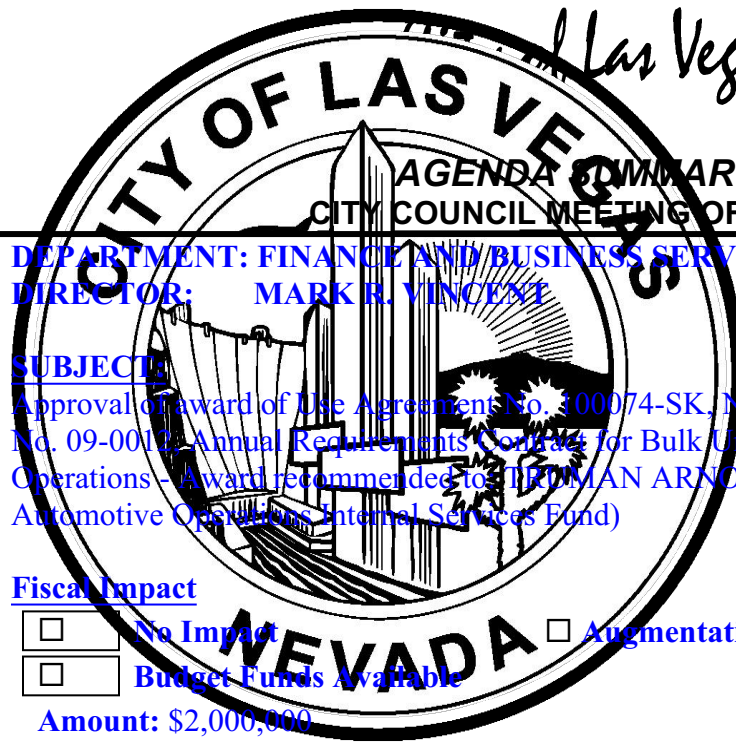

PURPOSE/BACKGROUND:

On November 10, 2009 the City Council of the City of Fort Worth, Texas approved the award of RFP No. 09-0012 for an annual requirements contract for bulk motor fuels. This agreement will provide for the purchase and delivery of bulk unleaded gasoline for use by the City of Las Vegas. This purchase is exempt from the competitive bidding process pursuant to NRS 332.195, which allows local governments to use the contracts of other local governments with the authorization of the contracting vendor.

The initial term will be from July 7, 2010 through November 9, 2010 to coincide with the Master Agreement with four one-year renewal options.
