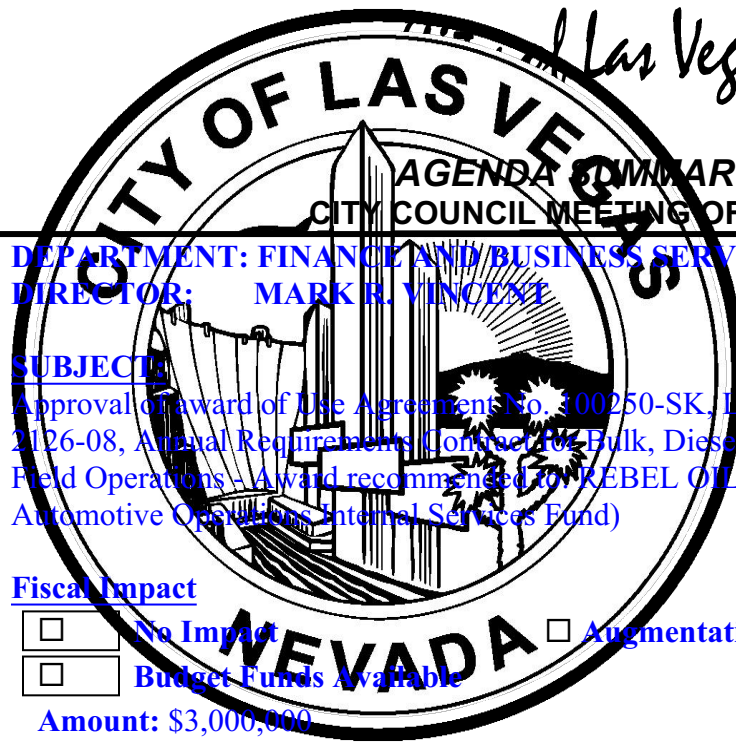

PURPOSE/BACKGROUND:

On March 3, 2009, the Board of Directors of the Las Vegas Valley Water District approved the award of Bid No. 2126-08 for an annual requirements contract for Bio-Diesel and #2 Diesel Fuel to Rebel Oil Company, Inc. This agreement will provide for the purchase and delivery of bulk diesel and bio-diesel for use by the City of Las Vegas. This item is exempt from the competitive bidding process pursuant to NRS 332.195, which allows local governments to use the contracts of other local governments with the authorization of the contracting vendor.

RECOMMENDATION:

That City Council approve the award of Use Agreement No. 100250-SK, Annual Requirements Contract for Bulk Diesel and Bio-Diesel Fuels to Rebel Oil Company, Inc. in the estimated annual amount of \$3,000,000. The initial term will be from July 7, 2010 through February 28, 2011 to coincide with the Master Agreement, with three one-year renewal options. Authority to execute the Agreement is given to the Purchasing Manager per R-48-2006.
