PURPOSE/BACKGROUND:

On July 1, 2009 City Council approved award of Bid No. 08.15341.04-LED (Revised), Rehabilitation of the Las Vegas Museum of Organized Crime and Law Enforcement. This modification is necessary for the design and installation of the fire pump, mechanical, plaster repair and other construction items. Funding is being provided 20% by a Centennial Grant and 80% by the General Fund.
