PURPOSE/BACKGROUND:

Ran Oriental Therapy's LLC d/b/a Oriental Angels Massage holds Massage Establishment License M03-00107-6-100306. Jinli Ran is the owner of Ran Oriental Therapy's LLC and also holds Massage Therapist License No. M12-00187-5-094559. Between 2008 and 2010, five individuals employed at Oriental Angels Massage have been arrested for soliciting prostitution. As a result of these repeated offenses, it is alleged that Ran Oriental Therapy's LLC d/b/a Oriental Angels Massage has operated in an illegal manner, contrary to law and in violation of LVMC 6.02.330, 6.52.120, NRS 201.354(1) and LVMC 10.36.020(A).

RECOMMENDATION:

Recommend revocation of Massage Establishment License M03-00107-6-100306

4 has been served upon you. You may be present at the hearing and you may be represented by
5 a lawyer. You may present any relevant evidence you have, and you will be given full
6 opportunity to cross examine all witnesses testifying against you.

7 YOU ARE FURTHER NOTIFIED that within twenty (20) days after service of the
8 Complaint for Disciplinary Action, but not later than five (5) days before the hearing date, you
9 must file with the City Clerk, First Floor, City Hall, 400 Stewart Avenue, Las Vegas, Nevada,
10 89101, and serve a copy upon the City Attorney of your answer to the charges made in the
11 Complaint for Disciplinary Action, and set forth any affirmative defenses you intend to raise.

12 YOU ARE ALSO NOTIFIED that your failure to file an answer to the Complaint for
13 Disciplinary Action or to appear at the hearing shall constitute an admission to all the matters

**COMPLAINT FOR
DISCIPLINARY ACTION**

The DEPARTMENT OF FINANCE AND BUSINESS SERVICES, on behalf of the
CITY OF LAS VEGAS, NEVADA (Department), Petitioner, brings this Complaint for
Disciplinary Action against RAN ORIENTAL THERAPY'S LLC, a Nevada limited liability
company, d/b/a ORIENTAL ANGELS MASSAGE, and JINLI RAN, individually and as
officer of RAN ORIENTAL THERAPY'S LLC, 2600 West Sahara Avenue, #115, Las Vegas,
Clark County, Nevada, Respondents, and states:

Respondent RAN ORIENTAL THERAPY'S LLC holds a privileged Massage
Establishment License No. M03-00107-6-100306. Respondent JINLI RAN is the sole officer
and member of Respondent RAN ORIENTAL THERAPY'S LLC and also holds Massage
Therapist License No. M12-00187-5-094559.

1 **SUMMARY OF ALLEGATIONS**

2 ORIENTAL ANGELS MASSAGE is owned by JINLI RAN through her interest in
3 RAN ORIENTAL THERAPY'S LLC, a Nevada limited liability company. It has been
4 operated repeatedly in an unlawful manner by creating a public and chronic nuisance in
5 violation of Nevada law and the Las Vegas Municipal Code by allowing its massage therapists
6 to engage in solicitation of prostitution.

7 **SOLICITATION OF PROSTITUTION**

8 On January 8, 2008, an undercover detective with the Las Vegas Metropolitan Police
9 Department entered Oriental Angels Massage and agreed with one Wenjuan Li to receive a
10 one-hour massage for the price of \$70. During the course of the massage, Ms. Li agreed to
11 perform an act of manual masturbation upon the detective for an additional \$80. Ms. Li was
12 arrested on charges of Soliciting Prostitution. On October 1, 2008, Ms. Li entered a plea of nolo
13 contendere, pursuant to negotiation, to a reduced charge of Obscene Massage.

14 On December 24, 2008, an undercover detective with the Las Vegas Metropolitan Police
15 Department entered Oriental Angels Massage and agreed with one Mei Zhao to receive a one-
16 hour massage for the price of \$70. During the course of the massage, Ms. Zhao agreed to
17 perform an act of manual masturbation upon the detective for an additional \$200. Ms. Zhao was
18 arrested on a charge of Soliciting Prostitution. On September 9, 2009, Ms. Zhao entered a plea
19 of guilty to the charge of Soliciting Prostitution.

20 On July 22, 2009, an undercover detective with the Las Vegas Metropolitan Police
21 Department entered Oriental Angels Massage and agreed with one Mei Wan Kong to receive a
22 massage. During the course of the massage, Ms. Kong agreed to perform an act of manual
23 masturbation upon the detective for an additional \$50. Ms. Kong was arrested on a charge of
24 Soliciting Prostitution.

25 On October 21, 2009, an undercover detective with the Las Vegas Metropolitan Police
26 Department entered Oriental Angels Massage and agreed with one Xue Rong Fu to receive a one-
27 hour massage for the price of \$70. During the course of the massage, Ms. Fu agreed to perform
28

1 an act of manual masturbation upon the detective for an additional \$60. Ms. Fu was arrested on a
2 charge of Soliciting Prostitution.

3 On February 19, 2010, an undercover detective with the Las Vegas Metropolitan Police
4 Department entered Oriental Angels Massage and agreed with Xue Rong Fu to receive a half-
5 hour massage for the price of \$50. During the course of the massage, Ms. Fu agreed to perform
6 an act of manual masturbation upon the detective for an additional \$50. Ms. Fu was arrested on a
7 charge of Soliciting Prostitution.

8 After each arrest Respondent RAN was notified of the arrest of her employee for
9 Soliciting Prostitution and of the violation of City ordinances regarding massage establishments.

10 **CODE COMPLIANCE FAILURE**

11 On March 29, 2007, detectives with the Special Investigations Section of the Las Vegas
12 Metropolitan Police Department conducted a compliance check at Oriental Angels Massage.
13 During the course of the inspection, the detectives spoke with Mai Tieu and Sun Wee who both
14 identified themselves as massage therapists. Neither Tieu nor Wee were licensed as massage
15 therapists by the City of Las Vegas as required by Las Vegas Municipal Code (LVMC) 6.52.040.
16 Both Tieu and Wee were issued citations for acting as massage therapists without a valid license.
17 Respondent RAN admitted to the detectives that she employed Tieu and Wee as massage
18 therapists, however, neither individual was included on the register of employees of Oriental
19 Angels Massage as required by LVMC 6.52.080. Respondent RAN was issued citations for
20 failing to include Tieu and Wee on the register of employees and allowing them to work as
21 massage therapists without the required license.

22 On November 5, 2007, Sun Wee was found guilty of the offense of acting as a massage
23 therapist without the required license pursuant to a plea of nolo contendere. On October 22,
24 2007, Mai Tieu entered plea of guilty to the charge of acting as a massage therapist without the
25 required license. On January 28, 2008, Respondent RAN was convicted of the offense of failing
26 to include Tieu and Wee on the register of employees for Oriental Angels Massage.

1 OTHER ACTS

2 Respondent JINLI RAN is also the owner of three massage establishments operated under
3 the names of Shangri La Health Clinic, Asian Garden and Desert Paradise Spa. Each of these
4 establishments has a history of offenses for soliciting prostitution. Detectives made four arrests
5 for Soliciting Prostitution at Shangri La Health Clinic between 2006 and 2009. Detectives made
6 four arrests for Soliciting Prostitution at Asian Garden between 2007 and 2010. Detectives made
7 one arrest for Soliciting Prostitution at Desert Paradise Spa in 2009.

8 SUBSTANTIVE LAW

9 LVMC 6.02.330 provides [Unlawful Business Activity]:

10 A licensee may be subject to disciplinary action by the City
11 Council for good cause, which may, without limitation, include the
following:

12 (A) The licensee or any of its principals is engaged, or has
13 commenced, instituted, advertised, aided, carried on, continued or
14 engaged, in a business, trade or profession without having obtained
15 a valid license, an approval for suitability, a permit or a work card
16 when such a person knew that one was required or under such
circumstances that they reasonably should have known one was
required, or has solicited, encouraged, caused or procured another
to do so;

17

18 (D) The licensee or any of its principals, or their employees
or those acting on their behalf, violate a condition which is
19 imposed upon the license;

20

21 (G) The premises on which the business is conducted do
not satisfy local, state or federal law or regulations which pertain to
22 the activity which is actually engaged in;

23 (H) The business activity constitutes, promotes, causes,
allows, fosters, aids, or otherwise enables a private nuisance,
24 public nuisance or chronic nuisance, or has been or is being
conducted in an unlawful, illegal or impermissible manner,
25 including but not limited to causing, allowing, promoting,
fostering, aiding, enabling, exercising deliberate ignorance towards
26 or failing to abate a private nuisance, public nuisance or chronic
nuisance; or

27 (I) The licensee, any of its principals, their employees or
28 those acting on their behalf failed to cooperate with the Director's
efforts to enforce the provisions of this Code.

1 LVMC 6.02.350 provides [Acts and Omissions]:

2 A licensee under this Title shall be subject to disciplinary
3 action not only for acts or omissions done by such licensee but also
4 for acts and omissions done by the principals, managers, agents,
representatives, servants or employees of such licensee.

5 LVMC 6.52.120 provides [Prohibited Activities]:

6 It is unlawful for a massage establishment licensee, or a
7 principal or employee thereof, to do any of the following:

8 (A) Within a massage establishment, engage in or solicit
9 sexual activity during the course of performing massage therapy on
a person, with or without the consent of the person, including,
without limitation, if the licensee, principal or employee:

10 (1) Made sexual advances toward the person;

11 (2) Requested sexual favors from the person; or

12 (3) Massaged, touched or applied any instrument to the
13 breasts of the person, unless the person has signed a written
consent form provided by the Nevada Board of Massage
14 Therapists;

15 (B) Within a massage establishment, allow a massage
therapist to engage in or solicit sexual activity in violation of
16 Subsection (A) of this Section;

17 (C) Engage in false, deceptive or misleading advertising
18 regarding the services available within a massage establishment,
including, without limitation, false, deceptive or misleading
19 advertising regarding the training that a massage establishment
licensee, principal or employee has received.

20 LVMC 6.52.080 provides [Register of Employees]:

21 The licensee or principal of a massage establishment shall
22 maintain a register of all persons who at any time are employed or
contracted as massage therapists and their City and State license
23 numbers. Such register shall be made available upon request to
representatives of the Department or Metro during regular business
24 hours.

25 LVMC 6.52.040 provides [License Required]:

26 No person shall engage in, conduct or carry on, or permit to
27 be engaged in, conducted or carried on, in or upon any premises,
the operation of a massage establishment, or the performance of
28 massage therapy as a massage therapist or a massage establishment
licensee practitioner, without first obtaining and thereafter

1 maintaining a valid unexpired license for that activity pursuant to
2 this Title.

3 NRS 201.354(1) provides [Solicitation of Prostitution]:

4 It is unlawful for any person to engage in prostitution or
5 solicitation therefor, except in a licensed house of prostitution.

6 LVMC 10.36.020(A) provides [Solicitation of Prostitution]:

7 It is unlawful for anyone, other than a Peace Officer acting
8 within the scope of his or her employment, to:

9 (1) Commit, engage in, institute, solicit, offer or agree to
10 commit an act of prostitution;

11 (2) Attempt to commit, engage in, or institute an act of
12 prostitution; or

13 (3) Intentionally facilitate, allow, permit, encourage,
14 procure, negotiate or provide a fee for an act of prostitution.

15 STANDARD OF EVIDENCE

16 LVMC 6.88.090 provides:

17 (A) The hearing need not be conducted according to
18 technical rules relating to evidence and witnesses. Any relevant
19 evidence may be admitted.

20 (B) The respondent shall have the right to call and examine
21 witnesses on his own behalf, cross-examine opposing witnesses,
22 introduce exhibits and evidence relevant to the issues of the case,
23 and offer rebuttal evidence.

24 (C) The respondent may be called and examined by the
25 City.

26 (D) The Clerk shall have the power to issue subpoenas for
27 witnesses to appear to give testimony.

28 PENALTY

LVMC 6.02.360 provides:

Upon a showing of good cause and in the discretion of the
City Council, disciplinary action against a holder may take the
form of cancellation, revocation, refusal to renew, suspension,
imposition of conditions or restrictions or civil fine in an amount
not to exceed one thousand dollars for each day that the violation
which forms the subject matter of the complaint that recommends
such disciplinary action is demonstrated to have been in existence,

1 or any combination of such actions, as the particular situation may
2 require. The Council may also impose against the licensee the
3 actual costs incurred, and a reasonable amount for attorney's fees,
4 resulting from the imposition of disciplinary action. The
disciplinary actions available in this Section shall be in addition to,
and not exclusive of, any other civil or criminal remedy which
otherwise might be available.

5 **ALLEGATIONS**

6 **COUNT ONE**

7 It is alleged that between March 29, 2007 and present, Respondents RAN ORIENTAL
8 THERAPY'S LLC d/b/a ORIENTAL ANGELS MASSAGE and JINLI RAN operated a business
9 which constituted a public, private and chronic nuisance and which has been conducted in an
10 unlawful, illegal and impermissible manner, to wit: creating, promoting, fostering, aiding,
11 enabling, exercising deliberate indifference towards or failing to abate a public nuisance, private
12 nuisance or chronic nuisance and permitting an environment in which solicitation of prostitution
13 occurred in violation of the Las Vegas Municipal Code and Nevada Revised Statutes.

14 **COUNT TWO**

15 It is alleged that between March 29, 2007 and present, Respondents RAN ORIENTAL
16 THERAPY'S LLC d/b/a ORIENTAL ANGELS MASSAGE and JINLI RAN operated a business
17 which they and its principals, employees and others acting on its behalf failed to require of its
18 employees and others related directly and indirectly to the business to acquire, maintain and
19 report required licenses, registers of employees and other required documents and failing to
20 cooperate with the Director of Business Services' efforts to enforce the provisions of the Las
21 Vegas Municipal Code, in violation of the Las Vegas Municipal Code and the Nevada Revised
22 Statutes.

23 WHEREFORE, the Petitioner respectfully requests the City Council to:

24 A. Approve the Complaint for Disciplinary Action and order a disciplinary hearing
25 at which the Respondents shall appear and show cause why the licenses that are the subject of
26 this Complaint should not be suspended or revoked, or other disciplinary action taken; or

1 B. Grant such other and further relief as the Council deems appropriate.

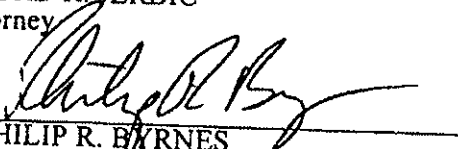

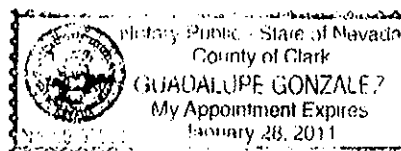

RESPONDENTS' RAN ORIENTAL THERAPY'S LLC, a Nevada limited liability
company/d/b/a ORIENTAL ANGELS MASSAGE and DR. JINLI RAN'S ANSWER TO
CITY OF LAS VEGAS'S COMPLAINT FOR DISCIPLINARY ACTION

COMES NOW, Respondents, RAN ORIENTAL THERAPY'S LLC, a Nevada limited
liability company/d/b/a ORIENTAL ANGELS MASSAGE and DR. JINLI RAN, by and through
their attorney, C. CONRAD CLAUS, ESQ., and hereby submits their ANSWER TO CITY OF
LAS VEGAS'S COMPLAINT FOR DISCIPLINARY ACTION, and answers and alleges as
follows:

ANSWER

1
2 1. Respondents deny Count one of the Complaint. Further, the Respondent submit that the
3 allegations that the Respondents created, promoting, fostered, aided, enabling, exercised
4 deliberate indifference towards or failing to abate a public nuisance, private nuisance or chronic
5 nuisance and permitting an environment in which solicitation of prostitution occurred are
6 impermissibly vague. These generalized allegations do not articulate a sufficient factual basis in
7 order that she may prepare her defense. Said vague allegations deny her of her 6th and 14th
8 Constitutional Rights.

9 2. Respondents deny Count two of the Complaint. Specifically answering, the Respondent
10 JINLI RAN is a licensed acupressurist, as well as duly licensed Oriental Medical Doctor. She is
11 also licensed in Chinese Herbs. See Exhibits A 1, 2, 3. By virtue of her occupation, she is
12 exempted from having to register, report, or require licenses for assistants who help her in the
13 performance of the practice in her healing arts license, per NRS 634A.200.

FACTUAL REPLY IN SUPPORT OF RESPONDENTS' ANSWER.

THE SOLICITATION OF PROSTITUTION ALLEGATION

16 The Respondent, Dr. JINLI RAN, operates ORIENTAL ANGELS MASSAGE, through
17 her LLC, RAN ORIENTAL THERAPY'S LLC. She holds a privilege license, Massage
18 Establishment License No. M03-00107-6-100306. She also holds Massage Therapist License
19 No. M12-00187-5-094559. She requires message therapists to sign a Service Contract, a
20 representative sample of the Service Contract is attached as **Exhibit B**. This contract spells out
21 in plain and simple words that no unethical, nude, or sexual behavior will be tolerated.
22 Additionally, the therapist must have her license with them at all times, is not allowed to
23 perform outcall massage, and is solely responsible for any fines and penalties for their conduct.

24 There are consequences for those who violate their contract. The therapists are required
25 to post a performance deposit, and their deposit is forfeited for ANY violation of sections 3 and

1 4 of their contract. Additionally, the offending therapist's contract is terminated. This written
2 contract provides strict rules of conduct, with accompanying stiff penalties if that behavior is
3 violated. Respondent has promptly terminated therapists' contracts of those who decide to
4 commit violations of the law, save and except for allowing one person a second chance. This is
5 really all Dr. Ran should be expected to do, in order to safeguard and maintain the well being of
6 the establishment.

7 The contract and prompt enforcement of same demonstrates that Respondent actively
8 discourages unethical or unlawful behavior. There are strict punitive sanctions. The violations
9 listed in the Complaint regarding solicitation of prostitution are conduct BY OTHERS, There is
10 no evidence that Dr. Ran ever encouraged, acquiesced, or in any manner tolerated this conduct.
11 She has never been charged as an accomplice or an aider and abettor to these acts unknowingly
12 committed by Ms. Li, Mei Zhao, Mei Wan Kong, or Xue Rong Fu, these violations being
13 articulated in the City's Complaint. Dr. Ran is compassionate, and when Xue Rong Fu begged
14 for a second chance, Dr. Ran relented, allowed her a second chance, promising that nothing like
15 this would ever happen again. Unfortunately, Ms. Fu was not true to her word, and continued to
16 violate the law. This time, the termination of the contract was permanent. The allowing of a
17 second chance for this one therapist falls far short of establishing that Dr. Ran is guilty of any of
18 the vague and generalized allegations in Count One.

19 THE CODE COMPLIANCE FAILURE ALLEGATION

20 Dr. Ran is a licensed OMD, she displays her licenses on the premises. As a part of her duties
21 as an OMD, she often utilizes acupuncture and acupressure techniques. Said techniques
22 frequently require the use of assistants. Mai Tieu and Sun Wee were such assistants on March
23 29, 2007. They were dressed like medical assistants, their apparel was clearly in contrast to the
24 way the licensed massage therapists were clad. This is because their job duties were not as
25 massage therapists, but as assistants to Dr. Ran, for whom they worked in their singular scope

1 and duty as assistants her in performing acupressure. When these two individuals assisted Dr.
2 Ran with the patients' acupressure, Dr. Ran was on premises, and present in the areas with these
3 assistants, who were merely assisting her. Additionally, on the date that the detectives saw these
4 two individuals, they were merely present on the premises, they were not performing any job
5 duties, as the only way that this could lawfully occur is by assisting Dr. Ran with acupressure.
6 These assistants are not required to be licensed, or to register, they, and Dr. Ran, were in all ways
7 compliant with NRS 634A.200, which reads as follows:

8 **NRS 634A.200 Applicability of chapter.**

9 1. This chapter does not apply to Oriental physicians who are called into this State for consultation.

10 2. This chapter does not prohibit:

11 (a) Gratuitous services of druggists or other persons in cases of emergency.

12 (b) The domestic administration of family remedies.

13 (c) Any person from assisting any person in the practice of the healing arts licensed under this chapter,
14 except that such person may not insert needles into the skin or prescribe herbal medicine.
15 (Added to NRS by 1973, 639; A 1975, 235)

16 In response to the allegations that Dr. Ran "admitted" to the detectives that she employed
17 these two assistants as massage therapists, this contention is respectfully and adamantly denied.
18 She explained that she was an OMD, and further explained what the duties of these two
19 assistants were. It would fly in the face of logic that she would "admit" to something that did not
20 occur. Perhaps it was a misunderstanding, however, she simply explained what these girls were
21 doing at the premises. The fact that these assistants were not performing any massage, and the
22 fact that they were dressed as medical assistants is strong corroboration of her position, which is
23 further buttressed by Dr. Yan's having three healing licenses, see Exhibits A 1, 2, and 3.

24 It is true that there are convictions with respect to this alleged conduct. In mitigation and in
25 explanation, she was simply following the advice of her attorney at the time, the late Bucky
Buchanan, who implanted in her mind that the police would stop bothering her if she simply
plead and paid the fine. As it turns out, this advice was misguided, and had an adverse, rather
than positive, effect on her situation. As hearings envision a search for the truth, it is hoped that

1 this Council will see the true state of circumstances, and hopefully realize that there are simply
2 no violations that occurred.

3 OTHER ACTS ALLEGATIONS

4 As to the establishments mentioned in this section, these arrests are approximately one per
5 year. This is hardly an indication that Dr. Ran tolerates, encourages, or acquiesces in this
6 conduct. These therapists were all required to execute contracts, and all of their deposits were
7 forfeited for violation of the contract. See Exhibit B.

8 Additionally, the dispositions of these charges have not been shared with the Council, only
9 that there were charges. There is no factual basis for the conclusory statement that these
10 establishments have a "history of offenses for soliciting prostitution."

11 It cannot be overlooked that many establishments in which therapists are charged with
12 offenses such as the ones that occurred here are NOT made the focus of the discipline that the
13 City seeks with respect to Dr. Ran. There should be some proportionality here, gauged by what
14 enforcement has proceeded with similarly situated persons and establishments. For instance, the
15 owner's wife/manager of Princess Massage has been arrested on multiple occasions, yet this
16 establishment remains open. Additionally, the owner of Lucky's massage was arrested, and this
17 establishment is still in business.

18 LEGAL POSITION

19 LVMC 6.02.330A states as follows:

20 6.02.330 - Disciplinary action—Good cause designated.

21 A licensee may be subject to disciplinary action by the City Council for good cause, which may,
22 without limitation, include the following:

23 (A)

24 The licensee or any of its principals is engaged, or has commenced, instituted, advertised,
25 aided, carried on, continued or engaged, in a business, trade or profession without having
obtained a valid license, an approval for suitability, a permit or a work card when such a
person knew that one was required or under such circumstances that they reasonably
should have known one was required, or has solicited, encouraged, caused or procured
another to do so;

- 1 (B) The licensee or any of its principals has been subject, in any jurisdiction, to
2 disciplinary action of any kind with respect to a license, an approval for suitability, a
3 permit or a work card to the extent that such disciplinary action reflects upon the
4 qualification, acceptability or fitness of such licensee or principal;
- 5 (C) The licensee or any of its principals has been convicted of an act which constitutes a
6 crime which involves moral turpitude or involves any local, state or federal law or
7 regulation which relates to the same or a similar business, or has been convicted of
8 having solicited, encouraged, caused or procured another to commit such a violation;
- 9 (D) The licensee or any of its principals, or their employees or those acting on their behalf,
10 violate a condition which is imposed upon the license;
- 11 (E) The licensee or any of its principals has been convicted of having perpetrated, or has
12 solicited, encouraged, caused or procured another to perpetrate, deceptive practices upon
13 the public;
- 14 (F) The licensee or any of its principals suffers from a legal disability under the laws of the
15 State;
- 16 (G) The premises on which the business is conducted do not satisfy local, state or federal law
17 or regulations which pertain to the activity which is actually engaged in;
- 18 (H) The business activity constitutes, promotes, causes, allows, fosters, aids, or otherwise
19 enables a private nuisance, public nuisance or chronic nuisance, or has been or is being
20 conducted in an unlawful, illegal or impermissible manner, including but not limited to
21 causing, allowing, promoting, fostering, aiding, enabling, exercising deliberate ignorance
22 towards or failing to abate a private nuisance, public nuisance or chronic nuisance; or
- 23 (I) The licensee, any of its principals, their employees or those acting on their behalf failed to
24 cooperate with the Director's efforts to enforce the provisions of this Code

25 With respect to Section "A," Dr. Ran reasonably believed that her acupressure
assistants, as they did not insert needles into the patients, did not need a valid license, or approval
for suitability. As this ordinance address a culpable mental state, there is no violation in this case.
She should not be forever stigmatized and unfairly hamstrung from presenting her truthful
position at the hearing.

The city does not suggest that sections "B" or "C" apply.

With respect to Section "D," although the ordinance may be vague, the city has not
articulated exactly what condition imposed on the licensee that has been violated.

The city does not suggest that Sections, "E" or "F" apply.

With respect to section "G," while it is permissible that the ordinance is broadly worded,
Respondents' conduct, when viewed in a realistic fashion and in its totality, do not demonstrate

1 that the premises of the business do not satisfy local, state or federal law or regulation. This is
2 particularly true when the events occurring at the premises are compared with similarly situated
3 businesses which remain open.

4 Respondent will now deal with section "H." Substantively speaking, one must ask, what
5 constitutes a nuisance? The alleged actions do not fall within the statutory of "Nuisance" under
6 NRS 40.140:

7 **40.140. Nuisance defined; action for abatement and damages; exceptions.**

8 1. Except as otherwise provided in this section:

9 (a) Anything which is injurious to health, or indecent and offensive to the senses, or an
10 obstruction to the free use of property, so as to interfere with the comfortable enjoyment of life
or property;

11 In this case, there are isolated instances of alleged illegal acts of solicitation. Dr. Ran imposes
12 written policy guidelines to the therapists who contract with her, the contractual terms carry
13 punitive sanctions as an inducement for the therapists who perform massage there to conduct
14 themselves in a lawful and respectable manner. The ones who have even been charged,
15 regardless of the outcome of the cases, have had their contracts terminated, and their deposits
16 forfeited. Dr. Ran puts teeth into her contracts. If an individual wishes to willfully defy the
17 terms of the contract and face arrest, that is their decision, however this type of conduct cannot
18 be said to be something which Dr. Ran causes, allows or promotes. It is not tolerated, the
19 therapists' contracts are terminated, it cannot be maintained that Dr. Ran promotes, allows,
20 conduct that she specifically prohibits in the contracts. She clearly puts people on notice that she
21 will NOT tolerate such conduct. She does not pay for their attorneys, does not pay for the fines,
22 it has never been suggested that she is aiding this activity; termination the therapist's contract
23 and requiring them to forfeit their deposit is clearly not "aiding." She is not exercising willful
24 indifference, she is not allowing, and the termination of a contract and forfeiture of the person's
25 deposit does not promote, foster, aid, or enable.

1 The activities here, the isolated and quickly punished acts of soliciting, simply do not
2 constitute a nuisance. Only one person was allowed a second chance, and when that person was
3 re charged, that person was gone. The establishment is simply not a nuisance of any kind, instead
4 it is an establishment that has a few instances where therapists exceed the written terms of their
5 contract, and Dr. Ran institutes immediate remedial measures. She does not wait for the court
6 disposition, those persons are gone, and their deposits forfeited.
7

8 With respect to section "I," there is no proof that Dr. Ran has failed to cooperate with
9 anyone in authority. She is not protecting offenders, she is not harboring or concealing them,
10 rather, they are terminated, and for the most part, on the spot.

11 LVMC 6.02.350 is stated for reference:

12 | **6.02.350 - Disciplinary action—Acts of principals and subordinates.**

13 A licensee under this Title shall be subject to disciplinary action not only for acts or omissions done
14 by such licensee but also for acts and omissions done by the principals, managers, agents, representatives,
servants or employees of such licensee

15 Respondents do not suggest that the therapists involved have been perfect. However, from a
16 proportionality standpoint of discipline, similarly situated establishments are not subjected to the
17 discipline that is attempted to be imposed. There also exists a serious question of whether a
18 therapist, with their own license, would even be considered an employee of the licensee. An
19 independent massage therapist is defined as follows, per LVMC 6.52.020:

20 **"Independent massage therapist" means a massage therapist who is not an employee of a massage**
21 **establishment, is a sole practitioner, and hires no employees.**

22 LVMC 6.52.120 is now stated for reference:

23 | **6.52.120 - Prohibited activities.**

24 It is unlawful for a massage establishment licensee, or a principal or employee thereof, to do any of
25 the following:

1 (A) Within a massage establishment, engage in or solicit sexual activity during the course of
2 performing massage therapy on a person, with or without the consent of the person, including,
without limitation, if the licensee, principal or employee;

3 (1)Made sexual advances toward the person;

4 (2)Requested sexual favors from the person; or

5 (3)Massaged, touched or applied any instrument to the breasts of the person, unless the
person has signed a written consent form provided by the Nevada Board of Massage
Therapists;

6 (B) Within a massage establishment, allow a massage therapist to engage in or solicit sexual
7 activity in violation of Subsection (A) of this Section;

8 (C) Engage in false, deceptive or misleading advertising regarding the services available within a
9 massage establishment, including, without limitation, false, deceptive or misleading advertising
regarding the training that a massage establishment licensee, principal or employee has received.

10 The independent contractors that violated the contract were not allowed to continue to work
11 at the premises, and their deposits were forfeited. The remedial measures were taken. Dr. Ran
12 has not allowed a massage therapist to engage in or solicit sexual activity, rather, she terminated
13 their independent contractor's written agreement. Further, Dr. Ran has not engaged in false,
14 deceptive, or misleading advertising, her business is up front, and does not foster, promote,
15 allow, encourage, or participate in illegal activities.

16 LVMC 6.52.080 states:

17 **6.52.080 - Register of employees.**

18 The licensee or principal of a massage establishment shall maintain a register of all persons who at
19 any time are employed or contracted as massage therapists and their City and State license numbers. Such
20 register shall be made available upon request to representatives of the Department or Metro during regular
business hours.

21 The acupuncture assistants were not contracted nor employed as massage therapists. There
22 is no violation here.

23 The same holds true with LVMC 6.52.040:

24 **6.52.040 - License required.**

25 No person shall engage in, conduct or carry on, or permit to be engaged in, conducted or carried
on, in or upon any premises, the operation of a massage establishment, or the performance of massage
therapy as a massage therapist or a massage establishment licensee practitioner, without first obtaining and
thereafter maintaining a valid unexpired license for that activity pursuant to this Title.

1 The two assistants referenced in page 3 of the City's Complaint were authorized to assist Dr.
2 Ran with acupressure, there is no indication that these two assistants did anything but that. They
3 did not perform a massage for these detectives, and were never viewed performing a massage.
4 They are allowed to be there without license, as they were not massage therapists, and were fully
5 compliant with NRS 634A.200, sec. c.

6 The Respondents acknowledge the illegality of Solicitation, so these statutes need not be
7 repeated. Dr. Ran has never been accused of Solicitation, she operates an establishment where
8 there were some rogue therapists, whose independent contracts were terminated.
9

10
11 **RIGHT TO AMEND AND SUPPLEMENT**

12 Respondents respectfully reserve the right to supplement or amend their answers filed herein.
13

14 **CONCLUSIONS AND PRAYER**

15
16 It is respectfully submitted that, based upon these facts, any substantial discipline would
17 be disproportionate to the injuries caused to the public at large, or to the facts of this case. Dr.
18 Ran has never intentionally violated any code ordinances, her only blemish was the mal-advised
19 decision to accept a conviction for conduct that her assistants were legally authorized to do.

20 WHEREFORE, the Respondents pray that after the evidence is fully and fairly considered,
21 that

22 1. That no violations be found,
23

24 ///

25 ///

- 1 2. That in the alternative that the Council levy minor penalties, certainly not anything rising
2 to the level cancellation or the imposition of large fines.

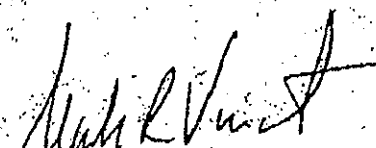

Agreement made this day May 18, 2008, between Ran Oriental Therapy's, LLC. (hereinafter referred to as Oriental Angels) and Xue Rong Fu (hereinafter referred to as Massage Therapist). It is mutually agreed between the two partners as follows.

1. Oriental Angels is located at 2600 W. Sahara, suite# 115, Las Vegas, NV .89102
2. Massage therapist must have City of Las Vegas massage therapist license and heath card, which the massage therapist will have with them all the time.
 - A.) Proof of massage therapist insurance.
 - B.) Massage therapist is required to stay current on all of these requirements by City of Las Vegas code and to work as an independent for Oriental Angels
3. No outcall massage
 - 4a.) Unethical or nude or sexual behavior will not be tolerated. Immediate termination and the massage therapist will be responsible for all fines and penalties by the metro police department, by involvement in the unethical behavior. Oriental Angels will not be responsible for any unethical behavior of any of the independent massage therapists that is working at Oriental Angels.
 - b.) Massage therapist can give out information and business cards for Oriental Angels only. There will be immediate termination of massage therapist if therapist is promoting individual business instead of promoting Oriental Angels. It is unethical to steal clients from Oriental Angels This includes using Oriental Angels business to make your own outcall appointments. Oriental Angels' massage

therapists do not do outcalls. Oriental Angels is not responsible for any person or massage therapist who misrepresents this company.

c.) Massage therapist is allowed to promote only Oriental Angels, and schedule clients for appointments.

d.) Any violation of item 3 or 4 above will result in the therapist being fired and forfeiting the entire deposit that was collected from her when she started working.

5. Massage Therapist is to have professional attire appropriate for massage therapist work. No halter top, short skirts or inappropriate attire is allowed.

6. No alcohol or drugs are allowed on property, nor used before or while at work for Oriental Angels.

7. Independent massage therapist must have respect for Oriental Angels place of business by keeping all rooms tidy and clean, including the bathrooms and showers and break room.

8. Massage therapist is an independent contractor. She is responsible for her own taxes and benefits. Pay scale is \$20 for a half hour massage and \$30 for one hour massage, plus massage therapist keeps tips.

9. No use of personal cellular phones during massage sessions. No use of Oriental Angels business phone for personal business.

10. It is the responsibility of each massage therapist to obtain their own health insurance if they desire. If the therapist injures themselves during their working, their own insurance will be used to pay for their medical bills. Oriental Angels

will not be responsible for the medical bills of the independent massage therapist that work here.

11. It is also the responsibility of each therapist to obtain their own disability insurance if they desire, in case they are unable to work due to injury. Oriental Angels is not responsible for disability insurance for its independent therapist.

12. Each massage therapist is responsibility to laundry the sheets and towels they use for their customers.

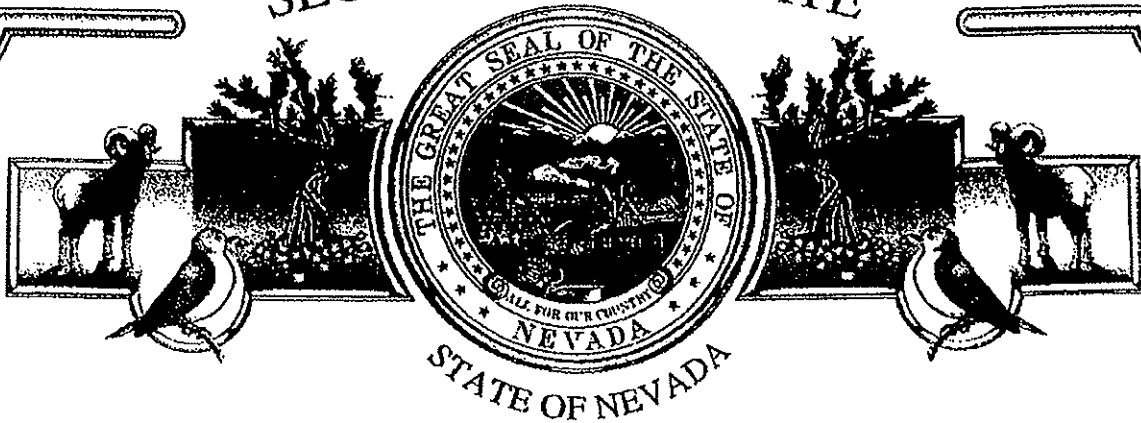

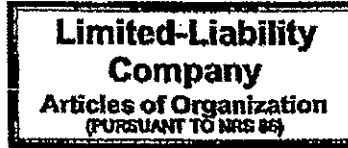

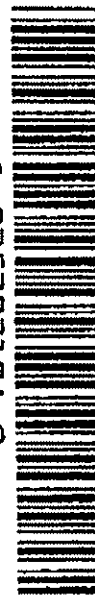

Li escorted me to Room #7 and told me to disrobe. She told me to lay face down on the table and pointed to the sheets. I asked Li if she wanted me to get under the sheets and Li said, "Yes". The table was set up with a sheet covering the table and a secondary sheet to climb into with a paper sheet on top of that. I disrobed as instructed and laid face down and climbed under the sheets and waited for Li to return. Li returned to the room and told me that I was suppose to lay on top of the paper sheet. I got out from under the sheets and climbed on top of the table face down. Li asked me if I was cold and did I want a sheet. I said, "I was fine".

Li started the massage, failing to cover my body and buttocks area, leaving me completely exposed. Li started to massage my back and upper arms area and eventually worked down to my buttocks and lower legs. While Li was massaging my buttocks, she asked me where I was from. I said, "You mean originally"? Li said, "Yes". I told Li I was from California and asked where she was from. Li told me she was from Korea. Approximately thirty minutes into the massage, Li asked me turn over on to my back and at no time did she attempt to cover my penis or genital area with a sheet or towel. She stood on the left side of me and asked if I wanted a whole body massage as she focused her eyes on my genital area. I told Li that I did and Li said, "How much you going to pay me"? I said, "Well, are you going to give me a hand job"? As I said this, I made a gesture with my right hand stimulating masturbation. Li said, "Yes, it would be \$100.00". I said, "How about \$80.00"? Zhao asked me if I wanted a half hour massage or an hour massage and I stated I wanted an hour massage. She then told me it would be \$70 at that time I gave her a \$100 bill and she brought me to the back to the right side of the hallway down to room number one. After entering room number one she stated take your clothes off and she'd be right back. I began taking my clothes off and Zhao came back to my room and gave me change that being \$30.

A short time later Zhao came in the room where I was laying face down on the massage table and she covered my backside with a sheet. At that time Zhao began massaging my back and shoulder area moving the sheet around to cover me. She massaged my back, my shoulders, and massaged under the sheet massaged my buttocks and thighs. After doing this for approximately a half hour to 40 minutes Zhao then had me roll over on to my back. When Zhao had be rollover the sheet was knocked to the side exposing my genital area to Zhao. While massaging my chest I engaged Zhao in conversation and asked Zhao if she lived here and she told me that did that she had moved here from New York. While massaging my chest Zhao stated she moved from China to New York to Vegas and was a 21 dealer here and had left and was doing massages now. Zhao asked me if I was a local or from out of town and I stated I was from out of town. She asked me where I was staying and I told her I was staying at the Mandalay Bay. Zhao asked if she could come see me and I told her that she could and asked if she gave massages besides at the business. Zhao stated that she did and we could do more. I asked her like what and she told me that we could have sex, referring to sexual intercourse. Zhao stated she'd do that for \$500. I then reconfirmed this and asked Zhao for \$500 I could have sex with you and she stated yes.

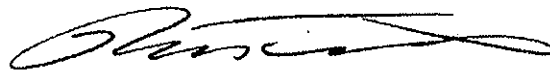

Oriental Angels Massage located at 2600 W. Sahara, Suite 115, Las Vegas, NV 89102

Dear Mr. DiFiore:

This investigation pertaining to Ms. Ran has determined significant evidence that Ms. Ran is allowing and promoting unlawful acts of prostitution within her massage establishments. Police reports and other supporting documentation show that nine (9) massage therapist have been arrested for **Soliciting for the Purpose of Prostitution**. On at least four (4) separate occasions, Ms. Ran has employed Massage Therapists without having a Massage Therapist License, as per Clark County Code and Las Vegas Municipal Code. Listed below is an outline of criminal activity that has occurred at ALL of Ms. Ran's Massage Establishments (City & County).

Shangi La Health Clinic

On April 12, 1999, City of Las Vegas Business License approved Jinli Ran for a Massage Establishment License at Shangri La Health Clinic, which is located at 430 E. Sahara, Las Vegas, NV 89104.

On November 14, 2006, Vice and SIS detectives conducted an undercover operation at Shangri La Health Clinic located at 430 E. Sahara, Las Vegas, NV 89104, investigating prostitution related crimes.

Upon walking up to the business, the detective noticed the door was locked, and a sign that stated, "Open 24 hours." The detective rang the doorbell and an Asian female, later identified as Di, Zhan opened the door and invited the detective inside the business. Once inside he asked Ms. Di for a one hour massage for seventy (\$70.00) dollars. Ms. Di escorted the detective to massage room #2. He was instructed to disrobe and lay face down on the massage table. Several minutes later, Ms. Di re-entered the room and began massaging the detectives neck and upper shoulders.



Approximately thirty minutes into the massage, Ms. Di rolled the detective onto his back, at this point he grabbed the towel and covered his genital and penis area. Ms. Di ripped the towel from his genital and penis area and stated that she would "suck" him, (referring to oral sex) for one hundred (\$100.00) dollars. Ms. Di was placed under arrest for **Soliciting Prostitution, Obscene Massage and Display of Massage License.**

During a site check of this business for compliance with regulation code, it was determined that Ping Jiang and An Li Sun did not have the required massage therapist license for employment to conduct massage on patrons at this establishment. Despite that fact it was confirmed that Ms. Jiang and Ms. Sun were in fact "working" this day per their own admission. This was also confirmed when the detectives found their names on the employee list. A records check of the City of Las Vegas Business Licensing data base also confirmed that neither subject had a valid Massage Therapist License. Both subjects were issued a citation for **No Business License-Massage.**

It should be noted that all three of these employees were dressed provocatively.

A Crime Scene Analysis (CSA) responded to the above business at the request of SIS detectives. The CSA used an alternate light source to locate and examine biological fluid stains that were located on all four (4) walls in each of the massage rooms. An acid phosphates presumptive test for semen was conducted on the walls. A sample swab was recovered from each of the massage room, all yielding positive results.

During the compliance check, it was learned that the owner Lin Ji Ran was out of the country and no key employee was available as per city code. City of Las Vegas Business License was notified and they responded to the establishment. The business was voluntarily closed, due to the fact that no licensed massage therapist or key employee were on the premises.

On December 12, 2006, SIS detectives met with Ms. Ran to discuss the above incident and to address some of the violation that were observed. Listed below are the violations:

- **License required (6.52.040):** No person shall engage in, conduct or carry on, or permit to be engaged in, conducted or carried on, in or upon any premises, the operation of a massage establishment or the performance or massage as a massage therapist or as an independent massage therapist, without first obtaining and there maintaining a valid unexpired license for the activity.
- **Obscene or opposite sex massage (6.52.120):** Perform massage unless the person performing the massage is wearing nontransparent outer garments that do not expose or exhibit that person's genitals, pubic area, buttocks or chest.

On October 3, 2007, LVMPD Vice detectives conducted an undercover operation at Shangi La Health Clinic located at 430 E. Sahara, Las Vegas, NV 89104, investigating prostitution related crimes. Upon entering the establishment, the Vice detective made contact with an Asian female later identified as Li, Miao. He requested a one hour massage for seventy dollars (\$70.00). Ms. Li escorted the detective to a massage room, asking him to disrobe and lay face down.

After performing a full body massage on the undercover detective, Ms. Li negotiated sexual acts in exchange for a fee. Ms. Li was subsequently arrested for **Soliciting Prostitution**.

On October 9, 2007, Ms. Ran appeared at the LVMPD SIS office per our request. During this meeting, Ms. Ran was provided with a warning letter notifying her that one of her employees solicited a police officer inside her business and that activity could subject her business license to suspension or revocation proceedings. Ms. Ran signed a form acknowledging that she received a copy of this letter.

After Ms. Ran expressed several concerns about her current and future employees. She was given several suggestions on how to obtain criminal history (via the internet, public access and having the employee provide a scope print out from various law enforcement agencies), and the importance of checking personal and/or employment references.

On February 13, 2009, LVMPD Vice detectives and SIS detectives conducted an undercover operation at Shangi La Health Clinic located at 430 E. Sahara, Las Vegas, NV 89104, investigating reported prostitution related activity under LVMPD Info-Com #0812-063V. During the undercover operation, the undercover detective approached the business and attempted to open the front door. Approximately one minute later, an Asian female later identified as Yang Qiao, opened the door. He requested an one hour massage for seventy dollars (\$70.00). After a brief conversation Ms. Qiao escorted the detective to a massage room, asking him to disrobe and lay face down on the massage table.

Several minutes later Ms. Qiao re-entered the room and began massaging the detectives back and shoulder area. Approximately 30 minutes into the massage Ms. Qiao had the detective turn over onto his back. Ms. Qiao began massaging the detectives chest and neck area. During the course of Ms. Qiao massaging the detectives chest, shoulders and neck area, she pulled the sheet back and pointed to the detectives penis and asked if he wanted her to touch it. After a brief conversation, Ms. Qiao agreed to perform a sexual act for sixty dollars (\$60.00). Ms. Qiao was placed under arrest for **Soliciting Prostitution**.

On February 26, 2009, Ms. Ran was to appear at the LVMPD SIS office to discuss the incident that occurred on February 13, 2009. Due to Ms. Ran's illness, she was unable to appear in person. However, the above incident was discussed and she was verbally put on notice that she is once again in violation of the Municipal Code that governs Massage Establishments. On June 16, 2009, Ms. Ran appeared at the LVMPD SIS office where she was given the written notification that one of her employees was arrested on February 13, 2009, for Soliciting Prostitution.

Oriental Angels Massage

On December 13, 2001, City of Las Vegas Business License approved Jinli Ran for a Massage Establishment License, at Oriental Angels, which is located at 2600 W. Sahara, Suite 115, Las Vegas, NV 89102.

On March 29, 2007, SIS detectives conducted a compliance check at Oriental Angels Massage. Upon entering the establishment detectives made contact with two Asian females later identified as Mai Tieu (aka Sammie) and Sun Wee (aka Michelle). Both subjects presented themselves as massage therapist both verbally and by uniform (medical scrubs). When asked for their City of Las Vegas Massage Therapist License, both stated that they have valid massage therapist licenses, but did not have them on their person. A records check through the City of Las Vegas Business License data base revealed that both subjects were in fact not licensed, as required by code. Both subjects later admitted to having a massage therapist license in the State of California, but not within the City of Las Vegas. Both were issued a citation for **No Massage License**.

Jim Rickett from City of Las Vegas Business License, Robbie Dahn a LVMPD Crime Scene Analysis (CSA) and Jim Shadrick from City of Las Vegas Code Enforcement responded to the above business at the request of SIS detectives.

The CSA used an alternate light source to locate and examine biological fluid stains that were located on all four (4) walls in each of the massage rooms. An acid phosphates presumptive test for semen was conducted on the walls. A sample swab was recovered from each of the massage rooms, all yielding positive results.

A short time later Ms. Ran responded to the establishment at the request of SIS detectives. Ms. Ran was asked in what capacity are the two above individual's employed. Ms. Ran stated that she hired Ms. Tieu in October of 2006 and Ms. Wee in January 2007, as Massage Therapists. The employee list that Ms. Ran provided SIS detectives was dated March 30, 2005 and failed to list the above individuals as Massage Therapist. (The original employee list was impounded under event number 070329-1253). Ms. Ran was issued two citations: **Register of Employees and License Required** (allowing the above individuals to work as Massage Therapist without having the required license).

Once again Ms. Ran was advised that she was in violation of the Municipal Code: Listed below are the violations that were discussed at length:

- **License required (6.52.040):** No person shall engage in, conduct or carry on, or permit to be engaged in, conducted or carried on, in or upon any premises, the operation of a massage establishment or the performance or massage as a massage therapist or as an independent massage therapist, without first obtaining and there maintaining a valid unexpired license for the activity.
- **Register of employees (6.52.080):** The or person designated by the licensee of a massage establishment shall maintain a register of all persons who at any time are employed or contracted as massage therapist and their business license numbers. Such register shall be made available upon request to representatives of City Business License and LVMPD during regular business hours.

Ms. Ran stated that she has an acupuncture license (which she showed me hanging on the wall) and claims that she is exempted from LVMC 6.52.030 (a) *The following persons while engaged in their respective professions or occupations for which they are licensed to practice or perform in Nevada, if they do not hold themselves out to the public as massage therapist and their performance of massage is only in connection with their profession or occupation. (1) Physicians, doctors of oriental medicine, surgeons, chiropractors, osteopaths or physical therapist and persons directly under their control and supervision.* Mr. Rickett (CLVBL) explained to Ms. Ran that she is not exempt from the above municipal code, because she markets and advertises as a massage establishment (per the outdoor signage and yellow page listing) and that her employees (massage therapist), perform massage on individuals who walk-in and there is no connection to Ms. Ran's acupuncture practice.

City of Las Vegas Code Enforcement issued Ms. Ran a notice of violation and a citation for several building violations.

On January 8, 2008, Vice detectives conducted an undercover operation at Oriental Angels Massage, located at 2600 W. Sahara, Suite #115, Las Vegas, NV 89102, investigating prostitution related offenses. Upon entering the establishment the undercover detective made contact with an Asian female later identified as Wenjuan Li. He requested a one hour massage for Seventy Dollars (\$70.00). Ms. Li escorted the detective to a massage room, instructing him to disrobe and lay face down on the massage table. Several minutes later Ms. Li re-entered the room and began massaging the detectives back and shoulder area for approximately 30 minutes.

Nearing the end of the massage, Ms. Li instructed the detective to turn over onto his back. Ms. Li began massaging his chest and neck area. After a brief conversation Ms. Li agreed to preform a "Hand Job" (manual masturbation) for Eighty Dollars (\$80.00). Ms. Li was subsequently arrested for **Soliciting Prostitution**.

On February 5, 2008, a SIS detective conducted a telephonic meeting with Ms. Ran. During this meeting, Ms. Ran was advised that on January 8, 2008, one of her employees solicited a police officer inside Oriental Angels. Ms. Ran was verbally put on notice that she was once again in violation of the Municipal Code that governs Massage Establishments.

On December 24, 2008, Vice detectives conducted an undercover operation at Oriental Angels Massage, reference vice related offenses. Upon entering the establishment the undercover detective made contact with an Asian female later identified as Mei Zhao. He requested a one hour massage for seventy dollars (\$70.00). Ms. Zhao escorted the detective to a massage room, instructing him to disrobe and lay face down on the massage table. Several minutes later Ms. Zhao re-entered the massage room and began massaging the detectives neck and shoulders.

Approximately 30 minutes into the massage, Ms. Zhao had the detective turn over onto his back, and began massaging his chest, shoulders, head and his neck. Ms. Zhao continued to massage down the detectives thighs, at which time she took the detectives legs and made into a figure four exposing his genital area.

After doing that Ms. Zhao reached down and touched the detectives groin area through the sheet and asked if he wanted that massaged. Ms. Zhao agreed to preform a "Hand Job" (manual masturbation) for Two Hundred Dollars (\$200.00), including removing all her clothes. Moreover, Ms. Zhao agreed to do outcall massage at a hotel room, including sexual intercourse for additional Five Hundred Dollars (\$500.00). Ms. Zhao was arrested for **Soliciting Prostitution** and **Obscene Massage**.

On February 26, 2009, Ms. Ran was to appear at the LVMPD SIS office to discuss the incident that occurred on December 24, 2008. Due to Ms. Ran's illness, she was unable to appear in person. However, the above incident was discussed and she was verbally put on notice that she is once again in violation of the Municipal Code that governs Massage Establishments. On June 16, 2009, Ms. Ran appeared at the LVMPD SIS office where she was given the written notification that one of her employees was arrested on December 24, 2008, for Soliciting Prostitution.

Asian Garden

On December 27, 2006, Clark County Business License approved Jinli Ran for a Massage Establishment License, at Asian Garden, which is located at 4650 W. Tropicana Ave, Suite #118, Las Vegas, NV 89103.

On January 16, 2007, SIS and Vice Detectives conducted an undercover operation at Asian Garden, located at 4650 W. Tropicana Ave, Suite #118, investigating prostitution related offenses. Upon entering the establishment the undercover detective made contact with an Asian female. He requested a one hour massage for seventy dollars (\$70.00). The Asian female escorted the detective to a massage room instructing him to disrobe and lay face down the massage table. The Asian female began to massage the detectives back and shoulder area for approximately 30 minutes.

Nearing the end of the massage, the Asian female instructed him to turn over onto his back. The Asian female began massaging his chest and neck area. After a brief conversation, she agreed to preform a "Hand Job" (manual masturbation) for one hundred dollars and a "Blow Job" for Two Hundred Dollars (\$200.00). The Asian female was placed under arrest for **Soliciting for the Purpose of Prostitution, Prohibit Acts-Unlawful Touching and Operating Requirements**. This case has been sealed.

On June 17, 2007, Vice detectives conducted an undercover operation at Asian Garden, investigating prostitution related offenses. During the operation one of the employees was arrested for Soliciting Prostitution. This case has since been sealed.

On January 18, 2007, Ms. Ran appeared at the LVMPD SIS office per our request. During the meeting, Ms. Ran was provided with a warning letter notifying her that one of her employees solicited a police officer inside Asian Garden and that activity could subject her business license to suspension or revocation proceedings. Ms. Ran signed a form acknowledging that she received a copy of the letter. Ms. Ran was also issued a citation for **No Manger in Charge**.

On March 24, 2009, Vice detectives conducted an undercover operation at Asian Garden, investigating vice related offenses. Upon entering the establishment the undercover detective made contact with an Asian female later identified as Connie Gong. He requested a half hour massage for Fifty Dollars (\$50.00). Ms. Gong escorted the detective to a massage room instructing him to disrobe and lay face down on the massage table. Several minutes later Ms. Gong began to massage the detectives back and shoulders area for approximately 15 minutes.

Nearing the end of the massage, Ms. Gong instructed the detective to turn over onto his back. Ms. Wang began massaging the detectives chest and neck area. After a brief conversation, Ms. Gong agreed to preform a "Hand Job" (manual masturbation) for Fifty Dollars (\$50.00). Ms. Gong was subsequently arrested for **Soliciting Prostitution**.

On June 16, 2009, Ms. Ran was issued written notification that one of her employees solicited a police officer inside Asian Garden. Ms. Ran signed a form acknowledging that she received a copy of the letter.

Desert Paradise Spa

On February 14, 2007, Clark County Business License approved Jinli Ran for a Massage Establishment License, at Desert Paradise Spa, which is located at 900 E. Desert Inn, Suite #101, Las Vegas, NV 89109.

On February 21, 2009, Vice detectives conducted an undercover operation at Desert Paradise Spa, which is located at 900 E. Desert Inn, Suite # 101, investigating vice related offenses. Upon entering the establishment the undercover Vice detective made contact with an Asian female later identified as Bin An. He requested a massage for Fifty Dollars (\$50.00). Ms. An escorted the detective to one of the massage rooms instructing him to disrobe and lay face down on the massage table. Ms. An re-entered the room and began massaging the detectives back, shoulders and buttocks.

Approximately ten minutes later, Ms. An had the detective turn over onto his back. While Ms. An was massaging the detectives chest she pointed to his groin area and did an upward hand stoke gesture (simulating manual masturbation). After a brief conversation, Ms. An agreed to preform a sexual act for a fee of Sixty Dollars (\$60.00). Ms. An was arrested for **Soliciting Prostitution**.

On June 16, 2009, Ms. Ran was issued written notification that one of her employees solicited a police officer inside Desert Paradise. Ms. Ran signed a form acknowledging that she received a copy of the letter.

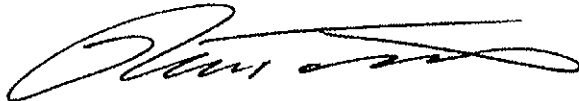
CONCLUSION:

Throughout this report there are examples of Ms. Ran's dereliction of her responsibility to operate her massage establishments lawfully. Significant similarities are present, at all of Ms. Ran's Massage Establishments, to include; Soliciting Prostitution, Aiding and Abetting Prostitution, No Massage License, Obscene Massage, No Health Cards and employees dressing provocatively.

Given the known occurrence of prostitution taking place at all Ms. Ran's Massage Establishments, LVMPD requested that on two separate occasions (Shangi La Health Clinic and Oriental Angels) that a Crime Scene Analysts perform presumptive tests to include acid phosphate test for bodily fluids associated with sexual activity. Those presumptive test proved positive for the fluids in question on the massage beds, walls, and floors in the massage rooms. This confirmation supported the prostitution activity which Vice and SIS detectives had previously established, was in fact occurring at ALL of Ms. Ran's Massage Establishments.

Ms. Ran has intentionally circumvented the specific regulatory ordinances and codes that govern massage establishments. The aforementioned violations all occurred during a period when the applicant knew that she was being monitored for compliance by LVMPD and the regulatory authority that has granted her these "**regulated**" licenses. These activities taking place at all of Ms. Ran's businesses are unlawful and constitute a public nuisance.

I entered the business and was greeted by an Asian female who would later be identified as Mei Wan Kong, ID number 1778182. Kong was escorting another customer to the door as she let me. After the other customer left she asked if I wanted an hour or half hour massage, then collected the money for the massage and escorted me to a room where she instructed me to disrobe and lay face down on the massage table.

Kong then brought me my change for having paid for the massage and told me that she would be my massage therapist. Kong began to massage my back and shoulders during which time we had an ongoing conversation, all in English, which Kong was easily able to understand and communicate back and be easily understood. Kong asked me some questions about what I did for a living and where I worked. As well as where I lived and if I had any family in town. Kong also made small talk elements she had on being on her feet and doing massage business all day.

Near the end of the massage Kong had instructed me to lie on my back while having a towel draped across my hips and genitals area. Kong briefly massaged my face and neck and front of my legs. Near the end of the massage Kong asked do you want me to finish you? She then put her hand over my genitals which were still covered by the towel, squeezed gently, and emphasized again do you want me to finish you. I told Kong yes, but asked her how much it would cost. In very clear English Kong told me it would be 50. I clarified \$50 and Kong said yes. I then said for big finish. I then shook my hand back and forth in front of my genital simulating masturbation so that Kong would understand exactly what I meant. Kong shook her head vigorously and smiled at me. I then told Kong be careful when I cum I cum very far and I used hand gestures to simulate ejaculation. Kong then gave me a

look and then told me you must be a strong man and then went and fetched a small plastic bowl which was empty and place it between my knees, as though she were going to use it to put over me and cover my penis before I ejaculated.

Kong asked me if I was ready and instructed me to lie back. I then told Kong that she had been rubbing feet and that oil (inaudible) from feet on her hands and asked her if she would wash her hands. It was a stalling tactic used because I had already given the prearranged signal to covering Officers that I had probable cause for an arrest and needed assistance effecting the arrest. There was a short delay in covering Officers arriving.

Kong went and washed her hands and returned and asked me if I wanted lotion or oil when she used her hand on me, meaning when she was going to masturbate me. I told Kong that I was allergic to the oil and she told me that the lotion gets sticky. I then asked her if she had any sexual lubricant and Kong told me no but that she could just use her hand on me. She said, "I'll use my hand and we'll see how that goes." Kong then attempted to pull the thin sheet off my genitals which I held on to to keep her from completely disrobing me. Kong then reached her hand under the towel and placed her hand on my genitals before I could stop her. I then turned my hips so that her hand was no longer on me and told her that I still thought she had too much oil on her hands and asked if she could wash her hands again.

Kong then became apprehensive and told me maybe next time and began to walk away from the room as Officers arrived and were ringing the doorbell several times. Officers then entered and announced that they were the Police and began getting all of the customers and employees into the front room of the Oriental Angels business. After re-dressing I joined

in the foray of the business and identified Kong, who was wearing capri jeans and a black shirt and was easily recognizable from the other two employees. I then advised Kong that she was under arrest for SOLICITING FOR THE PURPOSE OF PROSTITUTION and began arrest paperwork.

While conducting a criminal records check of Kong found that she had a prior arrest for SOLICITING PROSTITUTION. Upon questioning Kong about this she told me it was while conducting massage business in Pahrump. Kong was then transported to City Jail and booked for the charge of SOLICITING PROSTITUTION under city code 10.36.020.

- (7) When substantial information exists which tends to show that the principal is dishonest or corrupt;

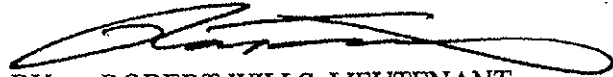

This correspondence is to inform you of a code violation and criminal activity which occurred at Oriental Angles located at 2600 W. Sahara, Suite #115, Las Vegas, NV 89102.

On July 22, 2009, at approximately 0030 hours, LVMPD Vice detectives conducted an undercover operation at Oriental Angles, investigating vice related activity. Upon entering, the Vice detective made contact with an Asian female later identified as Mei Wan Kong and requested a massage. After Ms. Kong collected the money, she escorted the detective to a massage room, asking him to disrobe and lay face down on the massage table.

Several minutes later Ms. Kong entered the room and began massaging the detectives back and shoulder area. Approximately 15 minutes later Ms. Kong had the detective turn over onto his back. Ms. Kong began massaging the detectives face, neck and front of his legs. Near the end of the massage Ms. Kong asked the detective "Do you want me to finish you?" Ms. Kong put her hands over the detectives genitals and emphasized again do you want me to finish you. After a brief conversation, Ms. Kong agreed to preform a "Hand Job" (manual masturbation) for a fee of Fifty dollars (\$50.00). Ms. Kong was subsequently arrested for **Soliciting Prostitution**. This case is scheduled for Pre-Trial on December 10, 2009.

On July 22, 2009, Ms. Ran (owner of Oriental Angles) appeared at the LVMPD SIS office per our request. During this meeting, Ms. Ran was provided with a warning letter notifying her that one of her employees solicited a police officer inside her business and that activity could subject her business license to suspension or revocation proceedings. Ms. Ran signed the form acknowledging that she received a copy of this letter.

CIRCUMSTANCES OF ARREST

On 10/21/2009 at approximately 0945 hours, I, Det. [redacted] had an occasion to be working as an [redacted] operative in reference to vice related offenses which maybe occurring at massage businesses who provide illegal activity, more specifically prostitution.

I went to a business called "Oriental Angels" located at 2600 W. Sahara suite #115, Las Vegas, Clark County NV 89102. As I entered the business, I met a female who was later positively identified as XUE RONG FU (ID# 2609512). When I met the female, I grabbed one of the business cards. The business card read: "ORIENTAL ANGEL, ALL TYPES OF MESSAGES, TABLE SHOWER, OPEN 7 DAYS, WALK-INS WELCOME, 702-362-8999 2600 W. SAHARA, SUITE #115 ACROSS FROM PALACE STATION".

While I was inside the business, the Asian female FU asked me which one I wanted while she pointed to a wall with times and fees listed. I saw the 1/2 hour that was \$50 and the hour that was \$70. I asked FU if I could get the hour for \$50 and she told me "No" that the fee was for the business and that she worked off tips. I then produced \$80 of marked LVMPD money and handed it to FU. FU took the money and told me that she would bring me my change later. FU directed me to the back rooms where she opened massage room #3 for me and entered in with me.

While inside the room, I immediately noticed there was a massage table in the room with two sheets on it and a place to put your face in a circular hole for you to breathe while laying face down. I also saw a small collapsible stool beside a coat rack. FU told me to take everything off and lay face down on the table. FU left the room to go get my change and I did what she requested. I took everything off except for my boxer briefs and laid on the massage table as directed face down. FU re-entered the room and placed \$10 on the stool.

FU saw that I had my boxer briefs on and told me to take them off as well. She told me to get off the table and I did as directed and asked her if I could get a towel. FU fixed the sheets that I folded over and made the massage table up again and then told me to get on top of the table and the sheets. I was nude face down on the massage table. FU then left for a moment, returned with a towel and concealed my backside for a brief moment. I saw FU bend over and squirt some massage oil in her hand and walked to the front of the table and began to massage my whole body.

I noticed that when FU got close to my backside, she went past the waistband and pulled the towel down exposing my backside as she continued to lean all the way over me from the front and extend herself and her reach past the bottom of my buttocks. FU continued her massage in that manner and I was then immediately asked a series of questions from FU, ie; where was I from, what was I doing here in town, how long would I be in town if I gambled and if this was the first time I've been to a massage business or ever had a massage. I told FU a series of answers and that I also have had massage before and that it wasn't my first time and that I had been here before.

I told FU that I had been winning at gambling and that I was trying to get a massage at the hotel, but girls don't go to the hotel anymore. FU said that I was right that girls don't go to the hotel anymore that it was too much trouble. FU would not comment on what type of trouble. As we continued with our conversation and massage, I asked FU if I could get the Korean style massage and she said she was Chinese, laughed and said, "You will not get the Korean, you will get the Chinese massage" and she said, "I'm really good, you'll be very happy, just me." I asked FU how much this trust was going to cost me and she said that I would have to tip her. I told FU that I already spent \$70 on the massage and asked her if \$30 be enough for her tip. FU told me that I was cheap and that her tips start at \$60. I told FU that I wasn't cheap and asked her how much more was she looking at. FU said that she usually gets \$100 and I told FU for a \$100 I was going to want more than just a "hand job". I told her that I was going to want a "blow job". Once I said that comment, FU did not tell me not to speak like that, but shhhh'd me as she put her index finger up to her mouth making the shhhhh noise as well as putting it up to my mouth making the shhhhh noise.

I told FU that I didn't understand what she was doing and she told me that we couldn't talk like that and I said, "Okay." I told FU that I wasn't going to give her the \$100, but if all she did was "hand jobs" I would give her the \$60. FU again put her fingers up to her face and shhhh'd me, but said, "Okay \$60." FU continued to perform her massage for approximately 10 to 15 more minutes and continued with conversation.

Moments later, once FU had finished with my legs and feet, FU told me to turn over which I did. When I turned over, I kept the towel on me to conceal my genital. FU then pulled the towel off me where I was unable to conceal myself with anything other than my hands. I acted as though, I was going to masturbate myself as I concealed and cupped myself with one hand and used my left hand in an up and down movement. At that same time, gave an arrest signal as FU was attempting to grab my genital. I told FU that I needed a condom and FU told me, "No condom." I told FU that I might get myself all over her chest as I simulated ejaculation all over her shirt.

FU reached over to a shelf where there was a box of Kleenex and provided me with tissues. I asked FU if I should use the tissues instead of the condom and FU shook her head up and down in affirmative as to say, "Yes." I continued to make a movement, now that my hands were covered by the tissue and FU asked me if I was okay as she was now leaning in again in attempt to grab my genital. I was still trying to stall the aggressive female from grabbing my genital so that she could masturbate me, engaging now in an act of prostitution.

The front door of the business had been jilted and a door ring at the door and FU said that she needed to be excused for a minute. I told her that would be fine and that I would still work on myself and wait for her before I "cum". FU shook her head up and down in affirmative as to acknowledge what I was doing for her for the fee of \$60 that she quoted and that she would return briefly.

FU walked out of room #3 to the front lobby area, it was then I could hear other detectives identifying themselves as vice detectives with LVMPD and I was allowed to wipe off the oil she had provided for the massage and get dress.

When I walked out into the lobby area, FU said that she didn't want to go to jail and that I was a nasty man. I asked FU to explain why she would not leave the room or why she would continue to reach for my genital or why she exposed me once I was on my back and she was finished with her massage. FU could not provide any explanation of her actions to masturbate me with her hands and provide me with tissue to catch my ejaculation once I was sexually gratified for the \$60 fee.

FU was consequently transported to Las Vegas City Jail where she was booked accordingly.

- (5) The principal has been subject, in any jurisdiction, to disciplinary action of any kind against a license, permit, approval for suitability or work card to the extent that such disciplinary action reflects on the qualification, acceptability or fitness to be approved for suitability;
- (6) The principal has committed acts which would constitute a crime involving moral turpitude or involving any Federal, State or local law or regulation relating to the same or a similar business;
- (7) When substantial information exists which tends to show that the principal is dishonest or corrupt;

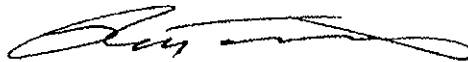

Dear Mr. DiFiore:

This correspondence is to inform you of a code violation and criminal activity which occurred at Shangri La Health Clinic, located at 430 E. Sahara, Las Vegas, Nevada, 89104.

On December 17, 2009, at approximately 0820 hours, LVMPD Vice detectives conducted an undercover operation at Shangri La Health Clinic, investigating vice related activity. Upon entering the business, the Vice detective made contact with an Asian female later identified as Fengying Ma and requested a one hour massage. After Ms. Ma collected the money, she escorted the detective to a massage room, asking him to disrobe and hang his clothes on the door and she would return shortly. After disrobing, the Vice detective laid face down on the massage table and covered his buttocks with a white bath towel.

Several minutes later, Ms. Ma entered the room and began massaging the detectives upper back and neck area. After completing the massage on the detectives back, Ms. Ma moved the towel covering his buttocks up to his high back area, thus exposing his buttocks. She then began to massage his buttocks and lower legs. Ms. Ma briefly left the room and returned with a hot wash rag and began to wipe down his back, buttocks, and legs, exposing his buttocks again. When she was finished, Ms. Ma had the detective turn over onto his back and she made no attempt to cover his exposed genitals with the towel. The detective had to cover his exposed penis and genitals himself.

Ms. Ma began massaging the detectives head, neck and chest. She then began to massage the inside of his legs and moved the towel up to his stomach, exposing his penis and genitals. As she was massaging the inside of his legs she briefly brushed his genitals. She then moved to his lower legs and when she was done massaging his legs, she asked if he needed attention to any other body part and focused her eyes on his groin area. The detective asked if it had already been an hour (referring to the hour massage he paid for), and Ms. Ma stated, "no, you have ten minutes left, but I leave that time in case there's any other body part that needs attention." As she said this, she reached her right hand and quickly grabbed the detectives penis and genitals which were covered with a towel. After a brief conversation, Ms. Ma agreed to perform a "Hand Job" (manual masturbation) for a fee of Fifty dollars (\$50.00). Ms. Ma was subsequently arrested for **Soliciting Prostitution**. Ms. Ma plead Not Guilty to this charge on January 28, 2010. This case is scheduled for Pre-Trial on April 26, 2010.



Additionally, the Employee List was not current and up to date as the only name on the list was Jinli Ran (the owner of Shangri La Health Clinic). Ms. Ma was working in the capacity of a massage therapist and was not listed on the Employee List as required per City Code. Ms. Ran responded to the business and acknowledged the Employee List was not up to date and stated she did not know why Ms. Ma's name was not on the list.

On December 22, 2009, Ms. Ran appeared at the LVMPD Special Investigations Section office per our request. During this meeting, Ms. Ran was provided with a warning letter notifying her that one of her employees solicited a police officer inside her business and that activity could subject her business license to suspension or revocation proceedings. Ms. Ran signed the form acknowledging that she received a copy of this letter. Additionally, she was issued a citation for **No Employee List** as the Employee List recovered at the business was not current and up to date. This case is scheduled for arraignment on February 9, 2010.

Ms. Ran is the owner of four massage establishments, two of the businesses are in the City of Las Vegas (Oriental Angels and Shangri La Health Clinic), and two are in the County of Clark (Asian Garden and Desert Paradise Spa). There have been a total of 14 arrests out of all her establishments and Ms. Ran has been issued 11 letters by Special Investigations Detectives notifying her of the various violations and arrests out of her massage establishments. They are listed and detailed below:

- Oriental Angels, 2600 W. Sahara, Suite 115, LV, NV, 89102: 5 Soliciting Prostitution arrests (1 arrest in 2007, 2 arrests in 2008, 2 arrests in 2009), 4 notice of violation letters issued to Ms. Ran.
- Shangri La Health Clinic, 430 E. Sahara Avenue, LV, NV, 89104: 4 Soliciting Prostitution arrests (1 arrest in 2006, 1 arrest in 2007, 2 arrests in 2009), 2 notice of violation letters issued to Ms. Ran.
- Asian Garden, 4650 W. Tropicana, Suite 118, LV, NV, 89103: 4 Soliciting Prostitution arrests (2 arrests in 2007, 1 arrest in 2009, 1 arrest in 2010), 3 notice of violation letters issued to Ms. Ran.
- Desert Paradise Spa, 900 E. Desert Inn, Suite 101, LV, NV, 89109: 1 Soliciting Prostitution arrest (2009), 1 notice of violation letter issued to Ms. Ran.

According to Las Vegas Municipal Code:

1. 6.52.120 - Prohibited activities.

It is unlawful for a massage establishment licensee, or a principal or employee thereof, to do any of the following:

(A) Within a massage establishment, engage in or solicit sexual activity during the course of

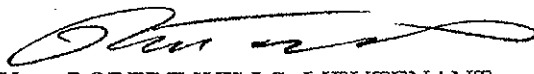
performing massage therapy on a person, with or without the consent of the person, including, without limitation, if the licensee, principal or employee:

- (1) Made sexual advances toward the person;*
 - (2) Requested sexual favors from the person; or*
 - (3) Massaged, touched or applied any instrument to the breasts of the person, unless the person has signed a written consent form provided by the Nevada Board of Massage Therapists;*
- (B) Within a massage establishment, allow a massage therapist to engage in or solicit sexual activity in violation of Subsection (A) of this Section;*
- (C) Engage in false, deceptive or misleading advertising regarding the services available within a massage establishment, including, without limitation, false, deceptive or misleading advertising regarding the training that a massage establishment licensee, principal or employee has received.*

(Ord. 5998 § 107, 2008; Ord. 5491 § 10, 2002; Ord. 5168 § 6, 1999; Ord. 4024 § 14, 1996)

Despite the repeated arrests out of Ms. Ran's establishments and the numerous notice of violation letters she has been issued over a 5 year time frame, the prostitution issues have continued at her businesses. She has taken no corrective action and has allowed these issues to take place which is in clear violation of City Code. This calls into question her suitability as the owner of these problem businesses.

I stated that I just wanted a half hour massage. She then charged me \$50.00, which I gave her a \$100.00. She then walked me back to a room and told me to take off my clothes and lay on the table. At that time, she stated that she would bring my change back.

I then proceeded to lay on the table and a few moments later, that unknown female Asian returned and put two twenties and a ten dollar bill on a chair approximately one foot off from the table I was laying on. A few minutes later, another Asian female came in the room, later identified as Xue Fu (ID# 2609512). Fu then conducted a massage on me. Approximately twenty minutes later, at the end of the massage, Fu then asked if everything was okay. I stated to Fu yes. Fu then grabbed my left hand and held onto it with her hand and started to circle around my stomach area by my belly button. At that time, Fu asked if I wanted anything else. I stated a "blow job" (fellatio). Fu stated no "blow job". I asked about a "hand job" (manual masturbation) then. Fu stated yes. I asked Fu how much was that going to cost. Fu turned and motioned with her head toward the chair where my two twenties and ten from my change from my \$100.00 were. I stated the \$50.00 change. Fu stated yes. I then agreed to \$50.00 for a "hand job", at which time, I stated that I would give her extra money if she would take off her clothes. Fu stated no she doesn't do that. I asked Fu if all I was going to get was a "hand job". Fu stated yes.

At which time, assisting LVMPD Vice detectives came in and took Fu into custody. Fu was then placed under arrest for Soliciting Prostitution due to the fact that she willfully and unlawfully agreed to give me manual masturbation for a fee of \$50.00. It should be noted that Fu and I carried on a conversation the whole entire time I was in the room and she even asked me if I was a police officer while she was massaging me. Fu was transported to the Las Vegas City Jail, where she was booked accordingly.
