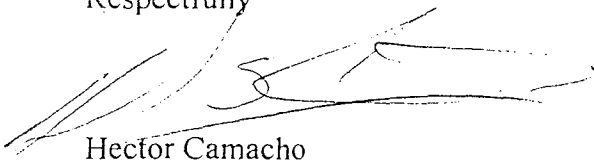

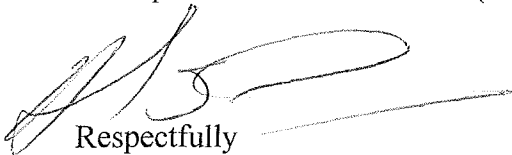

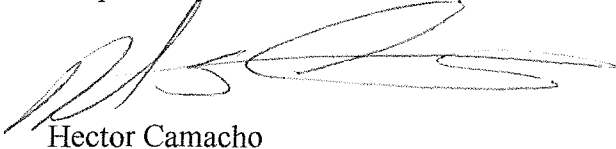

I am hereby requesting that PAULA AXELROD be no longer allowed on the property that is described above. Miss AXELROD has been harassing my people every other day for the last two months.

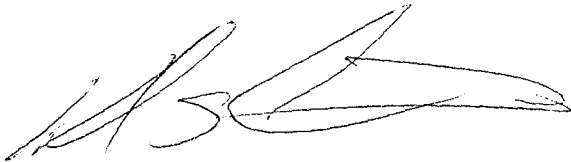
She has told individuals on the property and I quote:

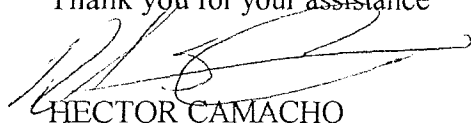
