PURPOSE/BACKGROUND:

On July 23, 2007 Contract No. 070410-DK (purchase order 248409) was awarded by the Purchasing Manager for soil transportation and stockpile management services in support of activities in Symphony Park in the amount of \$351,250. Funding was augmented by Council by \$400,000 on February 16, 2008 and \$400,000 October 7, 2009. This modification will restate the contract for clarity, restructure certain cost elements for savings and add funding to support continuing development at Symphony Park.
