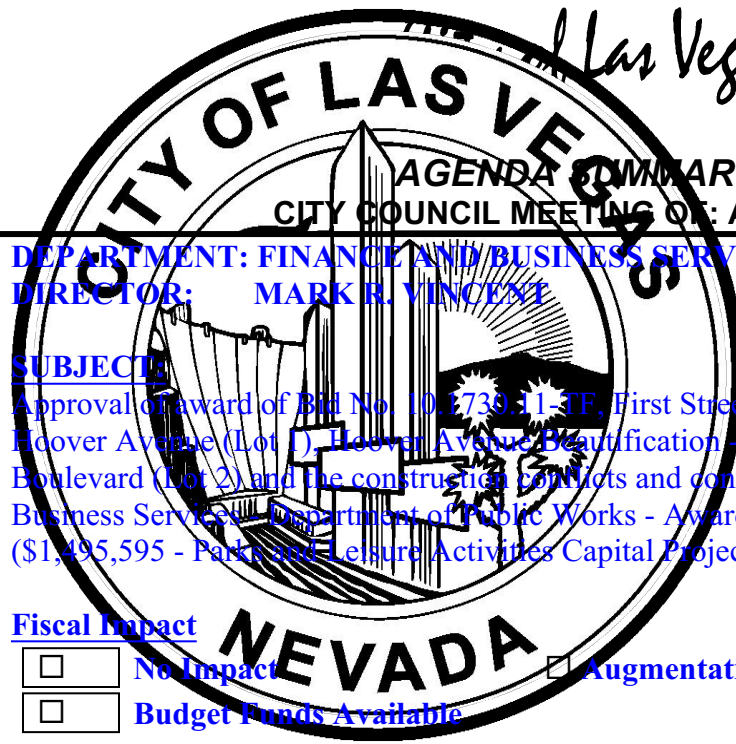

PURPOSE/BACKGROUND:

This project consists of the construction of streetscape improvements on First Street and Hoover Avenue to include pavers, sidewalk ramps, street lighting, utility adjustment, waterline relocation, landscaping and irrigation. Sixty percent of the funding for this project is being provided by funds from the Southern Nevada Public Land Management Act (SNPLMA) and the remainder is provided by 1% room tax.
