

SUPPLEMENTAL INTERLOCAL CONTRACT NO. 3

TENAYA WAY OVERPASS, WESTCLIFF DRIVE TO WASHINGTON AVENUE

THIS SUPPLEMENTAL INTERLOCAL CONTRACT NO. 3, made and entered into this 10th day of June, 2010 by and between the CITY OF LAS VEGAS, a municipal corporation, hereinafter referred to as the "CITY" and the Regional Transportation Commission of Southern Nevada hereinafter referred to as "RTC".

WITNESSETH

WHEREAS, pursuant to Chapter 373 of the Nevada Revised Statutes, a Project to design, purchase right-of-way, perform construction inspection and construct roadway improvements for Tenaya Way Overpass, Westcliff Drive to Washington Avenue located wholly within the CITY, has been approved by the Regional Transportation Commission.

WHEREAS, the parties have executed an Interlocal Contract dated June 13, 2002 and supplemental interlocal contracts dated May 18, 2006 and October 9, 2008 for the design and construction of Tenaya Way Overpass, Westcliff Drive to Washington Avenue;

WHEREAS, the CITY desires to extend the date of completion.

NOW, THEREFORE, in consideration of the covenants, conditions, agreements, and promises of the parties hereto, the RTC authorizes the CITY to proceed with the PROJECT as it is mutually understood and agrees as follows.

SECTION III – GENERAL paragraph 7 shall be revised to read as follows:

7. The project must be completed to the satisfaction of the RTC prior to September 30, 2011. The RTC may at any time thereafter grant time extensions or terminate this Contract and require all sums advanced to the CITY be reimbursed.

The remainder of the Interlocal Contract dated June 13, 2002, and supplemental interlocal contracts dated May 18, 2006 and October 9, 2008 shall remain unchanged.
