

**SUPPLEMENT INTERLOCAL CONTRACT NO. 3
I-15/OWENS AVENUE INTERCHANGE STUDY**

THIS SUPPLEMENTAL INTERLOCAL CONTRACT NO. 3, made and entered into this 10th day of June 2010 by and between the CITY OF LAS VEGAS, a municipal corporation, hereinafter referred to as the "CITY" and the Regional Transportation Commission of Southern Nevada hereinafter referred to as "RTC".

WITNESSETH

WHEREAS, RTC approved an Interlocal Contract on March 13, 2008 and supplemental interlocal contracts on June 11, 2009 and August 13, 2009 for a project a Project to perform a planning study for a future interchange on the I-15 at Owens Avenue and for eliminating the current Owens Avenue One-way couplet, which is located wholly within the CITY,

WHEREAS, the RTC previously granted "Authorization to Proceed" for engineering and,

WHEREAS, the CITY desires to extend the project completion date.

NOW, THEREFORE, in consideration of the covenants, conditions, agreements, and promises of the parties hereto, it is mutually agreed to supplement the Interlocal Contract for the Project as follows:

SECTION III – GENERAL paragraph 7 shall be revised to read as follows:

7. The project must be completed to the satisfaction of the RTC prior to June 30, 2012.

RTC may at any time thereafter grant time extensions or terminate this Contract and require all sums advanced to the CITY be reimbursed.

The remainder of the Interlocal Contract dated March 13, 2008 and supplemental interlocal contracts dated June 11, 2009 and August 13, 2009 shall remain unchanged.
