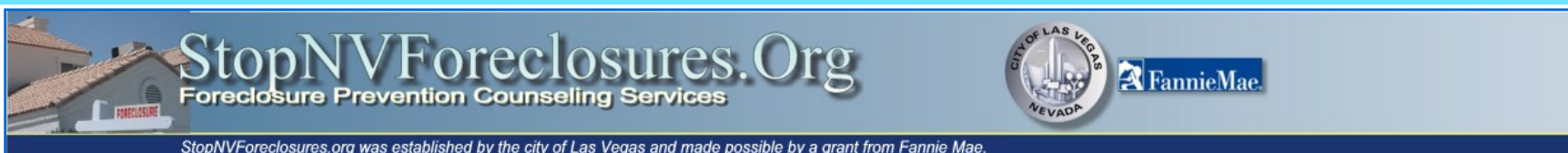

Get Foreclosure Help Now

Are you or someone you know facing foreclosure? The city of Las Vegas is providing a free service to connect homeowners facing foreclosure with local HUD approved counseling agencies. This service will help you navigate through the process and prevent you from falling victim to fraud from companies that require up-front fees or other scams that prey on vulnerable homeowners.

Through the website, you can securely complete and submit an online form and be connected with a HUD approved counseling agency that will assist you. Once your information has been submitted, an agency representative will:

- Schedule an appointment with you;
- Determine where you are in the foreclosure process;
- Perform a financial assessment and provide recommendations about your available options; and
- Assist you in working out a plan with your mortgage company.

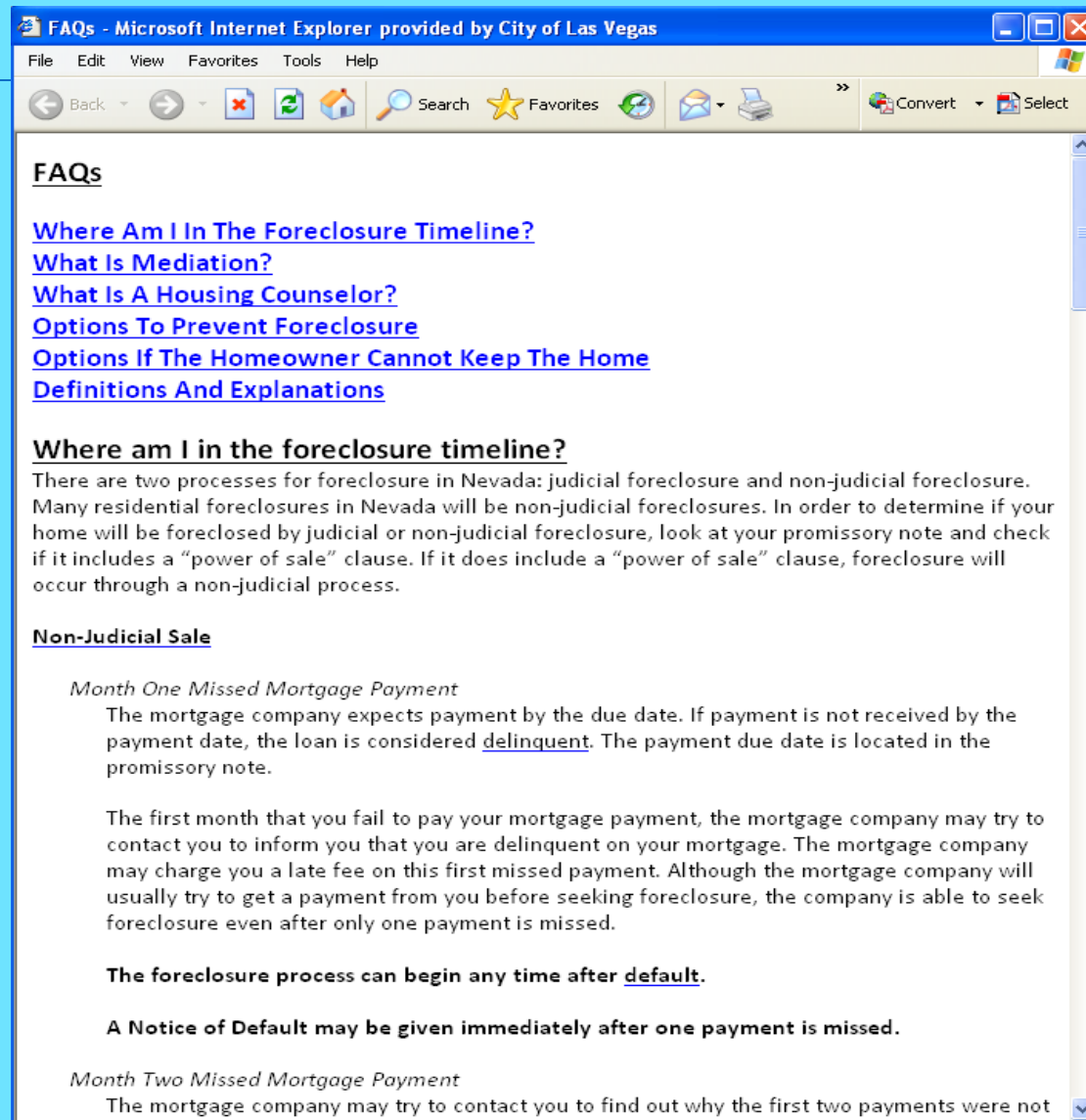
