PURPOSE/BACKGROUND:

On June 18, 2008 City Council approved award of Bid No. 08.1730.18-LED in the amount of \$20,779,140. Subsequent approvals by Council modified the contract and added contingency funds bringing the total contract amount to \$24,977,969.17. This modification will provide for an additional transit station on Grand Central Parkway to facilitate improved access and enhance service to system patrons. Funding for this modification is contingent on the approval of funds by the Regional Transportation Commission Board which is scheduled to vote on this item on September 9, 2010.
