PURPOSE/BACKGROUND:

This project consists of improvements of approximately 16,800 feet of new storm drain facilities including reinforced concrete boxes, laterals, confluence and transition structures, storm drain inlets and manholes of various types and sizes, roadway reconstruction and restriping for the existing pavement, roadway improvements and waterline and sewer line relocations. This project also includes one additive alternate bid item to extend the dual 15' by 8' reinforced concrete box facility at the Northern CC-215 Bruce Woodbury Beltway. Funding for this project is being provided by the Regional Flood Control District.
