PURPOSE/BACKGROUND:

Discussion and possible action regarding a Six Month Review of a Tavern License.

RECOMMENDATION:

Recommendation to be provided following the discussion of this item at the City Council Meeting and subject to the following conditions:

1. Entertainment allowed will include karaoke, comedy, live bands, birthdays, weddings and wedding receptions.
2. Entertainment will be limited to Monday, Wednesday, Friday or Saturday nights from 6 PM until 2 AM for ages 21 and over for a three month period.
3. Live bands to be limited to Monday, Wednesday, Friday or Saturday nights only for a three month period.
4. Entertainment for the week will be submitted to Business Services each Monday for review and approval.
5. No outdoor events will be allowed.
6. DJ must be an employee of the Red Label Bar & Lounge. No outside DJs or promoters will be allowed.
7. The Manager or designee may immediately suspend the entertainment venue if violations of the conditions are found pending a review of the tavern license at the next available City Council meeting.
8. Three month review.

Minutes:

CAROL MEYER, Supervisor of Business Services, reported that this matter was brought to the Council for a three-month review and she read the conditions under the Recommendation section.

ATTORNEY LANCE HENDRON, representing the applicants, who were present, stated that there have been no concerns in the past three months. He requested a permanent license be granted, the limitation on the days offering entertainment be eliminated and the hours of operation be approved for 6:00 p.m. to 4:00 a.m., retaining conditions 1 and 4-7.

MRS. PETKOVA stated that she would like the limitation on the days eliminated for more flexibility. ATTORNEY HENDRON indicated that Business Services would be made aware of all events.

COUNCILMAN REESE supported inserting Conditions 2 and 3 and granting the permanent license with a three-month review.
