**INTERLOCAL CONTRACT FOR SERVICE SHARING AND GOVERNMENT
EFFICIENCY STUDY**

THIS INTERLOCAL CONTRACT ("Contract") is made and entered into this 6TH day of OCTOBER, 2010, by and between the City of Las Vegas (the "City"), and the City of North Las Vegas ("NLV"), both of which are municipal corporations within the State of Nevada.

RECITALS

WHEREAS, the City and NLV agreed to commence a cooperative effort to procure the services of a consultant for the purpose of preparing a Service Sharing and Government Efficiency Report (the "Report") in an amount not to exceed \$75,000; and

WHEREAS, the City issued Request for Proposal (RFP) No. 110017-PM to solicit proposals from various consultants who would be responsible for preparing the Report; and

WHEREAS, the CITY received two proposals which were analyzed by an evaluation team composed of representatives from the City and NLV; and

WHEREAS, the evaluation team determined that Management Partners, Inc. (the "Consultant") submitted the best value proposal in response to the RFP; and

WHEREAS, the City and NLV desire to enter into this Contract, which set forth their respective obligations for sharing the costs of the Report.

NOW, THEREFORE, in consideration of the covenants, conditions, agreements and promises herein contained, it is mutually agreed to by and between each of the parties as follows:

1. **Contract Award:** The parties hereto hereby agree that the City shall award the contract for the preparation of the Report to the Consultant in the amount of \$75,000.
2. **Contract Liability:** The parties hereto agree that the City shall be responsible for submitting the full payment to the Consultant. North Las Vegas will be responsible for submitting \$25,000 to the City of Las Vegas as reimbursement for services provided.
3. **Contract Payment:** The City is hereby authorized to pay the Consultant on behalf of both parties hereto, which payment shall be after the completion of a presentation to the Las Vegas City Council and North Las Vegas City Council as provided in the contract between the City and the Consultant. NLV agrees to submit a check to the City for its share of the costs of the Contract no later than 15 days after the presentation to the North Las Vegas City Council.

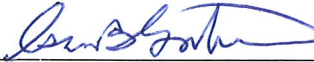

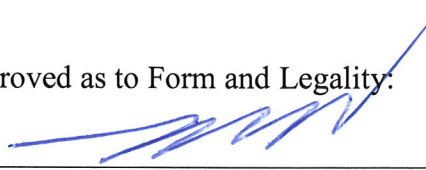
