PURPOSE/BACKGROUND:

James Cooper d/b/a The Amazing Art Company holds Retail Gallery License A48-00227-1-147116. On February 12, 2009, and June 17, 2010, James Cooper sold graffiti implements in the form of a 15mm silver paint marker and four cans of spray paint to underage decoys without the consent of the parent or guardian of such minors. As a result of these repeated offenses, it is alleged that James Cooper d/b/a The Amazing Art Company has operated in an illegal manner, contrary to law and in violation of LVMC 6.02.330, and 10.48.090.

RECOMMENDATION:

That the City Council issue the Complaint for Disciplinary Action and set a date and time certain for hearing no later than 60 days from the date of approval of the complaint.

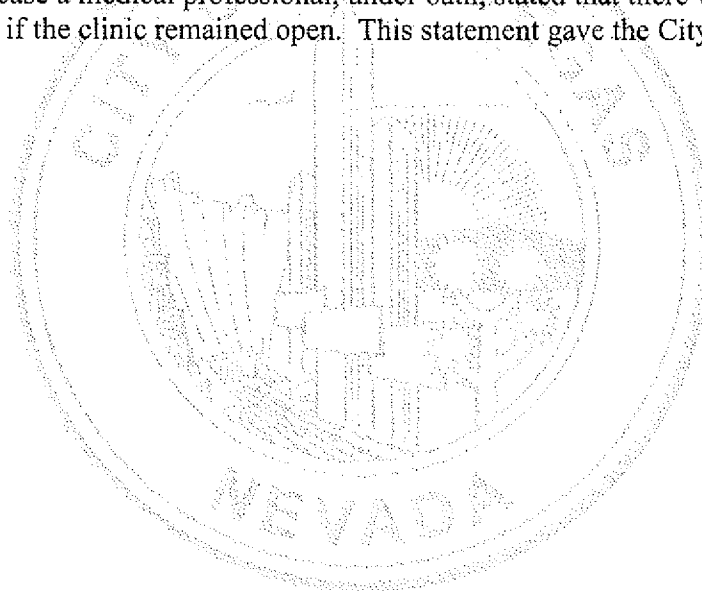
PHILIP BYRNES, Deputy City Attorney, recommended the City Council approve the Complaint and filing of service on JAMES COOPER, and hold a hearing within 60 days. The Complaint was provided to the City Clerk's Office.

CITY COUNCIL MEETING OF: AUGUST 18, 2010

COUNCILWOMAN TARKANIAN felt strongly that the Council has to put a stop to selfish business owners who sell to taggers and contribute to the increased problem with taggers, because it poses a great hardship for residents and government.

COUNCILMAN WOLFSON noted that the respondent has already engaged in illegal activity twice in a 12-month period and asked if he is still in business. CITY ATTORNEY BRAD JERBIC responded that the business is open; however, the Council does not have the liberty of discussing the merits of the case, opining that any discussion would create a poor record. The mechanism for shutting the business down is to follow through with the Complaint. CITY ATTORNEY JERBIC advised COUNCILMAN WOLFSON that there is no quicker vehicle to shut this business down.

COUNCILMAN BARLOW was perplexed as to how in this matter the City would have to terminate the business by means of the Complaint, yet in the recent case involving a clinic, the City went into the clinic and removed the business license. CITY ATTORNEY JERBIC explained that in that case a medical professional, under oath, stated that there was an immediate threat to public health if the clinic remained open. This statement gave the City unusual legal power.

14 The DEPARTMENT OF FINANCE AND BUSINESS SERVICES, on behalf of the
15 CITY OF LAS VEGAS, NEVADA (Department), Petitioner, brings this Complaint for
16 Disciplinary Action against JAMES COOPER d/b/a THE AMAZING ART COMPANY,
17 3814 Meadows Lane, Las Vegas, Clark County, Nevada, Respondent, and states:

18 Respondent JAMES COOPER d/b/a THE AMAZING ART COMPANY holds Retail
19 Gallery License A48-00227-1-147116 and engages in the retail sales of art and art supplies.

20 **SUMMARY OF ALLEGATIONS**

21 Respondent JAMES COOPER d/b/a THE AMAZING ART COMPANY operates a retail
22 gallery selling art and art supplies. The business has been operated in an unlawful manner by
23 creating a public and chronic nuisance in violation of the Las Vegas Municipal Code by selling
24 graffiti implements to minors without the consent of the parent or guardian of such minors.

25 **SALE OF GRAFFITI IMPLEMENTS TO MINORS**

26 On February 12, 2009, a 17-year-old decoy, utilized by the Las Vegas Metropolitan
27 Police Department, entered the premises of Respondent JAMES COOPER d/b/a THE
28 AMAZING ART COMPANY and approached JAMES COOPER (COOPER). The underage

1 decoy asked to purchase a 15mm silver paint marker. COOPER sold the underage decoy the
2 silver paint marker without requesting identification or inquiring about the underage decoy's age.
3 COOPER was cited for furnishing a graffiti implement to a minor in violation of LVMC
4 10.48.090. On January 25, 2010, COOPER entered a plea to the citation by submitting the
5 matter on the record. COOPER received a suspended sentence of 180 days in jail and forfeited
6 bail in the amount of \$300.

7 On June 17, 2010, a 17-year-old decoy, utilized by the Las Vegas Metropolitan Police
8 Department, entered the premises of Respondent JAMES COOPER d/b/a THE AMAZING ART
9 COMPANY and approached COOPER. The underage decoy informed COOPER that his parents
10 had taken away his paint and asked to purchase spray paint. COOPER asked the underage decoy
11 if he was working with the police or was a junior cadet. COOPER sold the underage decoy four
12 cans of spray paint for the sum of \$32. COOPER also gave the underage decoy a number of
13 custom spray paint tips free of charge.

14 SUBSTANTIVE LAW

15 LVMC 6.02.330 provides [Unlawful Business Activity]:

16 A licensee may be subject to disciplinary action by the City
17 Council for good cause, which may, without limitation, include the
18 following:

.....

18 (G) The premises on which the business is conducted do
19 not satisfy local, state or federal law or regulations which pertain to
20 the activity which is actually engaged in;

21 (H) The business activity constitutes, promotes, causes,
22 allows, fosters, aids, or otherwise enables a private nuisance,
23 public nuisance or chronic nuisance, or has been or is being
24 conducted in an unlawful, illegal or impermissible manner,
including but not limited to causing, allowing, promoting,
fostering, aiding, enabling, exercising deliberate ignorance towards
or failing to abate a private nuisance, public nuisance or chronic
nuisance; or

25 (I) The licensee, any of its principals, their employees or
26 those acting on their behalf failed to cooperate with the Director's
efforts to enforce the provisions of this Code.

27

28

1 LVMC 6.02.350 provides [Acts and Omissions]:

2 A licensee under this Title shall be subject to disciplinary
3 action not only for acts or omissions done by such licensee but also
4 for acts and omissions done by the principals, managers, agents,
5 representatives, servants or employees of such licensee.

6 LVMC 10.48.060(C) defines a "Graffiti implement" as:

7 "Graffiti implement" means any broad tipped indelible
8 marker or aerosol paint container or other item that may be used to
9 propel or apply fluid that is not soluble in water.

10 LVMC 10.48.060(E) defines a "Responsible adult" as:

11 "Responsible adult" means a parent or legal guardian of a
12 minor.

13 LVMC 10.48.090 [Graffiti Implements - Prohibition Against Furnishing to Minors]
14 provides:

15 No person, other than a responsible adult, shall sell,
16 exchange, give, loan, or in any way furnish a graffiti implement to
17 any minor without the consent of the minor's responsible adult.

18 STANDARD OF EVIDENCE

19 LVMC 6.88.090 provides:

20 (A) The hearing need not be conducted according to
21 technical rules relating to evidence and witnesses. Any relevant
22 evidence may be admitted.

23 (B) The respondent shall have the right to call and examine
24 witnesses on his own behalf, cross-examine opposing witnesses,
25 introduce exhibits and evidence relevant to the issues of the case,
26 and offer rebuttal evidence.

27 (C) The respondent may be called and examined by the
28 City.

(D) The Clerk shall have the power to issue subpoenas for
witnesses to appear to give testimony.

25 PENALTY

26 LVMC 6.02.360 provides:

27 Upon a showing of good cause and in the discretion of the
28 City Council, disciplinary action against a holder may take the
form of cancellation, revocation, refusal to renew, suspension,

1 imposition of conditions or restrictions or civil fine in an amount
2 not to exceed one thousand dollars for each day that the violation
3 which forms the subject matter of the complaint that recommends
4 such disciplinary action is demonstrated to have been in existence,
5 or any combination of such actions, as the particular situation may
6 require. The Council may also impose against the licensee the
actual costs incurred, and a reasonable amount for attorney's fees,
7 resulting from the imposition of disciplinary action. The
8 disciplinary actions available in this Section shall be in addition to,
and not exclusive of, any other civil or criminal remedy which
otherwise might be available.

7 **ALLEGATIONS**

8 **COUNT ONE**

9 It is alleged that between February 17, 2009, and the present, Respondent JAMES
10 COOPER d/b/a THE AMAZING ART COMPANY operated a business which constituted a
11 public, private and chronic nuisance and which has been conducted in an unlawful, illegal and
12 impermissible manner, to wit: furnishing graffiti implements to minors without the consent of
13 the parent or legal guardian of such minors in violation of LVMC 10.48.090.

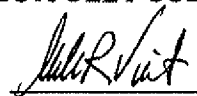
14 WHEREFORE, the Petitioner respectfully requests the City Council to:

\$60.00 in U.S. currency. He entered the store and engaged the sales person in conversation. That sales person was confirmed to be owner-operator James K. Cooper. The decoy verbally described to Cooper that "his parents took his paint from him" and inquired about purchasing spray paint. Cooper asked if the decoy was "working with the police or was a junior cadet" at which time the decoy stated that he was not.

At that time the sale was made with the decoy handing Cooper \$40.00 in U.S. currency which was provided by the LVMPD. He received \$8.00 back from Cooper completing the transaction.

Cooper advised the decoy that he was a "cash business only" and he freely offered some custom spray paint tips to the decoy free of charge. During this transaction Cooper also advised the decoy that he was receiving a large shipping of spray paint on "Friday."

At no time during this event did Cooper inquire about the decoy's age or request identification. The decoy then left the business and met with detectives. The spray paint was taken into detective's possession. Detectives then entered the business and engaged Cooper in conversation.
