**PURPOSE/BACKGROUND:**

Ran Oriental Therapy's LLC d/b/a Shangri La Health Clinic holds Massage Establishment License M03-00053-4-082152. Jinli Ran is the owner of Ran Oriental Therapy's LLC and also holds Massage Therapist License No. M12-00187-5-094559. Between 2006 and 2010, six individuals employed at Shangri La Health Clinic have been arrested for soliciting prostitution. As a result of these repeated offenses, it is alleged that Ran Oriental Therapy's LLC d/b/a Shangri La Health Clinic has operated in an illegal manner, contrary to law and in violation of LVMC 6.02.330, 6.52.120, NRS 201.354(1) and LVMC 10.36.020(A).

**RECOMMENDATION:**

That the City Council issue the Complaint for Disciplinary Action and set a date for hearing no later than 60 days from the date of approval of the complaint.
