PURPOSE/BACKGROUND:

The Youth Neighborhood Association Partnership Program Grant Review Board was established by Council action on March 1, 2000. YNAPP is a service-learning program encouraging young people to take an active role in their neighborhood. The Board consists of 15 members, eight adults and seven youth and two alternate members (one adult and one youth). Terms of office are one year, and members may be reappointed to consecutive one-year terms. Expiration of this Board occurs yearly.
