

**SUPPLEMENTAL INTERLOCAL CONTRACT NO. 6
ARTERIAL RESTORATION AND PRESERVATION PROJECTS
FISCAL YEAR 2006**

THIS SUPPLEMENTAL INTERLOCAL CONTRACT NO. 6 made and entered into this 9th day of December, 2010 by and between the City of Las Vegas, a municipal corporation, hereinafter referred to as the "CITY" and the Regional Transportation Commission of Southern Nevada hereinafter referred to as "RTC".

WITNESSETH

WHEREAS, RTC approved an Interlocal Contract on August 11, 2005 and supplemental interlocal contracts dated May 18, 2006, July 13, 2006, September 13, 2007, February 12, 2009 and November 12, 2009 for the Arterial Restoration and Preservation Projects, Fiscal Year 2006, being located wholly within the CITY; and

WHEREAS, the RTC previously granted a revised "Authorization to Proceed" for construction; and,

WHEREAS, the CITY desires to extend the project completion date.

NOW, THEREFORE, in consideration of the covenants, conditions, agreements, and promises of the parties hereto, it is mutually agreed to supplement the Interlocal Contract for the Project as follows:

SECTION III – GENERAL paragraph 7 shall be revised to read as follows:

7. The project must be completed to the satisfaction of the RTC prior to December 31, 2011. The RTC may at any time thereafter grant time extensions or terminate this Contract and require all sums advanced to the CITY be reimbursed.

The remainder of the Interlocal Contract dated August 11, 2005 and supplemental interlocal contracts dated May 18, 2006, July 13, 2006, September 13, 2007, February 12, 2009 and November 12, 2009 shall remain unchanged.
