PURPOSE/BACKGROUND:

The Neighborhood Partners Fund Board was established through Council action in June 1998 to review Neighborhood Partners Fund applications and recommend awards to the City Council. It is designed to assist citizens in improving the quality of life for City of Las Vegas neighborhoods. The bylaws were amended in February 2000 to increase the number of members from 9 to 13 and again in March 2009 to adjust the one-year term to commence April 1. In 2010 the bylaws were amended as a housekeeping measure to clarify that members need not be a City resident. Procedure for this Board is appointment by Mayor and City Council.
