AUTHORITY: Created by Council Action on 3-9-98 with bylaws approved on 6-22-98. By-Laws were amended on 2-16-2000 to increase the membership to 13 members. By-laws approved 3-18-2009 adjusted term to run from April 1 though March 30 of appointed year. By-laws approved 5/19/2010 clarified members need not be City residents.

MEMBERS: 13 MEMBERS appointed by the Mayor and City Council comprised as follows:

- Mayor or her/his designee
- Council Liaison or Staff Designee of the Councilmember for each of the six Council Wards
- One Neighborhood Representative for each of the six Council Wards

TERM: Members shall each serve a term of one year. Expiration dates were set on 5/18/2000 so all members terms expired at the same time.
Members may be reappointed to consecutive one-year terms as necessary
(Must fill un-expired term. Membership is not assignable or transferable.)

NOTES: Members Need Not Be City Residents
