

Amendment No. 1 to
Highway Agreement No. P-093-10-063

This Amendment is made and entered into this 22ND day of APRIL, 2011, between the State of Nevada, Department of Transportation, hereinafter referred to as the DEPARTMENT, and City of Las Vegas, 400 East Stewart Avenue, Las Vegas, NV 89101, hereinafter referred to as the CITY.

WITNESSETH:

WHEREAS, on May 14, 2010, the Parties entered into Agreement No. P-093-10-063 to delegate authority to the CITY to design, advertise, award and manage construction of a multi use trail, signing, lighting, striping, median islands, sidewalk and ADA improvements by Hyde Park Middle School, Vegas Verde Elementary and Wasden Elementary; and

WHEREAS, the City has requested and been approved for a change in the PROJECT scope.

WHEREAS, the Parties hereto desire to make certain amendments to Agreement No. P-093-10-063.

NOW, THEREFORE, the Parties agree as follows:

- A. Attachment "A" is removed in its entirety and replaced with the attached Attachment "A-1".
- B. All of the other provisions of Agreement No. P-093-10-063 shall remain in full force and effect as if set forth herein.

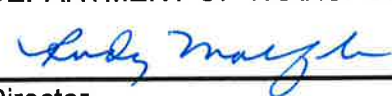

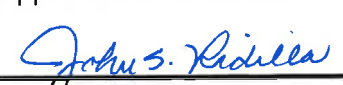

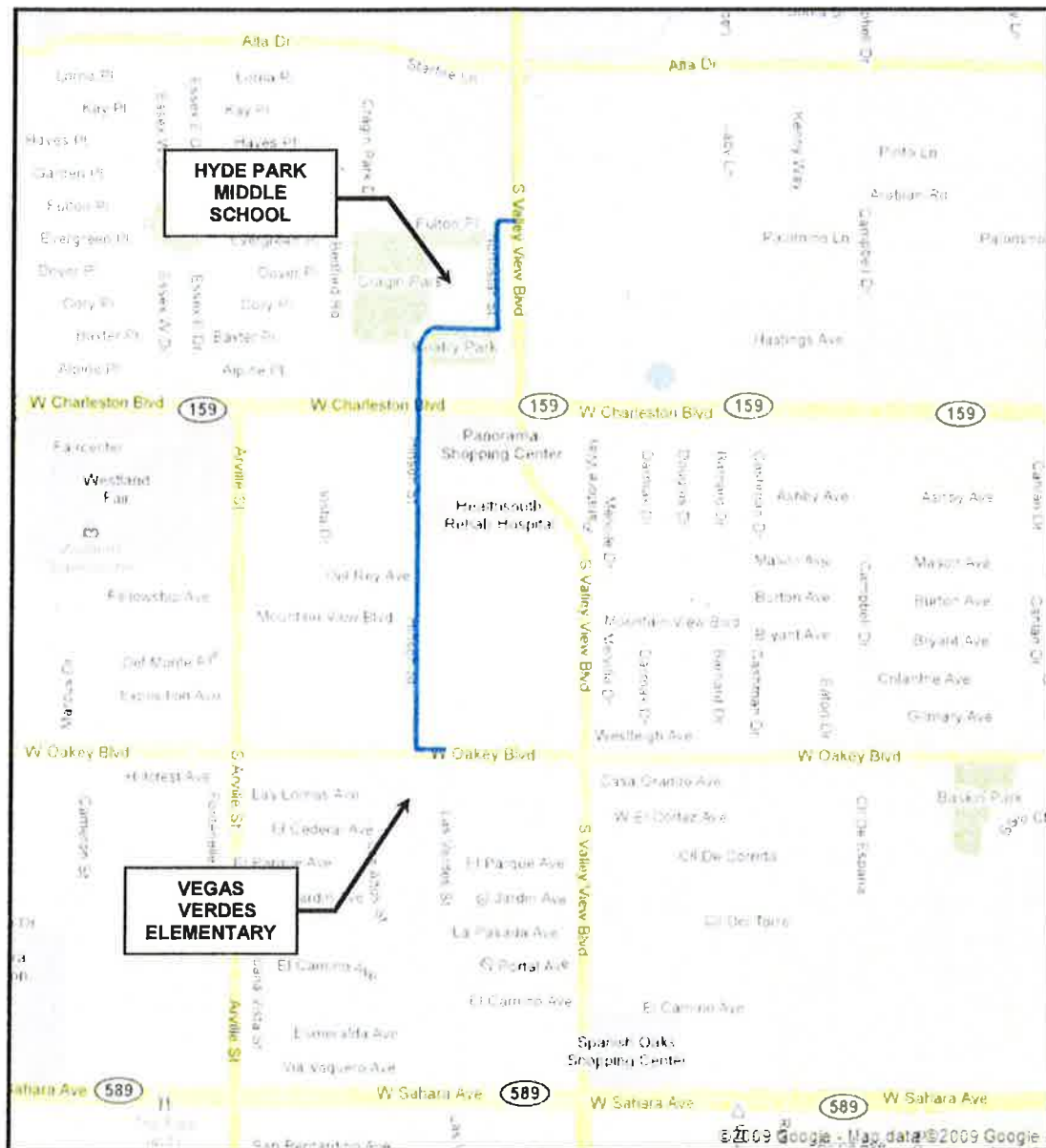

SCOPE OF WORK Hyde Park, Vegas Verdes and Wasden SRTS PROJECT

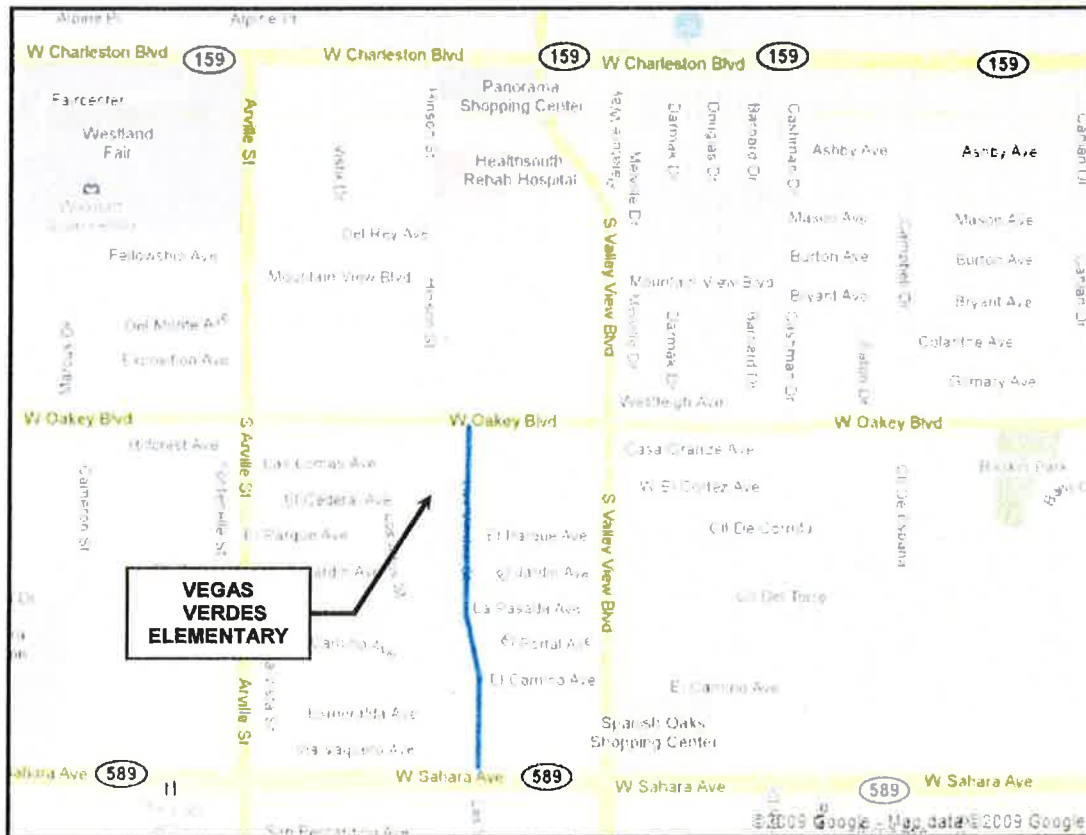
The PROJECT consists of the construction of a multi use trail along Oakey Blvd., Hinson St., Northstar St. and Fulton Pl. between Oakey Blvd. and Valley View Blvd. as depicted on the map below. Improvements will include signing, lighting, striping, sidewalk and ADA improvements

SHARED USE PATH



The Project also consists of the construction of two bike lanes on Las Verdes St. between Sahara Ave. and Oakley Blvd. as depicted on the map below. Improvements will include signing and striping.

BIKE LANE STRIPING



The project also consists of the construction of signing, striping, median islands, sidewalk and ADA improvements in front of Vegas Verdes Elementary School on Las Verdes St. from Oakley Blvd. to El Parque Ave. and Oakley Blvd. from Los Altos St. to 200' east of Las Verdes St., Hyde Park Middle School on Hinson St and Northstar St. and Wasden Elementary School on Palomino Ln. as depicted on the maps below.
