**** STAFF REPORT ****

PROJECT DESCRIPTION

The subject site is currently occupied by a vacant building located at 1141 South Maryland Parkway. The applicant received previous approval for a Site Development Plan Review (SDR-32447) for a proposed 2,672 square-foot, two-story office building with waivers to allow landscape buffers of five feet along the north perimeter where 15 feet is required; seven feet along the west perimeter where 15 feet is required; and zero feet along the south and east perimeters where eight feet is required. Plan check #34985 was processed on 06/05/09 for the office building, but has subsequently expired without permits being issued for the proposed project.

It is noted that a related Extension of Time (EOT-40994) will be heard concurrently with this item.

BACKGROUND INFORMATION

02/18/09	The City Council approved a request for a Variance (VAR-32448) to allow a building setback of 43 feet where residential adjacency standards require 96 feet; a five-foot front yard setback where 25 feet is required; and a seven-foot corner side setback where 15 feet is required on 0.16 acres at 1141 South Maryland Parkway. The Planning Commission recommended approval; staff recommended denial.
	The City Council approved a related request for a Site Development Plan Review (SDR-32447) for a proposed 2,672 square-foot, two-story office building with waivers to allow landscape buffers of five feet along the north perimeter where 15 feet is required; seven feet along the west perimeter where 15 feet is required; and zero feet along the south and east perimeters where eight feet is required.

ANALYSIS

This is the first request for an Extension of Time of a previously approved Site Development Plan Review (SDR-32447) for a proposed 2,672 square-foot, two-story office building with waivers to allow landscape buffers of five feet along the north perimeter where 15 feet is required; seven feet along the west perimeter where 15 feet is required; and zero feet along the south and east perimeters where eight feet is required. Plan check #34985 was processed on 06/05/09 for the office building, but has subsequently expired without permits being issued for the proposed project.

Title 19.18.050 deems a Site Development Plan Review exercised upon the issuance of a building permit for the principal structure on site.

FINDINGS

The Site Development Plan Review has not met Title 19.18.050 requirements to exercise the entitlement as no building permits have been issued for the proposed project. The applicant is requesting an Extension of Time due to the current economic climate in Las Vegas and to secure financing for the proposed project. Since the approval of the Site Development Plan Review (SDR-32447) in February 2009, there have not been any changes in land use or new development in the surrounding areas; therefore, staff is recommending approval of this request with a three-year time limit. Conformance to the conditions of approval of the Site Development Plan Review (SDR-32447) shall be required.
