

**INTERLOCAL CONTRACT FOR A SERVICE
SHARING AND GOVERNMENT EFFICIENCY STUDY
STRATEGIC IMPLEMENTATION**

THIS INTERLOCAL CONTRACT made and entered into this 4TH day of May, 2011 by and between the City of Las Vegas, a municipal corporation hereinafter referred to as the "CITY" and the City of North Las Vegas, hereinafter referred to as "NLV."

WHEREAS, the CITY and NLV agreed to commence a cooperative effort to procure a Service Sharing and Government Efficiency Report from Management Partners; and

WHEREAS, the report was provided to both City Councils and all recommendations were accepted; and

WHEREAS, the City Council and the NLV Council directed staff at the February 16, 2011 Joint Council Meeting to continue working with Management Partners to further analyze recommendations made by Management Partners and implement recommendations where feasible; and

WHEREAS, the City Council of each jurisdiction unanimously approved the report and indicated a value in continuing to work with Management Partners to:

- Further develop and analyze the seven areas identified in the report; and
- Provide an implementation strategy that is acceptable to both parties; and
- Further investigate other areas identified in the report that will yield the best return for both cities and their respective constituencies.

NOW, THEREFORE, in consideration of the covenants, conditions, agreements and promises herein contained, it is mutually agreed to by and between each of the parties as follows:

1. **Contract Award.** The CITY shall award the contract for the procurement of a Service Integration Study and Implementation Plans to Management Partners, Inc. in an amount not to exceed \$100,000 (the "Contract").
2. **Contract Payment.** The CITY shall pay Managements Partners, Inc. after they have fulfilled the obligations of the Contract within 30 days after receipt of invoice. NLV shall submit a check in the amount of Thirty-Five percent (35%) of the total value of the invoice submitted by Management Partners to the CITY no later than 15 days after the City has paid Management Partners.


