**PURPOSE/BACKGROUND:**

On October 6, 2010 Council approved award of Contract No. 110017-PH to study service sharing and efficiency opportunities between the cities of Las Vegas and North Las Vegas. This modification adds scope and funding for Management Partners to provide assistance to both cities in planning implementation of seven recommended service sharing areas. North Las Vegas will be reimbursing the City \$40,000 for its share of the contract costs.
