

**SUPPLEMENTAL INTERLOCAL CONTRACT NO. 1  
DOWNTOWN PEDESTRIAN AND BICYCLE IMPROVEMENTS**

**THIS SUPPLEMENTAL INTERLOCAL CONTRACT NO. 1** made and entered into this 10<sup>th</sup> day of March, 2011, by and between the CITY OF LAS VEGAS, a municipal corporation, hereinafter referred to as the "CITY" and the Regional Transportation Commission of Southern Nevada hereinafter referred to as "RTC".

**WITNESSETH**

**WHEREAS**, RTC approved an Interlocal Contract on January 13, 2011 for the design, right-of-way acquisition and right-of-way other for Downtown Pedestrian and Bicycle Improvements within one-mile radius of the Bonneville Transit Center, located wholly within the CITY; and

**WHEREAS**, the RTC previously granted "Authorization to Proceed" for construction, engineering, right-of-way acquisition and right-of-way other; and,

**WHEREAS**, the CITY desires to increase funding for the Project.

**NOW, THEREFORE**, in consideration of the covenants, conditions, agreements, and promises of the parties hereto, the RTC authorizes the CITY to proceed with the Project as it is mutually agreed and understood, as follows:

**SECTION II: PROJECT COSTS: shall be revised to read as follows:**

The RTC agrees to provide funding for project costs according to Section 6.1 REIMBURSEMENT COSTS of the Policies and Procedures Manual of the RTC within the limits specified below:

1. The total cost for engineering design and contract administration shall not exceed \$1,350,000.
2. The City will be issued a revised "Authorization to Proceed" for engineering design in an amount not to exceed \$1,350,000 at the time written "Authorization to Proceed" is received from the RTC. The "Revised Authorization to Proceed" shall state a specific amount within the total estimated cost of the Project and, upon approval by the RTC, only that amount shall be encumbered and allocated.
3. A written request must be made to the RTC and an additional supplemental interlocal contract approved to allow exceptions to the adopted policies and procedures of the RTC or the amount noted above prior to payment of any additional funds.

The remainder of the Interlocal Contract dated January 13, 2011 shall remain unchanged.

IN WITNESS WHEREOF, this SUPPLEMENTAL INTERLOCAL CONTRACT NO. 1 is effective as of the date first set forth above.
