**PURPOSE/BACKGROUND:**

On August 2, 2006 City Council approved award of a contract to provide architectural and associated services to develop the post office/courthouse. This modification adds services to make adjustments to the museum layout including the St. Valentines Day wall location and the main lobby cages, necessitated by a redesign of the third floor corridor requested by the National Park Service. This item is exempt from the competitive bidding process pursuant to NRS 332.115.1(b), Professional Services.
