PURPOSE/BACKGROUND:

The condition of the property was a public hazard and an attractive nuisance. The Department of Building and Safety declared the property in violation and started legal notification. When no corrective action was taken nor an appeal filed, the Department of Building and Safety hired Lunas Construction to board all open doors and windows, remove shed and exterior accessory structures located in the rear yard to include half constructed tree house, non-permitted and located in the set back, and remove all trash, debris, graffiti, and all high and dead vegetation, grass, and weeds. To date, there have been six (6) inspections conducted at this location. The estimated value of the property based on Zillow.com is \$56,000.

RECOMMENDATION:

That the City Council: Approve the report of expenses to include \$1,037 invoice for Lunas Construction in addition to other fees assessed for a total of \$2,868.55 and consider assessing a maximum of \$31,550 in daily civil penalties.
