PURPOSE/BACKGROUND:

The condition of the property was a public hazard and an attractive nuisance. The Department of Building and Safety declared the property in violation and started legal notification. When no corrective action was taken nor an appeal filed, the Department of Building and Safety hired American Demolition to board all open doors and windows, remove non-permitted structure, trash, debris, and high weeds and grass. To date, there have been six (6) inspections conducted at this location. The estimated value of the property based on Zillow.com is \$61,500.

RECOMMENDATION:

That the City Council: Approve the report of expenses to include \$1,300 invoice for American Demolition in addition to other fees assessed for a total of \$2,473 and consider assessing a maximum of \$54,550 in daily civil penalties.
