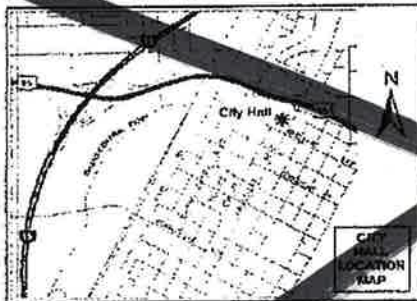

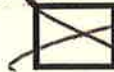

Re: Variance # 41321

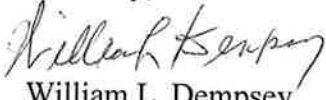
I expressed my disapproval of this variance request when it went before the Planning Commission and I again object to this variance.
