Amendment III

This Amendment III (this "Amendment"), dated this 6TH day of July, 2011 ("Effective Date"), is made to the License Agreement, dated July 1, 2001 as amended by Amendment I dated December 14, 2004 and Amendment II dated December 7, 2005, (collectively, the "Agreement") by and between **NEW CINGULAR WIRELESS PCS, LLC**, a Delaware limited liability company, successor in interest to New Cingular Wireless Services of Nevada, LLC ("LICENSEE"), and **CITY OF LAS VEGAS** ("LICENSOR"), a municipality, with respect to the site known as Atrium Tower located at 333 N. Rancho Drive, Clark County, Las Vegas, Nevada 89107 ("Premises").

LICENSOR's managing agent with respect to the Agreement is SBA Site Management, LLC ("SBAM"), a Florida limited liability company, having an address at 12250 Weber Hill Road, Suite 120, St. Louis, Missouri 63127.

LICENSEE and LICENSOR desire to amend the Agreement for the purpose of adding equipment at the Premises as further described herein, increasing the license fee and for other purposes as may be set forth in this Amendment.

In consideration of the foregoing and for other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, LICENSEE and LICENSOR agree as follows:

1. **Capitalized Terms.** Capitalized terms used in this Amendment will have the meanings set forth in the Agreement unless otherwise indicated.

2. **Equipment.** Notwithstanding anything to the contrary in the Agreement, from and after the Effective Date of this Amendment, LICENSEE shall have the right to swap six (6) panel antennas for larger and to install three (3) 8' antennas, six (6) Tower Mount Antennas (TMA's), six (6) Remote Radio Heads (RRH's), one GPS, three (3) Raycap surge suppressors, one (1) fiber cable and two (2) power lines ("Additional Equipment") at the Premises in accordance with all the terms and conditions of the Agreement.

Notwithstanding anything to the contrary in the Agreement, from and after the Effective Date of this Amendment, Exhibit A to the Agreement is deleted in its entirety and superseded and replaced with Exhibit A-1 attached hereto.

3. **License Fee.** Beginning upon the earlier of (i) the commencement of the installation of the Additional Equipment on the Premises or (ii) July 1, 2011, LICENSEE shall pay monthly to LICENSOR, in addition to and payable with the monthly license fee, an additional fee of One Thousand Two Hundred Dollars and Zero Cents (\$1200.00) (the "Additional Equipment Fee"), pro rated for partial months. The Additional Equipment Fee shall be subject to the same escalations, in amount and frequency, to which the license fee is subject in accordance with the Agreement. Payments under this paragraph 3 shall be in addition to any other amounts required under the Agreement.

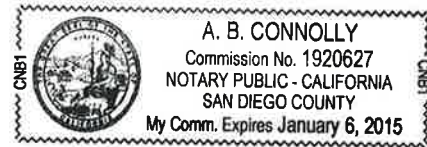

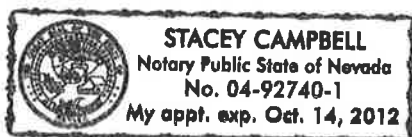
