SECOND FLOOR

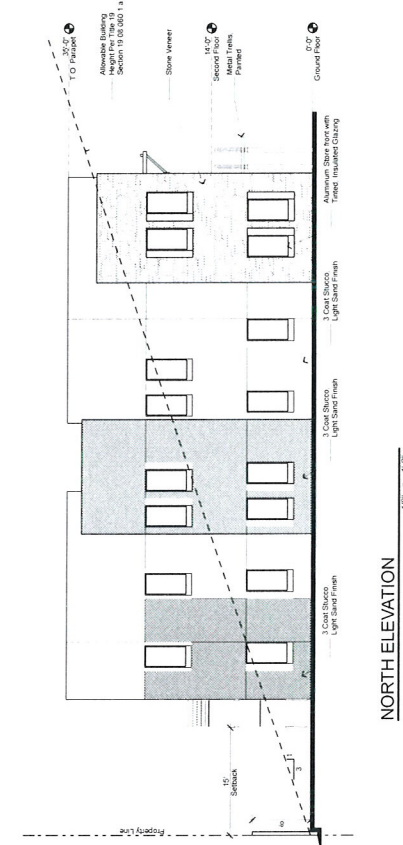
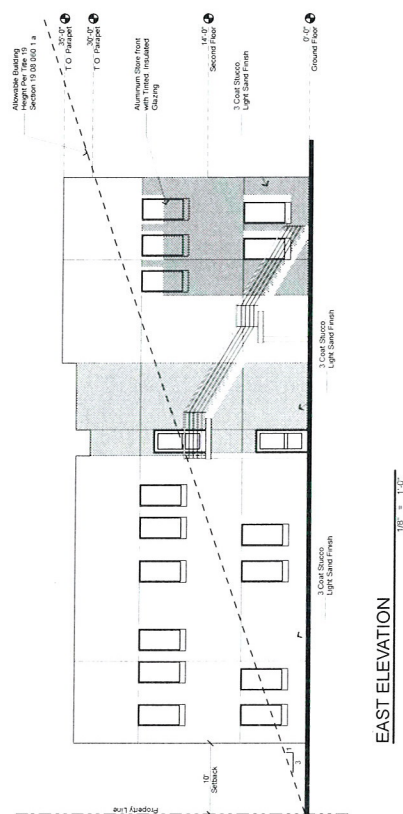
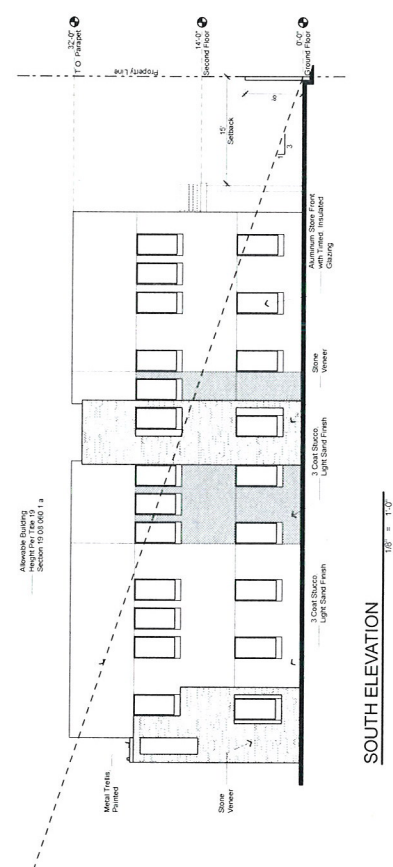
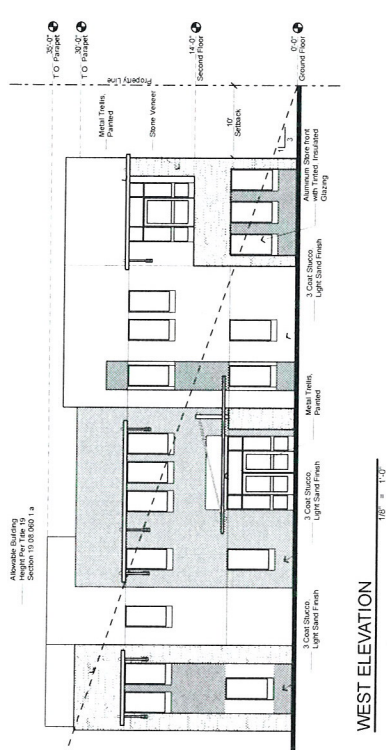
