

**SUPPLEMENTAL INTERLOCAL CONTRACT NO. 5
SHEEP MOUNTAIN CORRIDOR STUDY**

THIS SUPPLEMENTAL INTERLOCAL CONTRACT NO. 5 made and entered into this 19th day of May, 2011 by and between the CITY OF LAS VEGAS, a municipal corporation, hereinafter referred to as the "CITY" and the Regional Transportation Commission of Southern Nevada hereinafter referred to as "RTC".

WITNESSETH

WHEREAS, RTC approved an Interlocal Contract on May 19, 2005 and a Supplemental Interlocal Contracts on December 14, 2006, June 14, 2007, June 12, 2008 and April 9, 2009 for a project to design, purchase right-of-way, perform construction inspection and construct roadway improvements planned for Sheep Mountain Parkway located wholly within the CITY, has been approved by the Regional Transportation Commission.

WHEREAS, the RTC previously granted an "Authorization to Proceed" for design and right-of-way other; and,

WHEREAS, the CITY desires to extend the project completion date.

NOW, THEREFORE, in consideration of the covenants, conditions, agreements, and promises of the parties hereto, it is mutually agreed to supplement the Interlocal Contract for the Project as follows:

SECTION III – GENERAL paragraph 7 shall be revised to read as follows:

7. The project must be completed to the satisfaction of the RTC prior to June 30, 2015. The RTC may at any time thereafter grant time extensions or terminate this contract and require all sums advanced to the CITY be reimbursed.

The remainder of the interlocal contract dated May 19, 2005, and supplemental interlocal contracts dated December 14, 2006, June 14, 2007, June 12, 2008 and April 9, 2009 shall remain unchanged.
