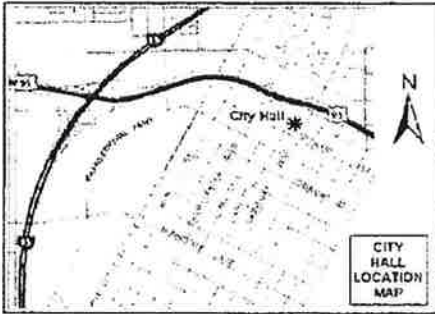

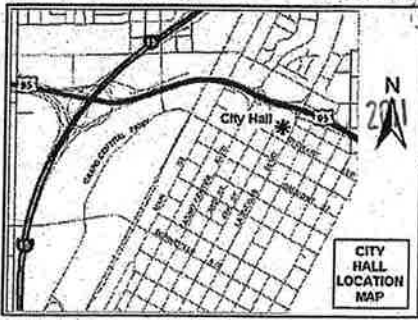

To whom it MAY CONCERN,

My Property at 1901 Ski Slope Cr. (APN#16304702006) Borders with 1900 Plantea Court from the Rear, South to North, for almost the entire width of both properties, which is approx. 130ft. The VAR-41401 to ALLOW TWO-FOOT distance separation between proposed 1,167 sq. ft RV GARAGE and the MAIN dwelling where SIX FEET is Required, will affect my property negatively and will undermine its overall value, since the proposed 1,167 sq. ft. RV GARAGE (17ft wide x 69ft. deep x 18ft High) will line up from the Rear, South to North, along its 17ft width with my entire MASTER Bedroom, and, all my MASTER Bedroom's windows and glass doors, which open to the backyard, would face directly the 17ft wide x 18ft. high back wall of proposed 1,167 sq. ft. RV GARAGE.

I also do not see why the Applicant/owner, Alex Fatahevich, had stipulated at a previous City Commission Meeting on June 17, 2011, that the fact that the property at 1900 Plantea Ct. had an APPROVAL FOR CASITA (592 s.f.) (back in January of 2006!), and it was main reason which ^{and} had determined his decision to purchase the property, (THE 6,303 sq. ft. French CHATEAU + existing 1,056 sq. ft. 4 CAR garages) on March 23, 2009.
