

**SUPPLEMENTAL INTERLOCAL CONTRACT NO. 1
BUS TURNOUT PROJECT - FISCAL YEAR 2011**

THIS SUPPLEMENTAL INTERLOCAL CONTRACT NO. 1 made and entered into this 14 day of July, 2011, by and between the CITY OF LAS VEGAS, a municipal corporation, hereinafter referred to as the "CITY" and the Regional Transportation Commission of Southern Nevada hereinafter referred to as "RTC".

W I T N E S S E T H

WHEREAS, RTC approved an Interlocal Contract on November 10, 2010 for improvements associated with the Bus Turnout Project – Fiscal Year 2011; and,

WHEREAS, the RTC previously granted "Authorization to Proceed" for construction and engineering and,

WHEREAS, the CITY desires to change the scope of the project.

NOW, THEREFORE, in consideration of the covenants, conditions, agreements, and promises of the parties hereto, it is mutually agreed to supplement the Interlocal Contract for the Project as follows:

SECTION I - SCOPE OF PROJECT shall be revised to read as follows:

This Interlocal Contract applies to improvements associated with the installation of bus turnouts along Decatur Boulevard south of Charleston Boulevard, Pecos Road south of Bonanza Road and Rainbow Boulevard south of Lake Mead Drive. The basic improvements will result in the installation of bus turnouts including right-of-way acquisition, construction of bus turnout, passenger loading pad, ADA accessibility, utility relocation, retaining walls, landscaping, sign relocation, driveways relocation, storm drain drop inlets relocation and any other miscellaneous items to complete the project. The improvements will be designed and constructed in accordance with the appendix called "guidelines for the Provision of Bus Turnouts and Passenger Loading Areas for the Citizens Area Transit (CAT) bus" in the Policies and Procedures Manual of the RTC.

The remainder of the Interlocal Contract dated November 10, 2010 shall remain unchanged.
