

OPTION, DISPOSITION AND DEVELOPMENT AGREEMENT

THIS OPTION, DISPOSITION AND DEVELOPMENT AGREEMENT ("Agreement") is entered into as of the Effective Date (hereinafter defined) by and between the CITY OF LAS VEGAS, NEVADA, a political subdivision of the State of Nevada (the "City"), and LAURICH PROPERTIES, INC., a Nevada corporation ("Developer"). The City and the Developer may be referred to herein individually as a "Party" and together as the "Parties."

RECITALS

A. The City owns certain real property that is located within what is commonly known as the Las Vegas Enterprise Park ("Enterprise Park").

B. Enterprise Park is comprised of approximately seventy-five (75) acres that is bounded by Martin Luther King Boulevard on the east, Lake Mead Boulevard on the north, and Vegas Drive on the south.

C. The City desires to grant to Developer options to purchase three pads which are located on the certain property within Enterprise Park and described below in Section 3 (the "Site").

D. The Site is subject to that certain document entitled Covenants, Conditions and Restrictions ("CC&Rs"), which is recorded in the records of the Clark County Recorder at Book 991110, Instrument 01268.

E. In consideration of Developer's Agreement to develop on the Site a neighborhood shopping center comprised of a Dollar General Grocery Store ("DG Market") and two (2) additional retail pad sites of a compatible use (collectively, the "Project"), and for the other consideration described hereinafter, the City desires to sell the Site to Developer.

F. The Parties desire to set forth in this Agreement the terms and conditions of the purchase, sale, and development of the Site.

NOW, THEREFORE, in consideration of the foregoing and of the covenants and conditions contained herein, the Parties agree as follows:

1. **PURPOSE OF AGREEMENT.** The purpose of this Agreement is to facilitate economic development in Enterprise Park and the West Las Vegas community, and to accomplish the sale to, and purchase by, the Developer of the Site, which will lead to the creation of additional jobs and positive social and economic impacts, as further described hereinafter.

2. **COVENANTS, CONDITIONS AND RESTRICTIONS.** The City recorded the CC&Rs in order to facilitate the orderly development of a business park in which research, development, testing, evaluation, assembly, manufacturing, distribution, sales and specific commercial uses will predominate and in order to establish permissible uses, right of way and setback standards, landscaping standards, and various development standards for Enterprise

Park, including the Site. Developer acknowledges receipt of the CC&Rs and agrees to comply with all provisions thereof that are applicable to the Site.

3. SITE, OPTION PARCELS AND EASEMENTS.

(a) The overall site consists of approximately 4.94 acres of vacant commercial land as cross-hatched on the site map attached hereto as Exhibit A, and as legally described in Exhibit B. A preliminary site plan for the Project is attached hereto as Exhibit A-1 (the "Site").

(b) The Site is to be developed by Developer in three separate parcels as follows: (i) the DG Pad, (ii) Pad A and (iii) Pad B (the DG Pad, Pad A and Pad B are collectively referred to herein as the "Pads" or separately as a "Pad"). The Pads are depicted on Exhibit A-1 attached hereto and legally described on Exhibit B.

(c) City also shall convey to Developer two nonexclusive easements for vehicular and pedestrian ingress and egress to the Pads (the "Easements"). The Easements are depicted on Exhibit A-1 and legally described on Exhibit B, each attached hereto. The Easements shall be in the form agreed to by the parties during the Feasibility Review Period (defined below). The Easements are nonexclusive and provide that Developer will pay all costs for the construction of all roadways to be located on the Easements and that Developer shall be responsible for maintaining such roadways at Developer's sole cost and expense.

4. PARTIES TO THIS AGREEMENT.

(a) The City is a political subdivision of the State of Nevada. The principal office of the City is located at 400 Stewart Avenue, Las Vegas, Nevada 89101.

(b) The Developer is LAURICH PROPERTIES, INC., a Nevada corporation. The principal office of the Developer is located at 1770 North Buffalo Drive, Suite 101, Las Vegas, Nevada 89128. Wherever the term "Developer" is used herein, such term shall include any assignee as herein permitted.

(c) Pursuant to Resolution R-105-99 adopted by the City Council effective October 1, 1999, Developer has disclosed on the form attached hereto as Exhibit C all directors, officers, managers and/or principals of Developer, as well as all persons and entities holding more than one percent (1%) interest in Developer. Developer shall provide the City with written notification of any material change in the above disclosure within thirty (30) days of any such change.

(d) The qualifications and identity of the Developer are of particular concern to the City, and it is because of such qualifications and identity that the City has entered into this Agreement with the Developer. The Developer agrees that (i) no voluntary or involuntary successor in interest of the Developer shall acquire any rights or powers under this Agreement except as expressly set forth herein, (ii) except as may otherwise be permitted hereunder, the Developer shall not assign all or any part of this Agreement without the prior written approval of the City and (iii) Developer shall not transfer any ownership interest in Developer. Notwithstanding the foregoing, Developer may without obtaining City's prior written approval:

(1) transfer or assign this Agreement to an entity in which Hank Gordon has both (A) a direct or indirect material economic interest of at least fifty-one percent (51%) equity ownership; and (B) voting control, so long as Developer promptly provides the City with written notice of such transfer or assignment as well as documentation confirming that the transferee or assignee has agreed in writing to assume all of Developer's obligations hereunder; or

(2) transfer an ownership interest in Developer so long as after such transfer (A) Hank Gordon has both (I) a direct or indirect material economic interest of at least fifty-one percent (51%) equity ownership; and (II) voting control; and (B) Developer promptly provides the city with written notice of such transfer or assignment; or

(e) This Agreement may be terminated by the City if there is any change (voluntary or involuntary) in the membership, management or control of Developer except as expressly provided herein.

5. GRANT AND EXERCISE OF OPTIONS AND PURCHASE OF PADS.

(a) The City hereby grants to Developer separate options to purchase each of the Pads on the terms and conditions contained herein (each of the options is individually referred to as an "Option" and collectively referred to as the "Options"). The respective purchase price for each Pad is: (i) \$300,000.00 for the DG Pad; (ii) \$400,000.00 for Pad A; and \$483,525.00 for Pad B (each referred to herein as "Pad Purchase Price").

(b) Subject to 5(b)(i) below, Developer shall have the right to exercise the Options to purchase the Pads in any order that Developer may determine such that Developer may exercise an Option to buy a single Pad, two Pads or all three Pads at once. Developer's right to exercise the Options shall be subject to the following terms and conditions:

(i) In all events, Developer must exercise the Option to purchase the DG Pad in connection with the first exercise of any of the Options.

(ii) All of the Options must be exercised by Developer no later than June 4, 2012 at 5:00 p.m.

(iii) In the event Developer does not exercise any Option by June 4, 2012 at 5:00 p.m., then any such unexercised Option shall automatically terminate and be of no force and effect and Developer shall have no rights whatsoever under any unexercised Options.

(iv) In connection with the DG Pad, Developer must have submitted to the City evidence satisfactory to the City, of a lease between Developer and DG Market, Inc.

(v) In connection with Pad A, Developer must have submitted to City evidence satisfactory to the City, of a lease between Developer and the lessee/user of Pad A in compliance with the Scope of Development defined below.

(vi) In connection with Pad B, the Developer must have submitted to City evidence satisfactory to the City, of a lease between Developer and the lessee/user of Pad B in compliance with the Scope of Development.

(vii) In connection with Pad A, the Developer has provided to the City an executed and conformed copy of a cross access easement agreement between the Developer and Pad A over an area to be further defined, shown on Exhibit J attached hereto and (i) RLT Corporation, the McDonald's franchisee operating the McDonald's restaurant on the parcel located contiguous to the northeast corner of the Site, or (ii) the owner of the parcel on which such McDonald's restaurant is located, that grants cross access rights which are mutually acceptable to Developer and to the owner of such contiguous parcel, which agreement provides that it shall be recorded and effective concurrently with the Closing of the sale of Pad A.

Developer may exercise an Option by the service of written notice to the City which notice will set forth (i) the respective Pad for which an Option is being exercised and (ii) Developer's certification that the conditions precedent to the Closing for the Pad set forth above has been fulfilled. Upon the exercise of an Option by Developer, (i) City shall become obligated to sell the respective Pad, (ii) Developer shall become obligated to purchase the respective Pad and (iii) in connection with the closing of the DG Pad, the City shall be obligated to convey to Developer the Easements. The respective Pad Purchase Price for a Pad will be paid at the Closing for the Pad along with Developer's closing costs for such Pad.

(c) Developer has deposited the sum of Twenty-Three Thousand Six Hundred Seventy Dollars and Fifty Cents (\$23,670.50) (the "Deposit") with Escrow Agent (hereinafter defined). The Deposit shall be held and applied pursuant to the terms of Section 10 below and Section 27 below.

6. CONDITIONS PRECEDENT TO CLOSING. The following are conditions precedent to the City's obligation to consummate the Closing of the sale of a Pad:

(a) Developer is proceeding with development of the Pad and the Site, as more particularly described in Section 8, and is proceeding towards achieving the issuance of all necessary building permits for the Project by the City's Department of Building and Safety, all to the reasonable satisfaction of the Director of the Economic and Urban Development Department of the City (the "Director").

(b) Prior to the Close of Escrow for a Pad and no later than the time specified in the Schedule of Performance, Developer shall submit to the City evidence satisfactory to the City that Developer has firm and binding commitments for the equity capital and construction financing necessary for development of such Pad. Such financing shall be subject to the approval of the City which approval will not be unreasonably withheld, conditioned or delayed.

7. **BROKERS.** Neither City nor developer has contacted any real estate broker, finder or similar person in connection with the transaction contemplated hereby, and to the actual knowledge of each Party, no Acquisition Fees (as hereafter defined) have been paid or are due and owing to any other person or entity. As used herein, "Acquisition Fees" shall mean all fees paid to any person or entity in connection with the selection and purchase of the Site and/or the Pads, including real estate commissions, selection fees, and non-recurring management and start-up fees, development fees or any other fee of similar nature. The Parties each hereby agree to indemnify and hold harmless the other from and against any and all claims for Acquisition Fees or similar charges with respect to this transaction arising by, through or under the indemnifying party and each further agrees to indemnify and hold harmless the other from any loss or damage resulting from an inaccuracy in the representations contained in this Section 7. This indemnification agreement of the parties shall survive each Closing.

8. **SITE DEVELOPMENT.** The Parties agree that it is their intent that the Site be developed as a neighborhood shopping center as shown on the site development plan attached hereto as Exhibit A-1. In connection therewith, Developer agrees as follows:

(a) Any and all development on the Site will conform to the procedures and limitations contained in the CC&Rs, zoning regulations and all applicable building and other codes as adopted by the City. Developer shall submit to the Director a written progress report once every four (4) weeks after the Effective Date describing the status of Developer's performance since the preceding report, including any reports and studies completed, permits obtained, and the expected progress to be made in the next succeeding period.

(b) The Developer shall carry out the construction of the Project improvements in conformity with all applicable local, state, and federal laws. In addition, Developer has received and acknowledges the City's Employment Plan Policy adopted April 6, 2011 for all phases of project development. Developer shall cause the lessees of the DG Pad, Pad A and Pad B to agree to use best efforts and practices to promote (and will cause its general contractor to promote) the utilization of women, minority, disabled, and veteran owned business enterprises for the construction of the Project. Developer and or the lessees will organize a job fair within the City of Las Vegas prior to the grand opening of the Project. This fair will be advertised in newspapers of general circulation and with minority and women focused media outlets. Minority agencies will also be notified, as recommended by the City's Human Resources Office. This fair will be provided at no cost to such lessees or job applicants and will provide a forum for applying and interviewing for positions at the Project.

(c) The Project will be built in conformance with the "Schedule of Performance" attached hereto as Exhibit D and in accordance with the "Scope of Development" attached hereto as Exhibit E. Within the time set forth in the Schedule of Performance, the Developer shall prepare and submit to the City for review and written approval basic concept drawings and related documents containing the overall plan for development of the Project. The basic concept drawings shall conform to this Agreement, including the Scope of Development and this Section. The basic concept drawings shall conform to the CC&R's. The City shall approve or disapprove of the basic concept drawings within the time established in the Schedule of Performance. If the City shall fail to approve the basic concept drawings within such time, all

subsequent time periods in the Schedule of Performance shall be extended by the number of additional days required to obtain such approval. Any disapproval shall state in writing the reasons for disapproval. The Project shall be developed as generally established in the basic concept drawings and related documents except as changes may be mutually agreed upon between the Parties. Any such changes shall be within the limitations of the Scope of Development.

(d) Developer agrees that, in all events, within six (6) months after the Closing of a Pad, the Developer will begin construction on such Pad and will complete such construction on such Pad within twelve (12) months after commencement of construction, as evidenced by the City's issuance to the Developer of a Certificate of Completion, the form for which is attached hereto as Exhibit F. Commencement of construction on a Pad shall be evidenced by the pouring of the footings by Developer for the Pad, as determined by an inspection completed by the City's Building Official, or by his designee. Both commencement of construction and completion of construction will be extended by such additional time as corresponds to the extent of any delay that is caused by material shortages, labor disputes, fire, civil riots, unforeseen acts of government, acts of God or other events reasonably beyond the Developer's control.

(e) The Developer will be responsible for the installation, at its expense, of all onsite and offsite improvements required by the City in connection with the development of the Project, including, but not limited to, sidewalks and driveways, onsite utilities, sewer lines, and other onsite improvements.

(f) The Developer shall complete and submit to the City an application for a site development plan review for a site plan consistent with the basic concept drawings and in compliance with the CC&Rs.

(g) The City shall sign all required permit applications during its period of ownership of the Site, subject to the terms of this Agreement. The Developer agrees to assume all costs associated with preparation of the site development plan review application, and preparation of architectural plans, civil plans, structural plans, mechanical plans, electrical plans, plumbing plans, or any other plans required by local, state, or federal law required to complete the Project through certificate of occupancy. The Developer also agrees to assume the cost of any application or other connection fees due to the City or any other local, state, or federal agency or organization having regulatory authority over the Project, including, but not limited to, Las Vegas Valley Water District, Southern Nevada Water Authority, NV Energy and Southwest Gas.

(h) Prior to any entry upon the Site for the purpose of conducting any tests or studies, the Developer shall furnish or cause to be furnished to the Director duplicate originals (or certified copies) or appropriate certificates of bodily injury and property damage insurance policies in the amount of at least One Million Dollars (\$1,000,000) for any person, Two Million Dollars (\$2,000,000) for any occurrence and Five Hundred Thousand Dollars (\$500,000) property damage, naming the City as additional insured or co-insured.

(i) For the purposes of assuring compliance with this Agreement, representatives of the City shall have the reasonable right of access to the Site without charges or fees and at normal construction hours during the period of construction, including, but not limited to, the inspection of the work being performed in constructing the improvements. Such representatives of the City shall be those who are so identified in writing by the Director.

(j) The Developer agrees to indemnify, hold harmless and defend (with counsel acceptable to the City) the City, its affiliates, its officers, agents and employees against and from any and all actual or threatened liabilities, claims, actions, foreseeable consequential damages, penalties, costs and expenses (including attorney's fees) and losses arising from or all actual or threatened liabilities, claims, actions, foreseeable consequential damages, penalties, costs and expenses (including attorney's fees) and losses directly or indirectly arising out of or resulting from or relating in any way to the development and/or operation of the Project by Developer. The indemnity obligations of Developer under this Section 8(j) will survive any termination of this Agreement or delivery of the Deed and transfer of title.

(k) Failure on the part of the Developer after Closing to comply with the provisions of this Section 8 shall constitute a default under this Agreement and entitle the City to exercise its right to reenter and repurchase pursuant to Section 13, provided any such failure to comply is not cured for a period of thirty (30) calendar days after written notice thereof from the City. If the Developer has taken reasonable steps to cure, but cannot reasonably cure such default within the thirty (30) day period, it shall have a reasonable time thereafter to effectuate such cure, provided, however, that in all events any cure must be completed within ninety (90) days after such written notice.

9. FORM OF DEED. The City shall convey to the Developer fee simple title to each Pad in the condition provided in Section 15 by a Grant, Bargain and Sale Deed ("Deed") in a form that is consistent with Exhibit G.

10. EARNEST MONEY DEPOSIT. Developer has made an earnest money deposit in the amount of Twenty-Three Thousand Six Hundred Seventy Dollars and Fifty Cents (\$23,670.50) with the Escrow Agent, Escrow No. 423423-A (the "Deposit"). Such earnest money deposit, along with all earnings thereon is referred to in this Agreement as the "Deposit".

The Deposit shall be held by escrow as security for the performance of Developer's obligations under this Agreement and shall be applied at the Closing of each Pad as follows:

DG Pad - Six Thousand Dollars (\$6,000.00); Pad A - Eight Thousand Dollars (\$8,000.00); Pad B - Nine Thousand Six Hundred Seventy Dollars and Fifty Cents (\$9,670.50). In the event Developer does not close the purchase of all three of the Pads except as a result of default by the City, Developer agrees the Deposit shall be retained in full by the City and shall not be refunded to Developer.

11. ESCROW

(a) Escrow has been opened with First American Title Insurance Company ("Title Company"), 10655 Park Run Drive, Suite 140, Las Vegas, Nevada 89144, Attention: Sharon Silverberg, as escrow agent ("Escrow Agent"). This Agreement constitutes the joint escrow instructions of the Parties, and a fully executed copy of the Agreement shall be delivered to the Escrow Agent promptly after the Effective Date. Upon mutual agreement by the Parties, either Party shall provide such additional escrow instructions as shall be necessary and consistent with this Agreement. Subsequent additional escrow instructions may be authorized on behalf of the City and executed by the City Manager, or by the designee of the City Manager, subject to the condition that there is no material modification to the terms of this Agreement, nor additional monetary adjustment which obligates the City. The Escrow Agent hereby is empowered to act under this Agreement, and, upon indicating its acceptance of the provisions of this Section in writing, delivered to the Parties after the opening of the escrow, shall carry out its duties as Escrow Agent hereunder.

(b) Not later than one (1) day prior to the Closing Date (hereinafter defined) for a Pad, Developer shall deposit into escrow the following fees, charges and costs after the Escrow Agent has notified the Developer of the amount of such fees, charges and costs: (i) the Pad Purchase Price less the respective amount of the Deposit to be paid to the City pursuant to Section 10 above, (ii) ½ the escrow fee, (iii) the recording costs for the Deed for the Pad, (iv) the additional premium cost between the cost of a CLTA title insurance policy and an ALTA title insurance policy; should Developer elect to obtain an ALTA title insurance policy, (v) any inspection fee charged in connection with the ALTA title policy, and (vi) the cost of any title insurance endorsements Developer elects to obtain.

(c) The City shall pay the cost of (i) a CLTA policy of title insurance in the amount of the Purchase Price for the Pad, (ii) ½ of the escrow fee, and (iii) Real Property Transfer Taxes). Not later than one (1) business day prior to the Closing Date, the City will deposit with the Escrow Agent the following:

(i) The Deed for the Pad duly executed and acknowledged by the City and in recordable form.

(ii) In connection with the Closing of the DG Pad, the City's counterpart execution to the Easements.

(iii) The Irrevocable Escrow Instructions (hereinafter defined) executed by the City.

(iv) Any other documents, instruments, data, records, correspondence or agreements called for under this Agreement or reasonably necessary in order to complete the transaction, which have not been delivered.

(v) An affidavit that evidences that the City is exempt from the withholding requirements of Section 1445 of the Internal Revenue Code, in the Escrow Agent's standard form.

(vi) A declaration of value in the form required by Clark County to record the Deed.

(d) Not later than one (1) day prior to the Closing, Developer shall deposit and deliver to Escrow Agent the following items:

(i) The Quitclaim Deed for the Pad (hereinafter defined) duly executed and acknowledged by Developer.

(ii) In connection with the closing of the DG Pad, Developer's counterpart execution to the Easements.

(iii) The Irrevocable Escrow Instructions executed by the Developer.

(iv) Any other documents, instruments, data, records, correspondence or agreements called for under this Agreement which have been delivered.

(e) The Escrow Agent is authorized and instructed to (i) charge the Party obligated hereunder, and to pay to the persons entitled thereto, any fees, charges and costs payable under this Agreement and related solely to the acquisition and transfer of a Pad to Developer, provided that before such payments are made, the Escrow Agent shall notify the Parties of the fees, charges and costs necessary to clear title and close the escrow, (ii) disburse funds and deliver the Deed to a Pad and other documents to the parties entitled thereto when the conditions of this escrow have been fulfilled by the Parties, (iii) obtain and charge the Developer all of the premiums and amount by which the cost of any ALTA title insurance policy exceeds the cost of a CLTA policy and the cost of any endorsements thereto requested by Developer, (iv) hold the Quitclaim Deed to a Pad and respective Irrevocable Escrow Instructions until completion of the development on the respective Pad as evidenced by a Notice of Completion, and (v) record any instruments delivered through this escrow, if necessary or proper, to vest title in the Developer in accordance with the terms and provisions of this Agreement.

(f) All funds received in this escrow shall be deposited by the Escrow Agent with other escrow funds of the Escrow Agent in a general interest bearing escrow account or accounts with any state or national bank doing business in the State of Nevada. Such funds may be transferred to any of Escrow Agent's other such general interest bearing escrow account or accounts. All disbursements shall be made by wire transfer, cashier's check or check of the Escrow Agent. All adjustments shall be made on the basis of a thirty (30) day month. Any interest that is earned on funds deposited under this Agreement shall be for the benefit of the Party responsible for depositing those funds with the Escrow Agent and shall apply to the Purchase Price or returned to the Developer as provided elsewhere herein.

(g) If this escrow is not in condition to close before the Closing Date, either Party who then shall have fully performed the acts to be performed before the Closing may, in writing, terminate this Agreement and demand the return of its money, papers or documents. Thereupon all obligations and liabilities of the Parties shall cease and terminate, except that the Party who has not fully performed shall be solely responsible for any escrow cancellation charges. If neither Party shall have fully performed the acts to be performed by it on or before the Closing, no termination or demand for return shall be recognized until five (5) days after the Escrow Agent shall have mailed copies of such demand to the other Party at the address of its or their principal place or places of business. If any objections are raised within the five (5) day period, the Escrow Agent is authorized to hold all money, papers and documents with respect to the Site until instructed in writing by both Parties or, upon failure thereof, by a court of competent jurisdiction. If no such demands are made, the escrow shall be closed as soon as possible. Nothing in this Section shall be construed to impair or affect the rights or obligations of either Party to specific performance.

(h) The Escrow Agent shall not be obligated to return any such money, papers or documents except upon the written instructions of both Parties or until the Party entitled thereto has been determined by a final decision of a court of competent jurisdiction.

(i) Any amendment of these escrow instructions shall be in writing and signed by both Parties. At the time of any amendment, the Escrow Agent shall agree to carry out its duties as Escrow Agent under such amendment. All communications from the Escrow Agent to the either Party shall be directed to the addresses and in the manner established in the notice section of this Agreement for notices, demands and communications between the Parties.

(j) The liability of the Escrow Agent under this Agreement is limited to performance of the obligations imposed upon it hereunder.

12. CLOSE OF ESCROW, CONVEYANCE OF TITLE AND DELIVERY OF POSSESSION

(a) Provided that neither Party is in default under this Agreement and all conditions precedent to such conveyance have occurred, the consummation of the sale by the City to Developer of title to a Pad ("Closing") shall be completed on or prior to but no later than ten (10) days after the exercise by Developer of an Option for a Pad ("Closing Date"). The Parties shall perform all acts necessary for conveyance of title in sufficient time for title to be conveyed in accordance with the foregoing provision.

(b) Notwithstanding any other provision of this Agreement, the Developer's obligation to proceed with a Closing for a Pad is subject to the fulfillment or waiver by the Developer of each of the following conditions precedent, which are solely for the benefit of the Developer and which shall be fulfilled or waived prior to Closing: (i) the City shall not be in violation of any of its material obligations under this Agreement, (ii) the Developer has received from the City and other applicable governmental bodies and other third parties all permits, consents and approvals that Developer reasonably believes are necessary or desirable for the

successful construction and operation of the Project, (iii) the City has made all deposits required of the City pursuant to Section 11(c) above and (iv) Developer has not elected to cancel this Agreement pursuant to Section 16 below.

(c) Notwithstanding any other provision of this Agreement, the City's obligation to proceed with the Closing for a Pad is subject to the fulfillment or waiver by the City of each of the following conditions precedent, which are solely for the benefit of the City and which shall be fulfilled or waived prior to Closing: (i) Developer shall not be in violation of any of its material obligations under this Agreement, and the conditions precedent specified in Section 6 shall have been satisfied or waived by the City, (ii) the Developer has made all deposits required of the Developer pursuant to Section 11(b) and Section 11(d) above and (iii) Developer has not elected to cancel this Agreement pursuant to Section 16 below

(d) Possession to a Pad and easement where applicable, shall be delivered to the Developer concurrently with the Closing, except that limited access shall be permitted before Closing as specifically described in Section 16.

13. RIGHT TO REPURCHASE, REENTER AND REPOSSESS. In addition to any other right and/or remedy available to it, the City shall have the additional right at its option to repurchase, reenter and take possession of a Pad and easement where applicable, with all improvements thereon if, after Closing of the sale of a Pad and prior to the issuance of all certificates of occupancy for the Project, the Developer does any of the following:

(a) Fails to commence or complete construction of the required improvements on such Pad as required by this Agreement pursuant to Section 8. This is a condition subsequent and not merely a covenant.

(b) Transfers a Pad or any part thereof in violation of the Agreement. This is a condition subsequent and not merely a covenant. Transfer of title to the DG Pad to MLK & Lake Mead DG, LLC a Nevada limited liability company is not a violation of the Agreement.

The right to repurchase, reenter and repossess to the extent provided in this Agreement, shall be subordinate, subject to, be limited by and shall not defeat, render invalid or limit any mortgage, deed of trust, sale and leaseback or other security instrument or conveyance for financing not prohibited by this Agreement. To exercise its right to repurchase, reenter and take possession of a Pad, the City or its nominee, shall pay to the Developer the respective Pad Purchase Price minus the following: (i) all fees associated with close of escrow and (ii) the amount needed to repay any liens, claims, encumbrances or other security instruments held against the Site so as to enable the City to receive title to the Pad free and clear of any such liens, encumbrances, outstanding claims, bills to subcontractors, labor/material suppliers, or other security instruments.

For the purpose of implementing the provision of the Section 13, at the Closing, the Developer will deliver to the Escrow Agent an executed and acknowledged "Quitclaim Deed" for each Pad in connection with the closing of a Pad, each in the form of Exhibit H. The deposit of this Quitclaim Deed will be accompanied by "Irrevocable Escrow Instructions" in the form of

Exhibit I directed to the Escrow Agent and signed by the Parties. If any of the events authorizing the City to repurchase, reenter and take possession of a Pad as provided in this Section 13 occur, the City may, without limiting its remedies under this Agreement, direct the Escrow Agent, upon at least thirty (30) calendar days' prior notice to the Developer, to record the Quitclaim Deed to the Pad. If the Developer completes construction on or before the time set forth in Schedule of Performance, the City shall join with the Developer in instructing the Escrow Agent to return the Quitclaim Deed to the Developer.

14. GENERAL REPRESENTATIONS AND WARRANTIES

(a) Representations and Warranties by the City. The City represents and warrants that as of the Effective Date and as of the date of Closing for each Pad:

(i) The City has all requisite power and authority to enter into and perform its obligations under this Agreement. This Agreement constitutes the legal, valid, binding and enforceable obligation of the City.

(ii) By proper action of the City, the City's signatories have been duly authorized to execute and deliver this Agreement.

(iii) To the City's actual knowledge, no condemnation, eminent domain or similar proceedings have been instituted or threatened against the Site.

(iv) To the City's actual knowledge, there are no legal actions, suits or proceedings pending or threatened before any judicial body or any governmental or quasi-governmental authority against the Site or against the City which would inhibit the City's ability to perform its obligations under this Agreement.

(v) To the City's actual knowledge, the execution, delivery and performance of this Agreement by the City will not (A) conflict with or be in contravention of any provision of law, order, rule or regulation applicable to the City or the Site, or (B) result in any lien, charge or encumbrance of any nature on the Site other than as permitted by this Agreement.

(vi) The execution of this Agreement by the City does not violate any provision of any other agreement to which the City is a party.

(vii) The City has and will convey to Developer good and marketable fee simple title to the Pads subject only to the exceptions permitted by this Agreement. Except as shown on the Title Report (hereinafter defined), there are no encumbrances, liens, covenants, restrictions, reservations, options, leases, tenancies, easements, encroachments, claims or other matters affecting title or possession of the Site.

(viii) No labor has been performed or material furnished for the Site, or any part thereof, for which the City has not heretofore fully paid or will pay prior to Closing, or

for which a mechanic's or material man's lien or liens, or any other lien, can be claimed by any person, party or entity.

As used in this Agreement, the term "the City's actual knowledge" means the actual knowledge of the City Manager of the City.

(b) Representations and Warranties of the Developer. The Developer represents and warrants to the City that as of the Effective Date and the date of Closing:

(i) The Developer is a Nevada corporation duly organized and existing under the laws of the State of Nevada.

(ii) The Developer has all requisite power and authority to carry out business as now and whenever conducted and to enter into and perform its obligations under this Agreement.

(iii) By proper action of the Developer, the Developer's signatories have been duly authorized to execute and deliver this Agreement.

(iv) Execution of this Agreement by the Developer does not violate any provision of any other agreement to which the Developer is a party.

(v) Except as may be specifically set forth in this Agreement, no approvals or consents not heretofore obtained by the Developer are necessary in connection with the execution of this Agreement by the Developer or with the performance by the Developer of its obligations hereunder.

(vi) To the Developer's actual knowledge as of the Effective Date, there are no legal actions, suits or proceedings pending or threatened before any judicial body or any governmental or quasi-governmental authority against the Developer which would inhibit the Developer's ability to perform its obligations under this Agreement.

15. CONDITION OF TITLE

(a) The City shall convey to the Developer fee simple title to a Pad subject only to:

(i) A lien not yet delinquent for ad valorem taxes for real property, and any general or special assessments against such Pad.

(ii) All matters disclosed by the Title Report or the ALTA survey described in paragraph (b) of this Section, or any supplemental report, and which are approved or deemed approved by the Developer in accordance with this Section.

(iii) Any and all other exceptions, easements, conditions, covenants or reservations, if any, specifically set forth in the Deed and of record as of the Effective Date, including but not limited to, the CC&Rs.

(b) The Escrow Agent shall, upon the delivery of a fully executed copy of this Agreement to Escrow Agent, deliver to the Developer a current preliminary title report ("Title Report") and legible copies of all documents referred to therein covering or relating to the Site. The Developer may obtain its own ALTA survey of the Site (at the Developer's sole expense, but with the cooperation and all survey information available to the City being provided to assist in obtaining such survey). The Developer shall then approve or disapprove the exceptions listed in the Title Report and ALTA survey as to the Site by giving the City and Escrow Agent written notice thereof within thirty (30) days of the Effective Date. Failure to give written notice to the Escrow Agent and the City by such date of approval or disapproval of the exceptions shall be deemed to be approval of all exceptions, except for monetary liens and taxes. If Developer disapproves any exceptions, the City shall have ten (10) days within which to agree in writing to remove the exception. Failure to give written notice of such agreement to the Developer and the Escrow Agent shall be deemed to be refusal. If City does not agree to remove any exceptions properly and timely disapproved by the Developer, this Agreement shall terminate without further liability to Developer, unless the Developer waives its objection in writing delivered to the City and to the Escrow Agent. If the City shall agree to remove any exception objected to by the Developer, the City shall then have until the date for Closing within which to remove such exception and shall use its best efforts to remove the exception. If despite the use of its best efforts the City is unable to remove any exception objected to by the Developer and which the City has agreed to remove by the Closing, the Developer may elect to (i) terminate this Agreement and receive a return of the Deposit and all other funds or documents deposited by Developer; or (ii) waive the objection and proceed to Closing.

16. FEASIBILITY REVIEW; INSPECTION

(a) Developer will have until March 15, 2012 ("Feasibility Review Period") to review the condition of the Site and the feasibility of Developer's development plan of development on the Site, including, without limitation, the obtaining of leases for the Pads. Developer's feasibility review will pertain to Developer's review of and satisfaction with the following: (i) availability of approvals by all governmental bodies having jurisdiction over the Site for Developer's intended development thereof, (ii) Developer's engineering studies, soils investigations, environmental assessments, surveys and physical inspection of the Site, and (iii) those items contained in Section 15(b). The following items shall be provided or made available by the City to Developer concurrently with the execution of this Agreement by the City, to the extent such items are within Seller's possession or control or are reasonably available to Seller: (i) any and all surveys and maps of all or any portion of the Site, (ii) any and all soils condition reports, environmental assessment reports and endangered species and habitat reports on all or any portion of the Site, (iii) any and all water and sewer studies, engineering studies, zoning information, and marketing studies relating to all or any portion of the Site, (iv) any and all leases or other contracts or agreements relating to all or any portion of the Site, the availability of utilities or access to all or any portion of the Site, and investigations of any requirements which may be imposed by governmental or quasi-governmental entities and agencies relative to all or

any portion of the Site, (v) any and all plans, specifications, licenses, permits, authorizations and approvals relating to all or any portion of the Site; any and all covenants, conditions and restrictions of all owners' associations with jurisdiction over all or any portion of the Site, and any and all articles of incorporation, bylaws, rules, regulations and public offering statements of any such associations, and (vi) any and all such other materials, documentation and information concerning all or any portion of the Property required or reasonably requested by Developer in order to perform its due diligence.

(b) Developer may elect, at any time prior to the expiration of the Feasibility Review Period, to terminate this Agreement as a result of Developer's disapproval of any of the foregoing matters; provided, however, that if Developer fails to notify City and Escrow Holder of Developer's disapproval of the feasibility of Developer's proposed development of the Site by written notice delivered to City no later than the date of expiration of the Feasibility Review Period, Developer will be deemed to have approved the feasibility and this condition will be deemed satisfied. If this Agreement is terminated pursuant to this Section, Developer shall pay to Escrow Holder an amount equal to the cost of the cancellation of Escrow, and neither Party will have any further rights or obligations under this Agreement and the Deposit shall immediately be refunded to Developer.

(c) During the Feasibility Review Period, Developer, and its representative and consultants (including architects and engineers or potential tenants) will have the right to enter upon and inspect the Site and conduct such boundary and topographic surveys, soil and engineering tests environmental assessments, and such other tests and studies as Developer deems desirable, with engineers or consultants licensed in the State of Nevada; provided that such inspections and tests will not materially damage the Site in any respect; provided, further, that such tests and inspections are conducted in accordance with standards customarily employed in the industry and in compliance with all governmental laws, rules and regulations; provided, still further, that Developer notifies City in writing at least forty-eight (48) hours prior to the date that Developer intends to conduct invasive testing or inspections on the Site. Following Developer's inspections or testing on the Site, Developer promptly will restore the Site to its original condition as existed prior to any such inspections and/or tests. If Developer, its agents, representatives or employees undertakes any boring or other disturbance of the soil, the soil so disturbed will be recompacted to the original condition of the Site and Developer will obtain at its own expense a certificate from a soils engineer which certifies that such soil so disturbed has been recompacted to the original condition of the Site. To the extent that any costs for damages and/or injuries are not covered by any insurance policy protections or are in excess of the insurance policy limits, the Developer agrees to indemnify, hold harmless and defend (with counsel reasonably acceptable to City) the City, its affiliates or assignees, which are under the control of the City and its officers, agents and employees against and from any and all liability, loss, cost, damage or expense (including attorneys' fees) of whatsoever nature growing out of or in connection with personal injury to or death of persons whomsoever (including, without limitation, exposure to hazardous or toxic substances, to the extent brought on the Site by Developer), or loss or destruction of or damage to property whatsoever (including, without limitation, contamination by hazardous or toxic substances and any required testing, removal or cleanup thereof, to the extent brought on the Site by Developer), where such personal injury, death, loss, destruction or damage arises in any way in connection with or incident to the

occupation or use of the Site by, or the presence thereon of, Developer, its officers, agents or employees and occurs from any such cause. If Developer should discover any hydrocarbon substances or any other hazardous or toxic substances, asbestos or asbestos-bearing materials, waste or materials subject to legal requirements or corrective action, Developer will immediately notify City of the same. The indemnity obligations of Developer under this Section will survive any termination of this Agreement or delivery of the Deed and transfer of title. Developer covenants and agrees upon request of the City to promptly deliver to City without charge therefore, the results and copies of any and all environmental reports and related correspondence.

(d) Developer covenants and agrees to pay in full for all materials joined or affixed to the Site by Developer and to pay in full all persons who perform labor upon the Site at the request of Developer, and not to permit or suffer any mechanic's or material man's lien of any kind or nature to be enforced against the Site for any work done or materials furnished thereon at the instance or request or on behalf of Developer; and Developer agrees to indemnify, hold harmless and defend (with counsel acceptable to the City) the City, its affiliates, officers, agents and employees against and from any and all liens, claims, demands, costs and expenses of whatsoever nature in any way connected with or growing out of such work done, such labor performed or such materials furnished prior to Closing.

17. TIME FOR CLOSING AND DELIVERY OF DEED. Subject to any mutually agreed upon extensions of time, the City shall deposit the Deed for a Pad with the Escrow Agent pursuant to Section 11. The Parties shall also timely deliver into escrow (a) any transfer declarations, returns or other similar documents satisfying Nevada state law requirements, if any; (b) all documents set forth in Section 11; (c) evidence reasonably satisfactory to the other Party and Escrow Agent respecting the authorization and execution of the documents required to be delivered hereunder; and (d) such additional documents as may be reasonably required by the other Party or Escrow Agent in order to consummate the transactions provided hereunder.

18. CLOSE OF ESCROW.

(a) Closing Instructions. The Escrow Agent is authorized and instructed to on the Closing Date for a Pad:

- (i) record the Deed for the Pad;
- (ii) record the Easements in connection with the Closing for the DG Pad;
- (iii) deliver to the City by wire transfer or intrabank transfer funds in an amount equal to the Pad Purchase minus any of the costs for which the City is obligated to pay pursuant to Section 11(c) above;
- (iv) deliver to each of the Parties such other documents and instruments as may be mutually and in writing instructed by the Parties;
- (v) deliver to Developer the Title Policy; and

(vi) prepare and submit to the Internal Revenue Service the information return and statement concerning the closing of the Escrow required by Section 6045(e) of the Internal Revenue Code of 1986, if required thereunder.

(b) Instructions Upon Recordation. The instruments that are required to be recorded and/or delivered under this Agreement shall provide that the Recorder's Office shall return them to Escrow Agent after recordation, and upon receipt thereof, Escrow Agent shall deliver the following:

(i) to the City: (A) a copy of the Deed; (B) an original of the Easements as recorded; (C) original counterparts of all other bilateral documents and instruments executed and delivered between the Parties; (D) plain copies of the real property transfer declaration; (E) the original Developer certificate as to its representations and warranties, and (F) all other documents deposited by any Party into Escrow; and

(ii) to Developer: (A) the original of the Deed; (B) the original of the Easements as recorded; (C) original counterparts of all other bilateral documents and instruments executed and delivered between the Parties; (D) plain copies of the real property transfer declaration; (E) the original of the Non-Foreign Transferor Declaration; (F) the original of the City certificate as to its representations and warranties and (G) all other documents deposited by any Party into Escrow.

19. **TITLE INSURANCE.** Concurrently with recordation of a Deed for a Pad, and as a condition of the Closing, the Escrow Agent and any required co-insurer shall provide and deliver to Developer a title insurance policy issued by the Escrow Agent insuring that title to such Pad is vested in the Developer in the condition required by Section 15, and the title insurance policy shall be of the type and in the amount requested by the Developer, and with such endorsements and affirmative coverages as may be required by Developer ("Title Policy"). If Developer desires to obtain extended coverage for its title policy, the City shall provide the Escrow Agent at the Closing with such evidence and customary documents as are reasonably required to issue such coverage.

20. **TAXES, ASSESSMENTS, ENCUMBRANCES AND LIENS.** The Developer shall be responsible for the payment of all real estate taxes and assessments assessed and levied on a Pad for any period subsequent to Closing. Prior to Closing of the sale of a Pad, the Developer shall not place or allow to be placed on the pad or the Site (or portion thereof) any encumbrance or lien.

21. **CONVEYANCE FREE OF POSSESSION.** The Site shall be conveyed free of any possession or right of possession by any other person except that of the CC&Rs and approved easements, vacations, or dedications of record, which are mutually agreeable to the Parties.

22. "AS IS" SALE

(a) Except as otherwise provided in this Agreement, the Developer acknowledges and agrees that each Pad and the Easements are to be sold and conveyed to and accepted by the Developer pursuant to this Agreement in an "as is" condition, with, if any, all faults and defects. Except as otherwise specifically stated in this Agreement, the City makes no representations or warranties of any kind whatsoever, either expressed or implied, with respect to the Site, the Pads or any of such related matters; in particular, but without limitation, except as otherwise provided herein the City makes no representations or warranties with respect to the use, condition, title, occupation or management of the Site or the Pads, compliance with applicable statutes, laws, codes, ordinances, regulations or requirements relating to leasing, zoning, subdividing, planning, building, fire, safety, health or environmental matters, compliance with covenants, conditions and restrictions (whether or not of record,) other local, municipal, regional, state or federal requirements, or other statutes, laws, codes, ordinances, regulations or requirements affecting or relating to the Site or the Pads. The Developer acknowledges that notwithstanding any prior or contemporaneous oral or written representations, statements, documents or understandings, this Agreement constitutes the entire understanding of the Parties with respect to the subject matter hereof and the purchase and sale of the Site and supersedes any such prior or contemporaneous oral or written representations, statements, documents or understandings.

(b) Except as otherwise stated herein, the Developer, for itself, its successor and assigns, and for each and every subsequent owner of the Site ("Releasing Party") hereby mutually releases, waives, remises, acquits and forever discharges all rights, causes of action and claims which Developer has or may have in the future against the City, its officers, employees, agents, attorneys, representatives, legal successors and assigns, from any and all claims, suits, actions, causes of action, demands, rights, damages, costs, expenses, penalties, fines or compensation whatsoever, direct or indirect, which Developer or any Releasing Party now has or which Developer or any other Releasing Party may have in the future on account of or in any way arising out of or in connection with Hazardous Materials or violation of Environmental Laws (hereinafter defined) or arising out of or in connection with any other physical or environmental condition of the Site or the Pads. The Developer hereby agrees to hold harmless and indemnify the City from any claims, judgments, penalties, fines, losses, damages, expenses (including reasonable attorneys' fees) against or incurred by the City after the conveyance of a Pad to the Developer arising in any way from (i) the presence of Hazardous Materials at, on, beneath or from the Site or a Pad, or (ii) the application of Environmental Laws to the Site or a Pad.

(c) The Developer agrees that the City is making no representations or warranties regarding the environmental or any other condition of the Site.

(d) Definitions.

- (i) As used in this Agreement, the term "Hazardous Materials" means any substance, material or waste which is:

- (1) defined as a "hazardous waste," "hazardous material," "hazardous substance," "extremely hazardous waste" or "restricted Hazardous waste" under any provision of Nevada law;
 - (2) petroleum;
 - (3) asbestos;
 - (4) polychlorinated biphenyls;
 - (5) radioactive materials;
 - (6) designated as a "hazardous substance" pursuant to Section 311 of the Clean Water Act, 33 U.S.C. Section 1251 et seq. (33 U.S.C. Section 1321) or listed pursuant to Section 307 of the Clean Water Act (33 U.S.C. Section 1317);
 - (7) defined as a "hazardous substance" pursuant to the Resource Conservation and Recovery Act, 42 U.S.C. Section 6901 et seq. (42 U.S.C. Section 6903); or
 - (8) defined as a "hazardous substance" pursuant to Section 101 of the Comprehensive Environmental Response, Compensation, and Liability Act, 42 U.S.C. Section 9601 et seq. (42 U.S.C. Section 9601).
- (ii) As used in this Agreement, the term "Environmental Laws" shall mean any and all laws (whether common or statutory), compacts, treaties, conventions, rules, regulations, codes, plans, requirements, criteria, standards, orders, decrees, judgments, injunctions, notices or demand letters issued, promulgated or entered there under by any federal, state or local governmental entity relating to public or employee health and safety, pollution or protection of the environment, including without limitation, the Comprehensive Environmental Response, Compensation and Liability Act, as amended by the Superfund Amendment and Reauthorization Act and otherwise ("CERCLA"), the Resource Conservation and Recovery Act ("RCRA"), the Federal Safe Drinking Water Act, the Federal Water Pollution Control Act, and any and all other federal, state and local laws, rules, regulations and orders relating to reclamation of land, wetlands and waterways or relating to use, storage, emissions, discharges, cleanup, releases or threatened releases of pollutants, contaminants, chemicals or industrial, toxic or Hazardous Materials on or into the workplace or the environment (including without limitation, ambient air ,oceans,

waterways, wetlands, surface water, ground water (tributary and nontributary), land surface or subsurface strata) or otherwise relating to the manufacture, processing, distribution, use, treatment, storage, disposal, transportation or handling of pollutants, contaminants, chemicals or industrial, toxic, hazardous or similar substances.

23. GOVERNMENTAL PERMITS. Nothing in this Agreement shall affect the responsibility of the Developer to seek, obtain and comply with the conditions of any and all permits and governmental authorizations necessary to develop the Site, the Pads or any portion thereof. The Developer shall be responsible for the payment of permit fees, which shall be limited to those fees that are authorized by ordinance.

24. INTENTIONALLY OMITTED.

25. INTENITONALLY OMITTED

26. TIME OF ESSENCE. Time is of the essence of this Agreement and every obligation hereunder.

27. DEFAULT AND REMEDIES

(a) In the event the Developer fails to perform any of its obligations required to be performed hereunder prior to Closing, including, without limitation, Developer's obligations under Section 6 and Section 8, or in the event the Closing does not occur by reason of a default by Developer, the City may as its sole remedy, by written notice to the Developer and Escrow Agent, terminate this Agreement and receive from Escrow Agent the remaining amount of Deposit then held by Escrow Agent as the City's liquidated damages for the breach of this Agreement by the Developer. It is expressly understood and agreed between the Parties that the City's actual damages for any such breach by the Developer hereunder would be substantial but extremely difficult to ascertain. In addition, Developer agrees that in the event Developer does not exercise all Options to acquire the Pads, that the City shall be entitled to retain the remaining amount of the Deposit then held by Escrow Agent with no refund of the Deposit to Developer. In such case, such remaining amount of the Deposit shall be deemed to be a fee paid by Developer to the City in consideration of the initial grant of the Options by the City to Developer.

(b) In the event of the occurrence of a default or the breach of a covenant, representation or warranty by the City occurring prior to the Closing, the Developer's sole remedy shall be to pursue one, and only one, of the following remedies: (i) to waive such default; or (ii) to terminate this Agreement; and on such termination, the Deposit will be

returned to the Developer and the Parties thereafter shall have no liability or obligation hereunder; or (iii) to demand specific performance of the City's obligations under this Agreement without any abatement in the Purchase Price or other consideration and without any liability whatsoever on the part of the City for damages.

(c) Notwithstanding any termination of this Agreement for any reason whatsoever, the obligations of the Developer under Sections 8(j), 16(c) and 16(d) shall survive such termination of this Agreement.

28. SURVIVAL. The representations and warranties contained in this Agreement, and the covenants that extend beyond the Closing, shall survive the recordation of any Deed and shall not be deemed merged into such Deed.

29. SUCCESSORS AND ASSIGNS. This Agreement shall inure to the benefit of and bind the successors and assigns of the Parties, subject to the provisions of this Agreement regarding assignment.

30. NO PERSONAL LIABILITY. No official or employee of the City shall be personally liable to the Developer for any default or breach by the City, for any amount which may become due to the Developer, or for any obligation of the City under the terms of this Agreement. No manager, member, officer, or employee of Developer shall be personally liable to the City for any default or breach by Developer, for any amount which may become due to the City, or for any obligation of Developer under the terms of this Agreement.

31. NOTICES, DEMANDS AND COMMUNICATIONS. Formal notices, demands and communications between the Parties shall be sufficiently given if made in writing and dispatched by registered or certified mail, postage prepaid, return receipt requested or by personal delivery, to the principal offices of the City and the Developer as set forth in this Section. Such written notices, demands and communications may be sent in the same manner to such other addresses as either Party may from time to time designate in writing. Service by United States Mail or by Federal Express or other similar delivery service shall be conclusively deemed made on the first business day delivery is attempted or upon receipt, whichever is sooner.

32. SUBSEQUENT CITY APPROVALS. Any consents or approvals of the City required or permitted by the terms of this Agreement may be given by the City Manager of the City or such other person that the City designates in writing, subject to the condition that there is no material modification to the terms of this Agreement, nor additional monetary adjustment which obligates the City.

33. INTENTIONALLY OMITTED.

34. ENTIRE AGREEMENT, WAIVERS AND AMENDMENTS. This Agreement is executed in three duplicate originals, each of which is deemed to be an original. This includes Exhibits A, B, C, D, E, F, G, H, I and J attached hereto and incorporated herein by reference, all of which constitute the entire understanding and agreement of the Parties. This Agreement integrates all of the terms and conditions mentioned herein or incidental hereto, and supersedes all negotiations or previous agreements between the Parties with respect to all or any part of the subject matter hereof. All waivers of the provisions of this Agreement must be in writing and signed by the City Manager or other appropriate authorities of the City and the Developer and no waiver of one provision shall be construed as a waiver of that provision in the future or as a waiver of any other provision. All amendments hereto must be in writing and signed by the City Manager or other appropriate authorities of the City and the Developer.

35. SEVERABILITY. Whenever possible, each provision of this Agreement shall be interpreted in such a manner as to be valid under applicable law, but if any provision shall be invalidated, it shall be deemed to be severed from this Agreement and the remaining provisions shall remain in full force and effect.

40. DATES. If any date or other deadline set forth herein falls on a Saturday, Sunday or federal banking holiday, the date for performance on such date shall be extended to the succeeding day which is not a Saturday, Sunday or federal banking holiday.

41. FURTHER ASSURANCES. Each Party shall from time to time execute and deliver such further instruments as the other Party or its counsel may reasonably request to effectuate the intent of this Agreement, including, but not limited to, documents necessary for compliance with the laws, ordinances, rules or regulations of any governmental authority.

42. EFFECTIVE DATE. The effective date ("Effective Date") of this Agreement shall be the date when this Agreement has been signed by both Parties.

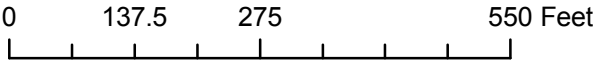

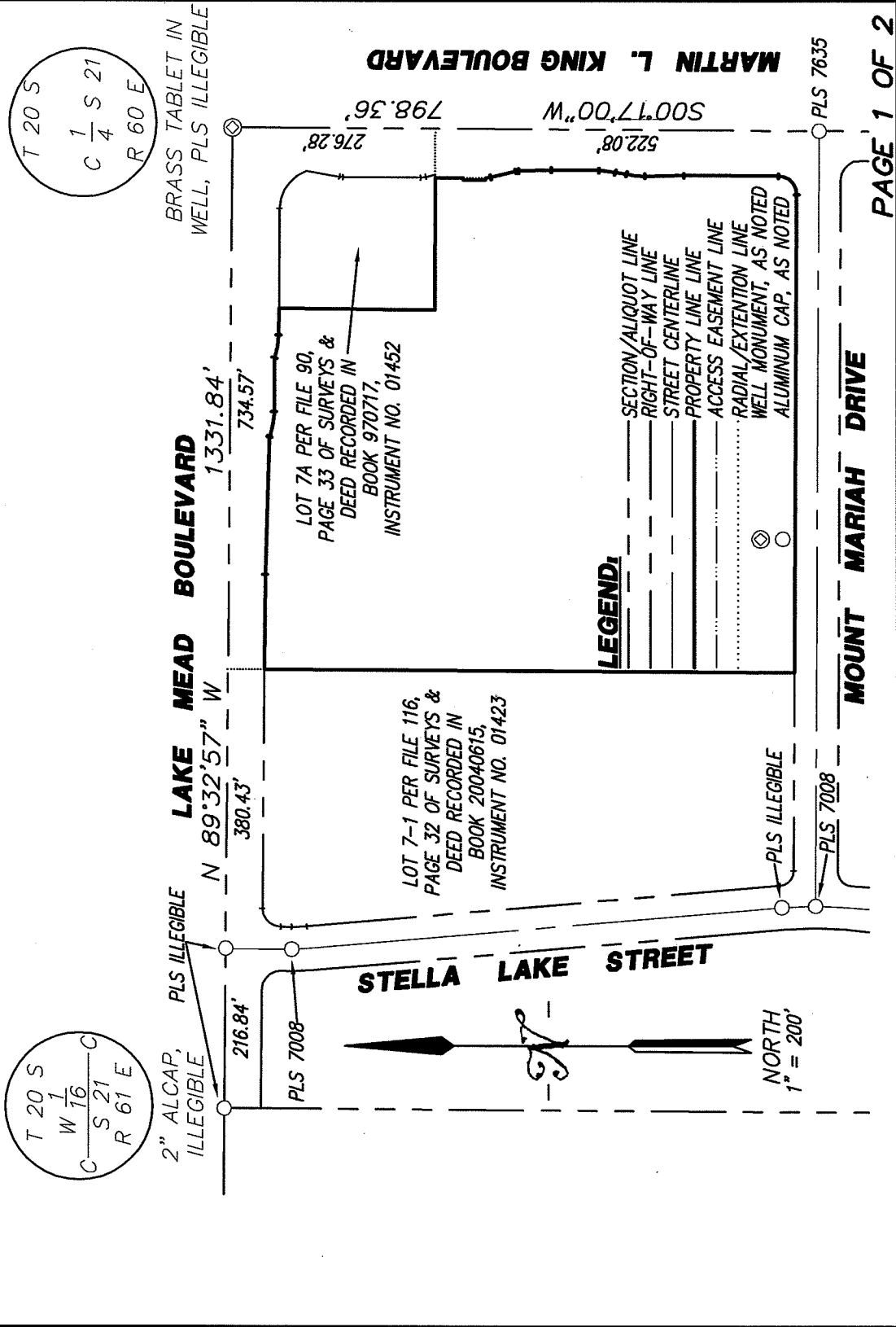
