

Amendment No. 1 to
Highway Agreement No. PR082-09-063

This Amendment is made and entered into this 9TH day of DECEMBER, 2011, between the State of Nevada, Department of Transportation, hereinafter referred to as the DEPARTMENT, and the City of Las Vegas, 333 N. Rancho Dr., Las Vegas, NV 89106, hereinafter referred to as the CITY.

WITNESSETH:

WHEREAS, on April 6, 2009, the Parties entered into Agreement No. PR082-09-063 to delegate authority to the CITY to design, advertise, award, and manage construction of the restoration and installation of 2 neon signs within existing median islands on Las Vegas Blvd. from Fremont St. to US 95, to have power run to the signs and the design and printing of 5,000 brochures for the Las Vegas Strip Scenic Byway; and

WHEREAS, due to delays in the design of the PROJECT by the CITY the termination date needs to be extended to allow sufficient time for the completion of the PROJECT.

WHEREAS, the Parties hereto desire to make certain amendments to Agreement No. PR082-09-063.

NOW, THEREFORE, the Parties agree as follows:

- A. The termination date referenced in Article III Paragraph 1, shall be changed from December 31, 2011 to December 31, 2013.
- B. Article III Paragraph 15, is amended by deleting it in its entirety and inserting in its place, All notices or other communications required or permitted to be given under this Agreement shall be in writing and shall be deemed to have been duly given if delivered personally in hand, by telephonic facsimile or electronic mail with simultaneous regular mail, or mailed certified mail, return receipt requested, postage prepaid on the date posted, and addressed to the other party at the address set forth below:
